With the expotential growth in the Nelson and Tasman area , aggregates for roading and more importantly for concrete manufacture and becoming scarce.		
To meet last years concrete demand , over 240,000 tonnes of washed and graded aggregate (including sand) was required. This makes no allowance for concrete masonry product demand ( paving, retaining wall veneers and masonry blocks).		
The only other alternative from my industry point of view would be to truck aggregate and sand into the region from either the West Coast or the Marlborough region (if available), this will hugely impact on the carbon footprint of the end product and impose a substantial cost increase on the end user

4.As to some specific issues:

a) The constant noise and drone of heavy machinery working 10 hours every weekday with 30 daily truck movements, will completely ruin the calm of the current rural/horticultural environment. It will also set a precedent for other similar uses of the land in the Valley. (We believe that a previous application for gravel extraction at Peach Island some years ago, was in fact declined. Hopefully, that decision has created the precedent).

b) West Bank Road was not designed for frequentiase by heavy tracks. It is narrow and winding (please see local paper report of a serious accident not long before Christmas 2021, involving a large track crashing over the bank not far from 493 WBR). The road is already carrying quite enough such traffic being used several times each day by Fonterra, Sollys, Borneys and other commercial company trucks. There are several residences along the proposed route which are right on the road frontage. An extra 30 daily movements will be intolerable to the occupants. Their homes would really shake given the weight of each gravel truck and trailer!

Damage to the road, its culverts and bridges as a result of these excessively heavy trucks will be significant.

c) West Bank Road is part of both the New Zealand Cycle Way and the Great Taste Trail. As such, it is used by toorists (international, when allowed back) including many cyclists (often in convoys of 10 or more) on hired likes who do not know the dangers of that road.

d) TDC will have the expertise to know the detrimental effect to the environment if this application is permitted. But we ask them to consider the human cost to the people who live in this beautiful valley. There are relatively few people who live here, so you are unlikely to be flooded with submissions of opposition. Regrettably, therefore, the objectors have but a small voice, flut you will find no one is the whole valley (nor the town of Motueka, I suggest) who wants this activity to be permitted.

It will do nothing to eshance the value of the area. Quite the reverse, in fact. It will amount to the rise of agricultural/horticultural land. It will destroy the peace and beauty of a large area, way beyond the 7.4 ha it will defile. It will allow an activity little different in its operation than that of heavy industry, all for the convenience of one commercial organisation.

Please, ask yourselves, what would be the justification of permitting a heavy commential activity in a zoned rural area if there is no discernible benefit to the community as a whole?

The consent will allow extraction of gravel from the berm of the Motueka River and on the landward side of the stopbank at Peach Island for a duration of 15 years. Excavated material will be transported to the Hau Road, Motueka processing unit by truck plus trailer units with 15 return/30 single truck movements per day. The proposed transport route is along Motueka River West Bank Road to the bridge at Alexander Bluff Road and then via Motueka Valley Highway. Inbound vehicles may return with back fill material for the extraction site.

The impact of heavy trucks and trailers carting gravel or back-fill every 20 minutes, Monday-Friday all year round will be significant for users of Tasman's Great Taste Trail (GTT). The Nelson Tasman Cycle Trails Trust is leading the project to build the GTT - a 175km cycle trail between Nelson-Mapua-Motueka-Kaiteriteri, and between Nelson-Wakefield-Tapawera-Motueka. More than two-thirds of the Trail is now open to cyclists and walkers and the Trust expects the trail to be fully open by the end of 2022.

Cycling is popular and in the 12 months to December 2020 GTT trail counters recorded more than 250,000 people cycling and walking. It's challenging to count the user numbers on the West Bank Rd, because many tackle just a portion of the trail. The closest counters to the Motueka River West Bank show the following user numbers for the 12 months to December 2021: Riwaka - 34,000, - Kohatu - 7,697, and Brightwater - 51,980.

The Trust expects that once the GTT is complete on the West Bank Section, it will become more popular with cyclists. Its proximity to Motueka means that it could easily experience user numbers that are similar to the Riwaka and Brightater counters. Other factors that lead us to think that user numbers on this section of trail will be high include: a large new cycle trail operator has established a business in Nelson in 2021, having a loop trail is very attractive to users, international tourists aren't included in the 2021 user figures, and the increasing popularity of e-bikes mean that cycling is continuing to grow in popularity.

Dear Council Members:

My name is David Kellogg and I reside at 398 West bank Road with my wife Susan Kellogg.

We are writing the Tasman Council in regard to the proposed rock and gravel extraction application lodged with the Tasman Council, by CJ Industries, the new owners of 493 West Bank Road.

My wife and I are permanent residents of New Zealand and we have peacefully resided at 398 West bank Road for the last 12 years. Our property overlooks the paddocks adjacent to West Bank Road, as well as, the entire Motueka River Valley, on to the Tasman Sea.

We purchased our property with the following significant values that we hold dear.

- The one of a kind, Incredibly beautiful, pristine visual landscape that greets us every morning. CJ Industries
  excavation project could not help but negatively impact our presently gorgeous view. We did not purchase this
  property, in order to watch trucks and machines work all day. How foolish that would have been! Would you?
- 2. In our opinion, The granting of any council consent for any industry that would use heavy machinery, large transport trucks, and include the disruption of the Motueka River's flow is an abomination to this valley and its residents. Not only will the quality of life be seriously affected for the worse...but the destruction of property values would, coincide as well. It is not fair that CJ Ind. Should try to take advantage of a rural location/zoning for industrial zoning, which is what this is. Our lifestyle and property values are at stake. We propose that the owners of CJ place a working pit right in the center of any residential property or lovely view they might have and see how they like it. The local forestry practices are enough!
- 3. The serenity of this valley which is now strictly agricultural, orchards and grazing cattle and sheep, these would totally be disrupted and disturbed by the constant droning noise created by the excavation process, along with the constant truck traffic that would be used to transport the extracted heavy material. The noise and vibration hum would be extreme...sound travels up and we sit up above the valley. The Motueka River Valley is only about 1 kilometer wide. Car and truck traffic from the East side of the valley are clearly audible from our west side. The proposed project which is only ¼-1/2 kilometer from us would be intolerable! Our treasured value of peace and quiet that we presently enjoy would disappear forever, once consent is granted, it is difficult to rescind.
- 4. Safety Issues-West Bank Road is a rural road that is far from being a highway. West Bank Road was not built for the constant daily use, of heavy construction vehicles, tourist busses and new larger frame RV's and trucks. We find that freight companies such as Sollys, Fonterra, and huge construction trucks are the norm these days on West Bank Road, increasing the hazards those who drive regular size vehicles, walk, jog, ride horses, bike or motorcycle. The big vehicles cannot slow down fast enough if there were an obstacle, such as a child on horseback or biking in their path. There is not much wisdom in additionally burdening the increasing local and freight traffic, with the constant entrance and exit by very large industrial vehicles into the proposed sight. Again, a loss of peace and quiet, along with property values and safety. People First!

- 5. The West Bank Road quality, which is poor, will certainly deteriorate, and continue to do so. This deterioration will only accelerate with constant, additional heavy truck traffic, from the proposed rock extraction project. It has been our experience that industry never picks up the tab for any civic works, or cleans up after themselves, when assuming the tax payer will cover the bill, such as, constantly needed quality road repairs and maintenance, as would be the case for West Bank Road, if this consent is granted.
- 6. The Water Quality....Peach Island. Quite at risk! Our water comes from Peach Island, as does the water for several other residents. The underlying aquifer and water table would be at high risk from the heavy machine extraction of the very gravels, rocks and sand that form a perfect natural filter for our water to stay clean. We get our water from a well immediately adjacent to the proposed project. Again, we say, let the C&J owners excavate the ground, constantly and deeply right by their drinking water source, (whatever it may be,) that is used for themselves and their families, then see what they have to say. C&J Industries cannot guarantee the continued excellence of our drinking water, and sadly neither can the Council. This has been a clean, undisturbed water source for West Bank residents, livestock and crops for decades, it should be grandfathered in as a protected water source, by the Council so it cannot be tampered with, at the whims of big money!

Mr. Askew, Mr. Scoles and Council Members who are considering the consent for this C&J industries project at 493 West Bank River Road, Motueka, NZ, please mark us down as categorically opposed to any sort of consent, limited, etc, to C&J Industries, or any such invasive Industry in this beautiful jewel of a valley. Shame on them for buying the property for such purposes!

As the closest property to CJ Industries proposal to extract gravel from Peach Island we strongly oppose this application on the following grounds. Please also note that on most data collected for this proposal that our dwelling and bore are not noted hence some data shown may not be correct in relation to the proximity of our dwelling and bore to the proposed sites

- WATER The hydrology report prepared by Envirolink Ltd does not factor in our bore site or the location of our house which is only approximately 100 metres from proposed site 3. We have grave concerns as to what extraction and backfill will do to the quality of our water. We are aware it is to monitored but quality could change between readings potentially putting our health at risk should the water at some stage become contaminated.
- EROSION We have approximately 4-5 hectares of good grazing land which has the Motueka river overflow flood channel running through it.

A good section of this land runs the full length of the proposed extraction site 1.

July 17 2021 saw extraction pits in Douglas road extensively eroded with large amounts of metal spread against and over neigbouring properties with one farmer unable to use one paddock because of the amount of metal deposited on it. It is of major concern that this could happen to us from this proposed site.

As a flood overflow channel this will and can flood on numerous occasions. The severity varies but it is not rare to flood site 1 entirely.

We have seen the severity of flooding from the overflow channel and in a larger flood as in July also from the Motueka river as well. The impact from the volumes of water coming through is significant, we are seriously concerned what these volumes of water will do to their extraction pits, stockpiled metal, topsoil and backfill. Potentially we could end up with this spread all down our grazing land.

DUST We own a pipfruit orchard. Excess dust on the fruit is not acceptable. If it settles in the stem end of the fruit it is impossible to remove. Consultation with the packhouse informs us that this would result in the fruit being rejected for export. With one block of apples on the boudary of site 3 just a few metres away dust would be a critical concern to us The rest of the orchard is also in close enough proximity to all proposed sites for dust to be an issue. It has been known to happen.

It is on file that CJ industries have had to compensate at least one orchardist a substantial amount for losses due to dust on fruit.

NOISE As the nearest dwelling to the proposed sites the noise is of concern to us. We are only about 100 metres from site 3 !! Metal being excavated, dumping on trucks, backing devices and heavy machinery operating 8 hours a day, vehicles coming and going is not acceptable to us. Our property was not recognised by Hegley Acoustic Consultacy when data was prepared by them for consents. We believe the noise levels will be unacceptable. The noise that we heard when CJ s were taking gravel from across the river from us we think would have been above the acceptable levels. It was very loud when metal was being dumped into trucks. We are extremely concerned as the closest neighbour that noise levels will exceed acceptable levels. On a personal note if one can not stand constant noise this could affect ones health. Please note that Hegley Acoustics Consulting data is computer generated not based on the actual location on Peach Island.

STOP
BANKS
Peach Island residents had a meeting with council members in November 2021 to discuss the stop banks.
We were informed that a sifnificant amount of money had been put aside for strengthening the Motueka and Peach Island stop banks. However, we were also informed that once repairs to the Motueka river stop banks was complete there would be very little if no funds left for the Peach Island stop banks to be strengthened.

If CJ Industries is going to be crossing the Peach Island stop bank several times a day, proposed 30 truck movements a day and that does not include heavy machinery and other vehicles, will this not impact on the welfare of the stop bank. It will lower with tracking on the sides and crest.

Ongoing repairs would be suspect should flood waters reach the crest. We can not afford a breach, it would be disasterous to all Peach Island residents. ROADING & Part of the proposed haul road, a paper road is either

We have lived at 119a Motueka Valley Highway for 32 years on a property overlooking the proposed excavation site.

- 1. Introduction and Background. At Douglas Road Quarry CJ Industries claim they have an excellent compliance record. Neighbours of this quarry have told that this is not the case. To quote "They push the boundaries until they get caught". We have also been told that there are major issues with this site's practices. I am sure TDC can share further light on this from past complaints.
- 2. Assessment Criteria Rule 16.10.2.2. Flood Hazard Excavation is taking place in a flood zone. While it has been classified as flooding approximately every 50 years it has flooded in 1990, 2014 and 2021 (the latter not noted).
- 3. Assessment Criteria Rule 16.2.2.6 Transport. As noted, the Motueka Valley Road, where the trucks towing trailers will be travelling is narrow and winding. There is no footpath or cycle way (road verge in places is less than a metre). When large logging trucks use this road, it has been for periods of relatively short term, with much fewer road movements per day. Gravel trucks will be crossing the Alexandra Bluff bridge and Rocky River bridge with heavy loads up to 30 times a day creates a fifteen-year hazard.
- 4. Dust and Noise Effect. "Noise generated from the activity will not be out of character or considered excessive given the surrounding land uses." We dispute this. This area is designated Rural 1 which means we can expect noise derived from agricultural practices from time to time. We experience noise pollution, but it is seasonal and short term spasmodically which we accept. The noise level assessed at our property is potentially 50 hours per week, 49 weeks per year at an industrial level. Neighbours at Douglas Road I have spoken to advise this is intrusive, constant and especially resounding when the first gravel is loaded onto empty truck steel decks. Trucks begin warming up from about 6.30am for a 7.00am start. We are well aware of the intrusive nature of this noise having experienced it in 2020/21 when CJ'S removed gravel from the river bed on a site opposite our property. It was intrusive but we tolerated it as the gravel beach needed to be removed to help river flow and it was for a relatively short period of time, approximately 6 weeks and a further 3 weeks. Also of note CJ's harvested bailage prior to Christmas in the area they wish to quarry. The harvester noise heard until 1.45am kept our household awake and we have a sound proofed bedroom constructed for when working night shift and sleeping during the day.
- 5. **Figure 11 Map (Water Bores in the vicinity).** Water Bore. Our water bore (at same site for 40+ years) is not noted on Figure 11 Map nor is our neighbours which is adjacent to ours.
- 6. **Visual Amenity Effects**. Our property overlooks the proposed quarry site with views of the river, stock bank and pasture. There will be a major property devaluation to our property and other surrounding properties if this goes ahead.

My objections are based on "common sense". I leave the technical part of the objections to be covered by knowledgeable people. I will do an overview of the situation.

2. First and foremost, the land subject to the application is zoned Rural 1 and quarrying is not permitted under this zoning. The fact that the applicants or their representatives have purchased this land with the object of removing the gravel, and therefore more cheaply, is not a sufficient reason to grant the application. This also shows a degree of arrogance as I submit that it is usual in such circumstances for the intending purchaser to enter into an Agreement for Sale and Purchase subject to consent being obtained. Also, a representative of the applicants has readily admitted that the company's gravel requirements can be easily obtained from other sources.

Hence the application should be readily dismissed without spending any more time and money in considering the application.

3. How is the intended road going to be constructed alongside our boundary (Arthur and Derek Woodcock) where the trucks enter from and exit to the Motueka River West Bank Road. Is there going to be a raised level or some of the existing private stop bank demolished. Either way it will contribute to regular noise for the grazing cattle and dirty the pasture that is used for grazing and hay making. If the ground is raised, how will it affect our fence line?

4. I am not a traffic expert or a heavy vehicle driver but I submit that there is no way in the world that a truck, let alone a truck and trailer unit can ever get on to the existing bridge with a load and I think that the driver will even be hesitant to cross the bridge with an empty unit or with back-fill and if they did succeed they would not be able to turn left on to the proposed route.

The units will have to cross on to the wrong side of the road when entering on to the West Bank Road.

5. 3 4 and 5 Owner Occupier - RT NL 11A/111 I require full details of what is intended.

493 has a right of way over our property. Is it proposed that this right of way be utilised (not according to the picture figure 17)

Is this right of way not to be used when the gravel extraction is moved to 493 - Pt Lot 1, DP 9860/RT NL8C/62 if the Resource Consent is granted.

It is noted that the original application for 493 Motueka River West Bank Road has been deleted but it is now stated that a separate application for 493 may be applied for in future.

Page 6 states that the application "is considered to give positive effects on the wider community" Very conveniently, the negative effects on the surrounding properties, roading etc is not given a mention.

6. Page 10 - Final paragraph 'temporarily stored' How much is this likely to be? What is the definition of temporary and what happens when a flood occurs, the weather gods will not wait for 15 years to pass by.

7. Page 10/11 It is stated that on average the gravel surface is around 0.5 to 1m below ground level and yet the top soil to be replaced is only 300mm. This in itself clearly states that the ground will not be returned to its normal fertility but I understand that land can never be reinstated to its prior productive capacity once it has been tampered with by this type of activity and what will happen to the surplus soil?

8. Page 11 - Transport Access - refer to my (4) above.

9. Applicant P19 (16) and P 20 (18) and (20)

When the West Bank Road was constructed, the road makers never envisaged the size of today's rigs. The road may be capable of handling up to 1,000 to 3,000 vehicles per day (P. 20 (16) of application) as stated in the applicants submission but the road is not capable of handling 4 CJ's units an hour or one every 15 minutes. The road is simply not wide enough in several places, there are many corners and some in the summer months are subject to car driver hitting sunstrike spots. It is anyone's guess as to the traffic volumes during the summer time.

What is the minimum width of this road and the width of the Motueka River Bridge?

The reference to logging trucks is mischievous. These logging trucks are very much intermittent, do not have 30 movements a day, do not have 4 units every hour and also do not last for any length of time, only on basically a weekly basis, do not last for months and certainly never for a continuous period of 15 years. They are only for a short period of time.

There are other heavy vehicle movements on a regular but intermittent basis e.g. Sollys Trucks, Milk Tankers, Livestock Trucks and School Buses. I submit that these trucks and buses will have serious problems in passing one another if they meet in the wrong place.

The current heavy duty vehicles using the West Bank Road regularly and often (not just once per trip) hit and even cross over the white line marking the centre of the road.

What is the weight restriction currently imposed on this road?

There are many other road users who will have their safety put in jeopardy e.g. the regular mums and dads in their cars and utilities, the walkers, joggers, cyclists (also part of the cycle trail), popular with motorcyclists, holiday makers with their boats and caravans, campervans, vintage and classic car enthusiasts.

In respect to cyclists these use the road every day (very popular for recreation cycling and cyclists do the loop from Motueka) they are of all ages and range from the solo cyclist to groups of 12 to 15. It is not just a case of one cyclist a day but you can see one/or more cyclists and five minutes later see another cyclist/s.

The road is popular with people going from Riwaka and Golden Bay to the south and vice versa.

Then there is the maintenance of not only the West Bank Road but also the East Bank Road.

#### 10 Applicants P 20 (19)

Traffic movements have suddenly gone from 30 per day to 40 per day. A change before work has actually begun. "The proposal's trip generation will have less than minor effect on the road network".

How can anyone make this statement? They obviously have no knowledge of either road i.e. the West Bank Road and East Bank Road.

Thirty to forty extra heavy vehicle movements a day is many more than what the road currently carries.

Even without these extra heavy vehicles, there are regular pothole sites and these always seem to wait a long time to get only temporarily repaired and road edges breaking up. These extra vehicles will, I suggest, also create considerable strain on the main part of the roads.

11 P 25 (8)

"Types and quality of introduced fill"

Greater clarification needs to take place here.

e.g. A) "Only clean and <u>substantially</u>" (what is the percentage?)

- B) It may include gravels etc (so it does not have to)
- C) timber is sawdust wood/timber
- D) no metallic objects (except for reinforcing material?)

How is this going to be monitered?

#### 12 P. 27 Tasman Resource Management Plan

The last paragraph states that "Due to the fact that the application site is surrounded by elevated residential activities on the valleys hills, there will be some adverse visual effects" etc is <u>NOT</u> mentioned in P. 24, point 9.

13. Several references are made to the applicants Douglas Road site in support of this application e.g. P31 - Heavy Vehicles and Traffic Effects and I incorporate Dust and Noise Effects here.

There can be no comparison between Douglas Road and 134 Peach Island Road because:-

a) Dust and Noise rises. The proposed site is on the edge of an amphitheatre setting. Not only will the dust rise but also the noise will rise and spread out. As recently as <u>Saturday</u> 22 January 2022 (not a work day) CJ's unloaded a gravel truck at 134. This completely shattered the quietness and tranquillity that I was enjoying on my property. There are many months of the year when there is a lot of air movement e.g. winds and breezes.

b) The roading to and from each site is as different as "chalk and cheese" as those of you who have visited the sites will well know. There simply is <u>no</u> comparison. Douglas Road to Hau Road is a flat and straight stretches, visibility is no problem, West Bank Road is narrow, winding, has ups and downs and visibility is restricted.

14. Heavy Vehicle and Traffic Effects continued P. 32

In reference to the bank trimming does the applicant know where the boundary is. Should this take place, is a retaining wall intended to be erected and at whose cost? The bank is very much unstable, composed of loose gravel.

#### 15. Visual Amenity Effects P. 32

Quarrying does not form part of the overall working rural environment and if permitted can only have a negative effect on the view of surrounding properties. Gravel extraction in this region is not quite common and pine plantation clear felling can not be seen from most of the surrounding residences because of the siting of these dwellings.

Large scale clear felling does not occur relatively frequently. Pine trees take 25 plus years to grow to the felling stage. The visual effect will be major, not minor, as stated.

#### 16. Consultation and Affected Parties P. 33

I note that the first two bullet points have names to them but not the next two, both of which are owned by myself and my brother Derek. Also Sec 32 is <u>not</u> part of a larger property to the south, this has its own title and does <u>not</u> extend across the opposite side of the Motueka River West Bank Road.

Properties 458, 470, 472 and 478 are referred to. I suggest that 504, 506 and 521 could have been included.

In reference to the applicants consultation methods, although I represent the land that is at the point where vehicles will exit on to the West Bank Road and conversely enter from the West Bank Road and will travel some distance alongside of our property, the applicant has never had the courtesy to approach myself or my brother but in fact stated in the first application that they had consulted with myself. This has never occurred and I only found out about the application from a third party. The statement is made that the truck movement will not adversely affect these parties in a more than minor way especially when considering the effects from the existing road networks. There are <u>NO EXISTING ROAD NETWORKS</u> close enough to have <u>ANY</u> affect.

#### 17. Section 95 of the RMA Page 35

It would appear that the applicant originally applied for the Council to consider nonnotification of their application because "adverse effects on the environment will be less than minor, and there will be <u>less</u> than minor effects on persons, including owning or occupying adjacent land"

I have been advised that since lodging this application the applicant has requested the Council to publicly notify the application. If this is the case the applicant must now realise that the application is <u>NOT</u> minor after the continuous use of "less than minor".

18. Complaints: The applicants wish to use one of their own to be the receiver and handler of any complaints. I suggest that this is totally unacceptable and any complaints should either be lodged direct with the Tasman District Council or an independent person.

19. Working Hours If the application is granted, I request that the starting time be reduced from 7 am to 7.30 am on the grounds that many residents are retired and it will not take long for the workers to start arriving from 6.30 a.m. to start work at 7 a.m.

20. Does the applicant commit to not transporting any gravel from the Peach Island to its depot in King Edward Street, Motueka.

#### 21. General

My roots in the area go back to 1847 but there have been many dwellings erected in the vicinity during the last 40 years. Most of them more recent than this. I suggest that these residents were attracted to the area because of its zoning and tranquillity and both of these are now under threat for no good reason.

CJ's have admitted that they can get gravel elsewhere should this application fail. Even if this is not correct, it is not a sufficient reason for the Tasman District Council to acquiesce to the application.

In conclusion, I have attempted to concentrate on the "common sense" approach to the application, leaving the legal/technical approach to other objectors and their expert advisers to canvas.

Simply put, I re-iterate that the applicant and/or their associates purchased the land in question merely to obtain cheap gravel giving no thought to the adjoining landowners or neighbouring residents or the cost to the Tasman District Council in maintaining the West Bank Road, or to the safety of the many and increasing number and variety of the users of the West Bank Road while all the time they could obtain their gravel requirement (from their own admission) from other sources.

The frivolity of this application is further highlighted by the approach to the Council made by the applicant in that they have made at least three applications, taking on board the advice/information received from the Council, even in their first application they made the statement that they had consulted with myself and that I had no objections but in fact, to this day, there has been no approach to myself, I only found out about the application from another source, yet I am directly effected.

Finally, I request that should the Councillors feel to be in favour of the applicants request that they first visit the site and road themselves to personally become informed of the major detrimental effects that will flow from any such decision.

I am making this submission on behalf of myself (Arthur Woodcock), Derek Woodcock and Shaggery Holdings Ltd.



Backfill material - Referring to the Douglas Road site, CJ's have a poor track record of not 'doing what they said they were going to do' in terms of backfilling the site. As referred to in RMCB11-12-08 to the Motueka Community Board "A number of infringements and consequent abatement notices had been issued but no evidence of serious toxic materials or contamination". Whether or not toxic material was dumped there, the fact is other non-natural material was likely dumped, and though this may not be considered 'toxic', it is still a practice that should not be tolerated. I do not have faith that the Applicant will backfill the site with materials that the receiving environment deserves, and I also do not believe there will be adequate monitoring (by the Council) of backfill substances which are getting put there.

Conservation Order. People live there due to the outstanding recreational and intrinsic values it provides. Without doubt, the proposed extraction for a 15 year term, will negatively impact on the character of the Motueka Valley, and the lives of people that live in the area.

Truck movements - while I understand there are other commercial users of the Motueka Westbank Road, this is a very narrow road and an additional 30 truck movements is a significant increase in heavy transport that will affect the safety of users of this road (residents, recreational users etc).

The need for gravel - I completely understand the need for gravel in a growing region. I just believe it should be taken in areas that will have less effect on its residents, and seek to achieve environmental outcomes such as wetland creation and native fish/bird habitat. Take the Waimea River gravel extraction (that will commence soon) for example: this is a win/win for the region and environment alike. It caters for a significant amount of gravel, but in the end this will be valued habitat for native fish and bird life, and be developed in a way that will be a recreational site for the public to engage with nature - a community asset. We need similar in Motueka, and there is land within the lower Motueka bermland that will cater for this - a part of the river which has little residential occupancy and significant horticulture already. It just requires the Council and the manager of this land to 'think big' for a triple win: provide gravel, habitat for native species, and a recreational area the public can use and engage with. Dig the holes, add a link to the river, plant it out in natives, and create tracks and picnic areas. And while I'm mindful of the flood event last July and those into the future, the precedent has been set with similar in the Waimea River corridor and other wetlands on private land within the lower Motueka, so I can see no reason this can't be achieved.
