Background

Local Government Act 2002 – Pecuniary Interests Returns

As of November 2022, new sections 54A to 54I of the Local Government Act 2002 (**LGA**) require elected members to provide an annual return of certain pecuniary interests. “Pecuniary interest” is defined in s5(l) LGA as “a matter or activity of financial benefit to the member”: The return period for LGA interests disclosed in this summary is 14 January 2022 – 13 January 2023. These sections of the LGA only apply to elected members.

The pecuniary interests that must be disclosed fall into these broad categories.

- Companies where an elected member is a director or significant shareholder
- Other companies or entities in which an elected member has a pecuniary interest
- An elected member’s employer(s)
- Trusts in which an elected member has an interest
- Organisations of which an elected member is a member, if the organisation receives or applies for funding from Tasman District Council
- Any organisation in which an elected member holds office by virtue of being an elected member
- Real estate in which an elected member has an interest, including where the property is held in a trust of which the elected member is a beneficiary
- Overseas travel, except where travel costs and accommodation were paid for in full by the elected member or a defined family member
- Gifts, including hospitality and donations over \$500 from the same donor
- Payments received for activities in which an elected member is involved.

Local Authorities (Members’ Interests Act 1968 (LAMIA))

Elected (and appointed) members also need to comply with the Local Authorities (Members’ Interests Act 1968 (LAMIA), in particular:

- (a) the contracting rule prohibits members from being interested in any contracts (e.g., being a director of a company who is party to the contract, being a sub-contractor of an entity who is party to the contract) with the council that have a combined value of more than \$25,000 (including GST) in a financial year – unless the Auditor-General approves the arrangement; and
- (b) the participation rule prohibits members from participating in any council decision-making in which the member has a pecuniary interest that is not one held in common with the public – unless the Auditor-General has pre-approved such participation.

Public Summary of LGA and LAMIA interests

This summary combines elected members’ disclosures under the LGA via their annual return, and contains additional interests disclosed under LAMIA. LAMIA interests are updated in this summary as circumstances change, and new or updated declarations of interests are made by elected and appointed members.

This summary is made available to the public to provide transparency and to enhance public trust and confidence in local government processes and decision-making.
