# Current work program

#### Tasman Environment Plan (TEP)

- Half way through issues & options work
- Consultation complete on around half of TEP topics
- Consultation mid 2023 on rest of topics
- Includes big issues like Natural hazards, Biodiversity, Freshwater

#### Other Environmental policy work

- Te Waikoropupū WCO
- Growth Plan Changes
- Mapua Master Plan
- Deferred zoning PC
- Urban Growth and Govt reporting
- Future Development Strategy implementation and review

# New legislation and implications

Resource Management Act (RMA) will be repealed & replaced with three new Acts:

- 1. Spatial Planning Act (SPA)
- 2. Natural and Built Environment Act (NBEA)
- 3. Managed Retreat and Climate Change Adaption Act (CAA)

# **Key Planning Instruments**

## National Planning Framework (NPF)

- Existing national direction collated into NPF
- Sets national and potentially regional environment limits and targetsand will apply to:
  - Air Indigenous biodiversity - Coastal water - Estuaries Freshwater Soil

### Regional Spatial Strategy (RSS)

- 30 years + vision, objectives
- Priority actions
- Implementation plans and agreements
- Collaboration—iwi, central and local govt
- Links NBEA, LGA, LTA, CCRA

# Natural and Built Environment Plan (NBE Plan)

- Combined Plan for Tasman & Nelson-
- Directed by National Planning Framework (NPF)
- Needs to be consistent with the RSS
- Council input via RSS and voluntary instruments
   Statements of Community
   Outcomes (SCO) or
   Statements of Regional
   Environmental Outcomes
   (SREO)

# Governance & DecisionMaking

Regional Planning Committee (RPC)

Purpose: to make, maintain and monitor implementation of RSS and NB plans for Region

- RPC composition & processjoint decision between TDC, NCC, Iwi
- Councilsmust in good faith jointly fund and provide resources
- Iwi participation agreements required to start ball rolling
- Supported by Secretariat (RPC appoint director)

#### Time frames


RPC must notify draft RSS within seven years of Royal Assent

- Unless Minister sets a later date
- No time frames for completion of RSS process


RPC must notify NBE plan within four years of RSS being adopted

Can't start drafting RSS until the Government completes the National Planning Framework – end of 2025

# Time frames—quickest



#### Time frames-slowest



#### Considerations

TRPS and TRMP will remain until new NBE Plan is operative

- Establishing the RPC likely to take at least two years
  - Resourcing required through LTP
  - Iwi participation agreements to be established
  - Information/data/evidence gathering
  - Staffing of secretariat (policy, GIS, science, engineering etc)
- FDS requires review in 2025 (commencing start 2024)

# Options for moving to the new system

Three high level options:

Option 1: Early Adopter move now

Option 2: Fast Followerlet the dust settle

Option 3: Late adopter wait and see

Must consider implications for Nelson and preferences of iwi Options 2 & 3 have sub options....

BAU not a viable option

# Option 1: Early Adopter – move now

Defer all BAU and commence transition to new system

Dedicate resources and time to establish a strategic project team to establish and NCC governance structure and processes to implement this workstream.

- ➤ Opportunity for Government resources MfE
- ➤ Risk with rushed legislation and new system
- ➤ Iwi capacity to go now?
- ➤ Would commence by end of 2023
- Council resourcing –science and information requirements significant

**But** we haven't seen the Managed Retreat and Climate Change Adaption Bill or the proposed National Planning Framework

# **Option 2: Fast Follower**

#### Wait two years for new system to bed in:

- Progress priority plan change/s to TRMP: and
- Freshwater Plan
  - Freshwater PC to meet Dec 2024 deadline
  - Decision on whether this is joint with Nelson or two separate PCs?
- Start preparing for transition
- ➤ Opportunity to learn from early adopters
- ➤ Gives iwi more time
- > Plan changes can be rolled into NBE plan
- Could resolve some big planning issues now and avoid re-litigation in a few years

# Option 3: Late adopter

- Progress series of plan changes to TRMP: and
- Start preparing for transition (2028h)
- Freshwater Plan
  - Freshwater PC to meet Dec 2024 deadline
  - Decision on whether this is joint with Nelson or two separate PCs?
- ➤ Opportunity to learn from others
- ➤ Gives iwi more time
- TRMP getting older ...

Pressing issues include deferred zone PC, Growth, freshwater, ONLF work to date, can these wait?
