#### 1. Welcome

David welcomed everyone to the meeting. Daren led a karakia to open the meeting.

#### 3. Minutes of last meeting – 21 September 2020

#### 4. Ngaio Reserve

The Heritage New Zealand stand down period has concluded.



Steve has spoken to the archaeologist regarding availability.

Still to speak with iwi.

Start date needs to be confirmed.

A meeting was held with Nelmac today to discuss works but still awaiting the tender documentation.

Steve has met with the contractor and an electrician re the lighting.

The ferry operator has been contacted to arrange safe passenger access during the project works.

It is proposed to undertake a two stage project.

- 1. half of the site adjacent to Golden Bear
- 2. second half adjacent to the foreshore walk along the beach or use the wharf depending on the tide.

Work is proceeding on the bike racks, picnic tables and bollards. A meeting will need to be scheduled with Māpua Boat Club to plan the dinghy storage rack.

A budget needs to be confirmed for the pou.

A meeting also needs to be scheduled with the Golden Bear.

It is anticipated the project will take 34 working days for a team of four for stages 1 and 2.

If koiwi tangata is found work would cease. An area has been designated for reinternment. Authority to re-enter the site would need to be given by the Police CIB.

Ngati Kuia have asked to be part of the iwi monitoring group. This needs to be discussed between the tribes. Steve will co-ordinate a meeting.

Richard Hollier advised two options for grassed area

- 1. Standard turf
- 2. Artificial turf \$20k more but lower lifetime maintenance costs

Considerations would be opex vs capex implications and sustainability – possible microplastics when it breaks down.

The Reserve Subcommittee will consider options for the interpretation panels once the budget has been finalised.

Richard Hollier will do a summary of actions for Ngaio Reserve to formally become a reserve.

Mark Johannsen will check how rezoning would proceed under the TRMP.
