We note that the applicant has given a series of undertakings as follows:

- The display of alcohol will be contained within the area demarcated by the "woodgrain" vinyl floor covering;
- The "end of aisle" display at the rear of the alcohol area, shown in the photo above and marked as "E" on floor plan will be removed;
- A small barrier wall similar to that currently in place where the flowers are displayed will be installed at the entrance end of the alcohol area;
- No wine displayed on the rear facing of the "island" (marked as "D" at the rear of the alcohol area will be under the price of \$14.99;
- these changes will be in place on or before 30 September 2016.
- The rear facing "end of island" display ("D" on Floor Plan 1) will be removed within three months of being advised that this is required as a consequence of the outcome of the appeal of the High Court Judgement (J Gendall CIV-2015409-000098 (205) NZHC 2749) that is currently before the courts.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act and grant the application accordingly. In accordance with Practice Statement LIQ/ADM 1 issued under s.176 of the Act a new licence will issue which will expire on **19 February 2019** unless again renewed.
