## 1. Summary / Te Tuhinga Whakarāpoto

- 1.1 The Dog Control Act 1996 (DCA) Section 10A requires territorial authorities to publicly report on dog control policies and practices for each financial year. This report contains the information required under the DCA for the year 1 July 2023 to 30 June 2024. It is a requirement of the DCA that a copy of this report be made publicly available once adopted.
- 1.2 Dog numbers have continued to increase in urban areas.
- 1.3 One more person was disqualified from dog ownership.
- 1.4 Complaint numbers have fallen, notably those related to wandering/found, dogs barking and attacks on stock.

## 3. Purpose of the Report

3.1 This report constitutes the annual report that the Council is required to prepare in administering its obligations under the DCA.

### 4. Background and Discussion

- 4.1 The Council reviewed its Dog Control Policy and Bylaw in 2014 adopting the Dog Control Policy 2014 and Dog Control Bylaw 2014 on 18 September 2014. A full review of the Dog Control Bylaw and Dog Control Policy is currently out for public submissions.
- 4.2 The objectives of the Dog Control Policy are:
  - To promote responsible dog ownership.
  - To minimise any danger, distress or nuisance created by dogs.

- To have regard to the welfare, exercise, and recreational needs of dogs, and
- To identify required means of dog control in all public places.
- 4.3 Control Services (Tasman) Ltd is contracted to implement the Council's dog control policy and bylaw. Compliance is achieved by:
  - Responding to dog-related incidents
  - Targeted property visits and patrols of areas with specific issues
  - Close liaison and cooperation with external agencies
  - Conducting dog safety and bite prevention programmes
  - Education programmes delivered to schools.
- 4.4 The Council uses various media to inform the public of dog-related issues. The Council's website provides dog-related information, online forms and links to relevant legislation and other websites of interest.

- 6.2 The trend of rising dog populations continues within the district, with a notable dominance of dogs in urban areas compared to their rural counterparts.
- 6.3 Failure to provide a robust and efficient dog control service would conflict with our fundamental principles of Kawenga (responsibility) and Manaakitanga (hospitality and kindness), which are integral to our community ethos.

7.1 Provision of this report to the DIA and general public achieves compliance with the requirements of the DCA.
