

No-no's

Some hazardous waste will not be accepted through this process.

These prohibited items (some listed below) need to be handled by other agencies.

Commercial Hazardous Waste including farm waste

Contact a specialist waste disposal contractor. Check the Yellow Pages of your phone book for details, under Hazardous Substance Management.

Agrichemical waste

- Take the waste and the signed form to the Nelson City Council's Pascoe Street Refuse Transfer Station.**

Where should your old chemicals go?

The problem

Putting out hazardous chemicals with general household rubbish can do a lot of damage.

Common examples are old garden sprays, household cleaners and chemicals used in hobbies like pottery and lead-lighting.

If the packaging is leaky, they can cause harm to waste collection staff.

Once in the landfills, the waste can leak through soils, contaminating groundwater, affecting our food chain.



The answer

Tasman District Council now provides a drop-off service for household hazardous waste in conjunction with Nelson City Council.

Here's how it works...

Nelson City Council have agreed to store hazardous waste from Tasman District Council providing it is accompanied by the signed form in this pamphlet. Tasman District Council remains legally responsible for the waste it accepts and this vetting process is necessary to ensure everything is done safely.

There is a small cost

There is nominal fee for this service to Nelson City Council.

Under 2kg: no charge

2 – 5 kg: costs \$9 a load and thereafter \$2 per kg.

What to do

1. Make a list of the name and quantity of all the hazardous waste you want to dispose of.

Send the list attention to: Resource Scientist – Contaminants.

- take the list into one of the Council service centres or
- fax it to 03 543 9524 or
- post it to Private Bag 4 Richmond, 7050.

2. The signed form will be returned to you and you can take this form plus your safely package hazardous waste to Nelson City's Refuse Transfer Station on Pascoe Street, Tahunanui (off Quarantine Road). Here it will be accepted by trained staff for storage.

What if...?

If you have an unknown substance and you're not sure what it is, any information you can provide will assist the experts to identify the substance, e.g. tell us if you know that the substance was used on the farm or in the home.

If you are unable to transport chemical to Nelson, staff will discuss alternative transport arrangements.
