Registration on a waiting list is required if a person seeks water from a water management zone that may be fully allocated. Registration on a waiting list grants priority in time in accordance with Policy 30.2.6 of the Tasman Resource Management Plan (TRMP). When water becomes available in a fully allocated zone, persons on a waiting list will be invited to apply for a water permit in order of the waiting list.

This registration does not constitute a water permit application. This registration form must be fully completed to satisfy Council's requirements for the registrant's name and details to be added to the Council's waiting list for water. It is also important that the registration information demonstrate to Council a need for water.

Waiting list - is a written list maintained by Council of registrations that are:

- (a) lodged on the list in priority in time order; and
- (b) accompanied by information on need for and amount of water taking and use; and
- (c) made by persons seeking to have authorised water takes, in water management zones where there may be full allocation of available water.

Every proposed irrigation bore in all deep Moutere groundwater zones (ie. the Moutere Eastern, Western, Southern and Coastal Groundwater Zones) must comply with the setback distances from existing bores and casing specifications specified for these zones in Figure 16.12A TRMP. The purpose of this requirement is to avoid excessive localised reductions in bore yields due to pumping drawdown effects.

Council will generally decline to register new bores where setback and casing requirements for the Moutere groundwater zones are not met, except in exceptional circumstances.
