2. What attributes are important for our values/objectives?



3. What state do the attributes need to be?



4. What is the current state of these attributes?



5. How do our desired and current states compare?



6. What are the threats and risks to attributes/objectives?



7. How can we manage the attributes and threats/risks?



8. Can we afford it, will this be effective?



#### Process from here

- Work through AMA-TWS zone recap (today)
- Review approach in light of AMA decision/options
- Identify desired attribute states all attributes (mid-late July)
  - Maintain vs improve situation
- Science panel feedback (late July 28th?)
- Review summary document (late July-early August)
- Review water quality risk management (early August)
  - Understand implications
  - Identify key projects for implementation plan
    including future plan changes
- Meet with iwi in this process (?August)
- Approve proposed solutions package (mid August)
- Workshop with EPC (1 Sept)

#### Process considerations

- What you put into the process will be tested
  - EPC decision on what goes into Sch.1
  - Council or commissioners decision on public submissions and what comes out
  - Court decisions on appeals (if any) gives final outcome
- What are key desired outcomes for this plan change?
  - Ensure these are robust and defensible
  - Protecting minimum flows with cease takes
  - Allocation limits for reliable and sustainable water use
  - Regulatory controls on land and water use and discharges to manage identified risks to water quality
- What needs to go in the implementation plan?
  - Non-reg support for projects that make things better
  - New monitoring, investigations, PCs for future improvements

## Questions for today – for the AMA-TWS review

- What are the desired states for these attributes?
- Are we in a maintain or improve situation?
- What are the threats/risks we want to control?
