1 OPENING, WELCOME

Mayor King welcomed everyone to the meeting and opened proceedings with a karakia.

2 APOLOGIES AND LEAVE OF ABSENCE

That apologies from Cr Greening and for lateness from Cr Maling be accepted.

Cr Bryant noted his concern that Cr Greening continually tenders apologies for his attendance at Council meetings. Mayor King said that he will discuss this concern with Cr Greening.

3 PUBLIC FORUM

Mik Symmons (via Zoom) spoke about the Hamama Water Supply Scheme referendum. He noted that the local community have been involved and paid for this water supply over time and have managed it over the last 40 years.

Mr Symmons said that, in his opinion, some incorrect information had been included in the report. He spoke about the closed account and noted that funds had been accumulated to cover unseen events and maintenance of the scheme. He said that the Hamama residents were concerned about the costs for the proposed referendum which equates to over \$300 per scheme member and suggested that with the closed account there is no impact on anyone other than those ratepayers who use the scheme. Mr Symmons said that the report was the first time that the scheme users had heard about the proposed Special Consultative Procedure and the required amendments to the Council's Revenue and Financing policy. He said that costs had been included in the report that were not discussed when this process was initiated in 2018. He suggested that the Council staff should look at the agreements noted in the 2018 report to the Engineering Services Committee.

Richard Johns spoke about the Waimea Community Dam and central government's decision to decline funding for the project. He suggested that the Council may not be able to afford to complete the dam and asked at what stage the Council would do something about making that decision.

7 PRESENTATIONS

7.1 Golden Bay Marine Enhancement Group

Neil Wilson and Gordon Mather provided a powerpoint presentation. They spoke about the present state of the local marine environment and suggested that the environment was severely degrading with previous abundant species now absent or in very low numbers.

Mr Wilson suggested that the accumulation of fine sediment from land runoff is higher than anyone knows. This accumulation has a smothering effect and the resulting toxic sludge is impacting on marine environments. Mr Wilson referred to the fragile marine environment around Separation Point and suggested that boaties should not be allowed to anchor their boats in this area.

Mr Mather asked the Council for their support for stronger protection of the marine environment. He suggested that there is a considerable lack of knowledge about our current marine resources and that means the marine environment cannot be managed appropriately. He proposed that the Council could do an inventory of the marine environment listing significant ecosystems and what treatment is required to protect them. He noted that Manawhenua ki Mohua support the marine enhancement group's aims. He also suggested that the Council should engage with the community to make them aware of the issue and to help promote a sense of public guardianship.

Mr Mather and Mr Wilson tabled their presentation and invited the Councillors to see examples of their work in Golden Bay.

Several Councillors thanked Mr Mather and Mr Wilson for their thoughts on how the Council can be involved in protecting the marine environment. It was agreed that staff should provide a report to the Regulatory Committee focusing on how the Council may support the group's aims.

8 REPORTS

8.1 Hamama Water Supply Referendum

Water Engineer, Becky Marsay and Engineering Services Manager, Richard Kirby presented the report which was taken as read.

In response to a question, Ms Marsay said that she was not aware of the issues raised in the public forum by Mr Symmons. Mr Kirby noted that the referendum is a proposal at this stage and staff will consider the issues raised by Mr Symmons. He confirmed that the Council will still be required to follow the special consultative procedure process.

Mr Kirby said that the Local Government Act requires the Council to carry out a referendum with the Council's electoral officer managing the process.

Several Councillors raised their concern about the costs of the referendum and the special consultative procedure. In response, Mr Kirby said that the referendum and special consultative procedure could be funded from the general rate if that is what the Council wants.

After some discussion it was agreed to amend the resolution to note the concerns raised by Mr Symmons.

Wastewater Engineer, Juliet Westbury and Mr Kirby presented the report which was taken as read.

In response to a question, Mr Kirby confirmed that the funding in the draft Long Term Plan for this capital works will be transferred to the NRSBU in year two of the Long Term Plan. Dean –

Ms Westbury confirmed that the new liner is a proven technology that will manage the wastewater velocities.

8.4 February 2021 Quarterly Financial Update

Finance Manager, Matt McGlinchey and Corporate and Governance Services Manager, Mike Drummond presented the report which was taken as read.

In response to a question about the forecast shortfall in capital expenditure, Mr Kirby said that some of the projects were being held up waiting for resource consent approval. He also noted that the Council has had issues with engaging design consultants to work on the water treatment plant projects, adding to the delays in the projects being completed.

In response to a question, Mr Drummond said that the Council's policy approach around managing surpluses is included in the financial strategy and treasury policy. If project work will be carried out in the following financial year, staff retain the funding in its nominated activity.

Community Services Manager, Susan Edwards noted that the reforecast of expenditure in Community Services related to:

- timing of payment for the work at the new Motueka Library;
- the carry forward of funding for the car parking and drainage to complete the Golden Bay Recreation Centre; and
- a delay in land purchase affecting the Reserves Financial Contributions expenditure budget.

In response to a question, Mr Drummond said that the relocation of the kitchen in the civic area

was carried out in a cost-efficient way dovetailing with the earthquake strengthening work which was being done at the time.

8.5 Treasury Report

Mr Drummond and Mr McGlinchey presented the report which was taken as read.

In response to a question, Mr Drummond said that funding for the cost overruns for the Waimea Community Dam will be progressively drawn down from the \$18 million CIIL loan facility from August 2021 through to September-October 2022.

Cr Hill returned to the meeting at 11.07 am.

Responding to a question, Mr Drummond said that the Emissions Trading Scheme (ETS) is reported on because it is covered by the Council's Treasury Policy which requires us to report even when the Council has no exposure under the ETS. He said that he would amend the commentary to reflect the Council's non-exposure in the future.

In response to a question, Mr Drummond said that the Council receives a weekly market update from the Local Government Funding Agency. Staff monitor and act accordingly on this update which forms part of our planning and treasury management, including managing our risk profile.

8.7 Chief Executive's Update

Chief Executive, Janine Dowding spoke to the report contained in the agenda which was taken as read.

In response to a question, Ms Dowding said that the new positions being advertised in the information technology team were the result of the Council's support of the reorganisation in the Chief Information Officer's department.

Referring to a question about the digital technology in the Council Chamber, Ms Dowding said she will speak to staff about utilising the roving camera.

In response to a question about the Māori Liaison Officer vacancy, Environment & Planning Manager said that this role was a fixed term contract working with iwi on the Jobs for Nature projects.

Mr Drummond noted that the Property Officer role is a new position that had previously been a fixed term position. The new role will manage the growing workload within the Property Services team.

Ms Dowding noted that the Council is currently experiencing a higher staff turnover than normal. She said that many government departments have an increasing appetite to have their staff based in the provinces, working remotely. This has resulted in some of our staff moving to government department jobs which offer both better remuneration and benefits. It also affects how the Council can attract job applicants.

He said that the Waimea Irrigators Ltd Board had considered the SOI and there were no matters to bring to the Council's attention.

Responding to a question about quantifiable performance measures that would help keep the

community informed, Mr Drummond said he would discuss this issue with Waimea Water Ltd and any change would be reported back to the Council through the final SOI.

It was noted that the entity and stakeholder information within the SOI is out of date and includes reference to the Nelson City Council. Mr Drummond agreed that this information should not be included in the SOI until Nelson City Council provide their share of the funding and the draft resolution was amended to reflect that.
