3.1 LONG TERM PLAN 2021-2031 SUBMISSIONS HEARINGS

1 Summary

- 1.1 The Long Term Plan 2021-2031 (LTP) consultation period has now closed. We received 1695 submissions within the submission period of 24 March 2021 to 24 April 2021. This report seeks that you accept the submissions received up until 30 April 2021, including late submissions, and that the submissions received after 30 April 2021 are not accepted.
- 1.2 This report sets out the submitter hearing schedule for the four days, 4 to 7 May 2021. Subsequent changes to the submitter order will be advised before the beginning of each Hearing day.
- 1.3 An analysis of the submissions received will be presented to the Hearing Panel prior to deliberations which are scheduled for 17 to 21 May 2021.
- 1.4 There are two submitters that have requested to speak confidentially in a public excluded session to provide more information and context to their public submissions. This additional information, if released publicly, would likely prejudice the commercial position and operations of these entities. This will be done in accordance with the Local Government Official Information and Meetings Act 1987:
 - s7(2)(b)(ii) The withholding of the information is necessary to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information; and
 - s7(2)(h) The withholding of the information is necessary to enable the local authority to carry out, without prejudice or disadvantage, commercial activities.

3 Purpose of the Report

- 3.1 The purpose of this report is to accept the submissions received on the proposed LTP 2021-2031, including late submissions received between 25 to 30 of April 2021.
- 3.2 This report also sets out the Hearing submitter schedule. Any changes to the submitter schedule will be advised at the beginning of each day.
- 3.3 This report does not include the staff deliberations report. This will be provided to the Hearing Panel prior to deliberations.

4 Background and Discussion

- 4.1 The Hearing Panel will consist of Full Council and the Hearing Panel Chair is Mayor Tim King and the Deputy Chair is the Deputy Mayor Cr Bryant.
- 4.2 Hearings are to be held:
 - Tuesday 4 May commencing at 9.30am in Richmond at the Council Chambers;
 - Wednesday 5 May commencing at 10.00am in Takaka at the Golden Bay Recreation Centre;
 - Thursday 6 May commencing at 1.30pm in Richmond at the Council Chambers and
 - Friday 7 May commencing at 9.30am in Motueka at the Motueka St John Hall.
- 4.3 Deliberations are to be held in Richmond at the Council Chambers on:
 - Monday 17 May commencing at 9.30am;
 - Tuesday 18 May commencing at 9.30am;
 - Wednesday 19 May commencing at 9.30am; and
 - Friday 21 May commencing at 9.30am.
- 4.4 Each submitter has been allowed a maximum of 10 minutes to speak to their submission. This time includes any points of clarification from the Hearing Panel. If the submitter uses their full 10 minutes, there is no additional time for questions due to the number of submitters wishing to be heard.
- 4.5 As at noon, 28 April 2021, staff have not yet contacted the 186 submitters who have indicated that they wish to speak in support of their submission.
- 4.6 Staff have asked submitters to be available from the start of the hour that they have been assigned to, and staff have allocated up to eight submitters per hour. This is in the knowledge that some will not use their allocated 10 minutes and that there may be some submitters who do not attend.
- 4.7 The Council received 206 proforma submissions recording support of a replacement boat ramp for Māpua, of which 36 have asked to speak to their submission. Staff have asked all submitters in this group to attend from 5:30pm at the Richmond Hearing on Tuesday 4 May. While there is a risk that this number will require a later finish to the meeting, staff have assumed that the group may collectively achieve some synergies and efficiencies in their feedback.

- 4.8 There were five submissions that contained unacceptable and defamatory comments. Those submissions have been accepted but with the unacceptable comments redacted. A full copy of those submissions will be confidentially provided to Councillors.
 - 4.9 There are two submitters who have requested to speak confidentially in a public excluded session. They are representatives of Port Nelson and Nelson Airport. The submitters intend to provide more information and context to their public submissions. This additional information if released publicly would likely prejudice the commercial position and operations of these entities. This will be done in accordance with the Local Government Official Information and Meetings Act 1987:
 - s7(2)(b)(ii) The withholding of the information is necessary to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information; and

6 Strategy and Risks

- 6.1 Due to the large number of submitters wishing to be heard, staff have allocated each submitter 10 minutes to speak to their submission. This 10-minutes allocation is equivalent to past hearings, where we have found this time to be sufficient for submitters to provide their views and for questions from the Hearing Panel.
- 6.2 In keeping with our current established policy and practices, we recommend that late submissions be accepted up to one week after the close-off date for consultation. Those

received after that time should not be accepted. There is a risk that those submitters who returned their submissions after 30 April 2021 will be disappointed with this decision.

7 Policy / Legal Requirements / Plan

7.1 As required under sections 82 and 83 of the Local Government Act 2002, we are required to provide the opportunity for submitters to present their submissions to the Council.

8 Significance and Engagement

8.1 The overall significance of this decision is low to medium as the report relates to the acceptance of the submissions received. For those late submitters they will have a medium-high interest in the decision as to whether the Hearing Panel accepts their submissions. The deliberations on submissions in May 2021 are likely to have a higher level significance.
