The Board discussed Council's decision to revise Option A for the Waimea Community Dam, a recent social media post and the preferred option from community submissions.

# Thorp Bush Playground Upgrade – Youth Council

Aki Takahashi, Youth Council Representative, spoke to a tabled document from Tasman Youth Council regarding the painting carried out for the Thorp Bush playground upgrade. The Board supported the groups frustration and acknowledged Councillor Walker for bringing the matter to the Board at the last meeting.

#### Motueka 100 year celebration first aircraft to land in Motueka

Councillor Dowler provided an update on the event planning and the Board Secretary confirmed that an application to the Discretionary Fund would be considered at the June Board meeting.

#### Motueka Skate Park

Chair Maru encouraged the Board to review the feedback included in the agenda and noted that he was pleased to see a good level of local participation and feedback from younger children. The Board agreed for Chair Maru to send a letter of support for the funding application to the Rata Foundation.

SH60 Motueka safety improvements – the Board had a discussion and agreed to await the outcome of a Long Term Plan Deliberations meeting the following day to see if the funding for Council's Motueka High Street – Streetscape Upgrade could be brought forward.

Parker Street treatment plant - the Board acknowledged adjacent residents' concerns with potential vibration and noise. Staff are working with neighbours to outline the design detail that would minimise if not mitigate any operational pumping vibrations. The pump station would be

located on the western side of the property as far away from adjacent properties as possible.

Dog park – the Board had a discussion and Chair Maru agreed to follow up with Reserves and Facilities staff.

Staff conduct - Chair Maru agreed to circulate Mr Hellyer's letter. The Board discussed the matters raised by Mr Hellyer and Chair Maru agreed to continue discussions with Janine Dowding, Chief Executive Officer, and invited other Board Members to be involved. The Board understood that Mrs Hellyer had received an apology from staff.

Maori Ward - the Board discussed Council's involvement with local iwi.

# Motueka Youth Council

Chair Maru to follow up with Glenn Thorn, Reserves Officer, on the location and cost for a disability playground in Motueka. Member Tomsett agreed to liaise with Nelson City Council on a recent installation.
