#### 1 KARAKIA, OPENING, WELCOME

Board Member Tomsett opened the meeting with a karakia and Chair Maru welcomed all to the meeting.

# 3 PUBLIC FORUM

#### Ian Wiliamson

Mr Williamson spoke to his tabled document containing five items, practical suggestions to be included in Newsline, the new library meeting room as a future venue for Board meetings, a mains water supply to the Tiro Kina subdivision and Old Coach Road, and progress of a Motueka dog park.

#### **Rachael Mason**

Ms Mason praised our amazing community for the recent donations of support shown to the Westport community.

Ms Mason spoke on behalf of the Nelson Tasman Community Transport Trust (NTCTT) and told the Board that Council had agreed to the community bus being parked overnight at the service centre carpark. Ms Mason said that the Trust would continue to lease a bus until a suitable bus was purchased, a trial run was planned for two weeks time with 11 volunteer drivers. Ms Mason encouraged Board Members to join the Trust.

#### Anneke Delou

Ms Delou spoke to her tabled document regarding the removal of Golden Elm trees on High Street.

#### **Kevin Fourie**

Mr Fourie spoke about the the low strike rate on rats at Kaka Point as part of the protection of blue penguins at the site. He also spoke about a recent accident on a section of the Great Taste Cycle trail and noted that work at the Saltwater Baths had not been completed.

#### Livinya Jayasinghe

Miss Jayasinghe tabled a petition to save the trees on High Street with over 500 signatures.

## Monty Tawhai

Mr Tawhai informed the Board of local groups for boys and men and past gang members and he emphasised the importance of raising awareness in the community.

## Ali Morton

Ms Morton spoke to her tabled document regarding the proposed NZTA safety measures and told the Board that she advocated to keep as many trees as possible. Chair Maru reminded the Board that it was a submitter on the proposed upgrade to SH60 and had not received any direct feedback.

#### 7.1 Reserve Financial Contributions

Richard Hollier, Reserves & Facilities Manager, discussed the report with the Board.

- 1) receives the Reserve Financial Contributions Report RMCB21-07-1; and
- 2) recommends to Council the proposed Reserve Financial Contribution carry forward from the 2020/2021 financial year into the 2021/2022 financial year, for the following projects:
  - \$22,000 from the Walkways/General budget
  - \$163,800 from the Toilets General budget
  - \$212,150 from the Sportsfields General budget
  - \$99,400 from the Playgrounds General budget; and
- 3) recommends to Council the proposed Reserve Financial Contributions carry forward from the 2020/2021 financial year into the 2022/2023 financial year for the following projects:
  - \$48,225 from the Motueka Quay Carpark/Landscaping budget
  - \$34,650 from the Sportsfields General budget
  - \$58,200 from the Playgrounds General budget; and
- 4) recommends to Council the Reserve Financial Contributions Capital projects to be undertaken in the 2021/2022 financial year and the projects proposed for the following two years as set out in the following table; and

## SH60

The Board acknowledged the petition from Miss Jayasinghe. The Board discussed the questions raised at public forum regarding the removal of trees and agreed it had supported the plan during consultation. Mr Kirby confirmed that the land belonged to Waka Kotahi. The Board noted that submitters were awaiting an updated plan from Waka Kotahi. Mr Kirby told the Board that Council should respond to queries out of courtesy and agreed to contact Waka Kotahi on behalf of the Board to seek an update.

Chair Maru agreed to seek a formal response from staff regarding a policy for tree replacement.

#### **Community Board Delegations**

#### Cr Ogilvie Update

Cr Ogilvie spoke to his update. The Board discussed the Motueka stopbank and recorded river levels during last week's weather event.

#### **Engineering Services Activity Report**

The Board acknowledged the report and discussed water treatment, current boil water notices and a proposed boardwalk for Kaiteriteri to be considered as a special project.

#### Senior Sergeant Martin Tunley

Chair Maru welcomed Senior Sergeant Martin Tunley to the meeting. The Board had a discussion with Mr Tunley regarding staffing, driver safety and family harm. Mr Tunley agreed to have a follow up with Cr Walker regarding youth aid in the local area.

Chair Maru thanked Mr Tunley.
