PROPOSED PLAN CHANGE No. 64 WITHOUT LEGAL EFFECT Update of Protected Tree Schedule

Explanatory Statement

Proposed Plan Change 64 amends the Council's Protected Tree Schedule 16.13B by removing 10 protected trees from the Schedule. Some of the trees have been damaged in storms while others have poor health or form. The trees no longer meet the assessment criteria required to be on the Protected Tree Schedule.

The Council has considered the proposed amendments in its policy report REP16-03-16. It has had regard to the issues and options and is satisfied that the Proposed Plan Change is the most appropriate means of addressing the issues, under section 32 of the Resource Management Act.
