# CALL FOR ALTERNATIVE APPLICATIONS IN RESPONSE TO APPLICATION FOR GOLDEN BAY LOCAL BOARD

Please find attached a copy of the public notice calling for alternative applications in response to an application from the Working Group for a Golden Bay Local Board.

The application is for the establishment of a local board covering the area of the present Golden Bay Ward of Tasman District. If approved, the local board would replace the existing Golden Bay Community Board.

You can find a copy of the application and further information on the Commission's website at www.lgc.govt.nz.

As required, the Commission is now inviting interested persons, groups and organisations to submit any alternative applications they wish to put forward for the affected area. This is a step in the reorganisation process designed to put a range of options on the table before the Commission advances its consideration of the application. The requirements for the contents of alternative applications are set out in clauses 5 and 10 of Schedule 3 of the Local Government Act 2002.

In the case of the Golden Bay application, the affected area is Tasman District. Clause 10(3) precludes an alternative application proposing the abolition of Tasman District or its union with another district, changes to the boundaries of Tasman District or to the functions of Tasman District Council.

Alternative applications must be received by the Commission by **10 June 2019**. They can be sent to the Commission at the addresses set out in the public notice. The Commission may decline to consider applications received after that date.

# Invitation for alternative applications following application for establishment of a Golden Bay local board

The Local Government Commission has received a local government reorganisation application from the 'Working Group for a Golden Bay local board' for the establishment of a local board covering the area of the present Golden Bay Ward of Tasman District.

If approved, the local board would replace the existing Golden Bay Community Board.

The Commission has determined that the application meets the requirements for an application under Schedule 3 of the Local Government Act 2002. As a result, the Commission has agreed to assess the application and is now publicly notifying it and inviting alternative applications as it is required to do.

An alternative application may be made by any person, body or group, suggesting alternative arrangements for local government for the affected area. In this case, the affected area is Tasman District although alternative applications may relate to just part of the district such as Golden Bay or any other part of Tasman District.

An alternative application may not propose the abolition of Tasman District or its union with another district, or propose any changes to the boundaries of Tasman District or the functions of Tasman District Council.

A description of the required contents of an alternative application is set out in clause 10 of Schedule 3 of the Local Government Act. A link to the legislation is available on the Commission's website – see below. Alternatively, the relevant legislation can be accessed via the New Zealand Government website <a href="www.legislation.govt.nz/browse.aspx">www.legislation.govt.nz/browse.aspx</a>. It is likely that access to online legislation may also be obtained through assistance from staff of local public libraries.

The deadline for the Commission to receive alternative applications is Monday, 10 June 2019. Alternative applications received after that date may be declined.

All alternative applications received will be considered by the Commission along with the original application made by the 'Working Group for a Golden Bay local board'. The Commission will then identify the reasonably practicable options for the affected area, which will include existing local government arrangements, before identifying its preferred option.

### Pah Street Pedestrian Crossing

In July 2016, our BOT Chairperson and I met with the Tasman District Council's Transportation Technical Officer to discuss concerns re the Pah Street Crossing, with no outcomes or changes made. The crossing is situated in front of the school, the Motueka Library and the Countdown car park; an extremely complex environment with very high traffic flow.

There are also issues of small children not easily being seen, or easily able to see cars, due to the various street furniture items (e.g. bins), parked cars and trees obscuring the view from a child's perspective. In the last two years we have received numerous complaints from members of the public raising concerns about speeding cars, parked vehicles and the visibility of the crossing.

Although we have teachers monitoring this pedestrian crossing before and after school, we have had very close near misses in recent years. I strongly believe that the needs of our primary school students must be taken into account for their safety. Ideally we would like a speed limit sign and lights at the pedestrian crossing, the same as what they have at Motueka South School and Motueka High School.

This crossing needs to be visible and safe for all our students and we really appreciate your support in this matter.

We would like to bring to your attention the following safety concerns in our locality. The Inland Moutere Highway is a stretch of road between Nelson and Motueka. The section between the Upper and Lower Moutere villages is a road that is becoming increasingly hazardous to drive along.

We have witnessed in recent years several accidents and many incidents of an alarming nature. Two separate identical and serious accidents occurred at the top of our drive when vehicles lost control, left the highway and ended in the roadside drainage ditch. The first of these uprooted a tree and telegraph pole. The second collided with the concrete parapet of the drainage culvert summersaulted finishing upside down facing the direction it had come from. Both incidents could have easily resulted in fatalities. A third incident, equally alarming was when a vehicle collided with trees at the road side. In addition two domestic cats and a dog have been killed on the very same spot. The hazards in this particular vicinity are compounded by irregular road surfaces, blind summits immediately followed by bends and lack of forward vision due to roadside vegetation. However drivers appear to treat this with some complacency and travel at speeds that are unsuitable for this stretch of road. Overtaking also occurs despite solid yellow lines.

In recent months we have on several occasions contacted the police and council expressing our concerns. In particular we have outlined the behaviour we have witness of excessive speeding. The main perpetrators are often motorcycle riders that sometimes are racing. The incidents tend to occur at the beginning and end of the working day. However, other incidents as above can be at almost any time of day and not associated with any particular age group or gender.

Almost all of our concerns are regarding drivers associated with excess speed but we regularly encounter vehicles crossing the centre line on bends, using cell phones or driving in manner paying a lack of attention to other road users

The distance from Lower Moutere School to Gardner Valley Road is approx. 8km. Within that distance there are 64 access points either drive ways or intersection of other roads. For safety of all it should be considered on this fact alone that the road be designated an 80km/h zone. The three main feeder roads that link the Moutere Highway to State Highway six are all 80km/h or less, having recently been reassessed for safety reasons.

When there were 50 people killed at the Christchurch massacre it was seen as a National disaster and laws were quickly amended. But when 26 people were killed in one week on the roads it was just called "a bad week on the roads". Surely this is a sad reflection on the attitude there is in this country to bad driving. It is time New Zealand adopted **Vision Zero**- or at least our District could make it a serious campaign to reduce injuries and eliminate fatalities.

### Good morning

This email is to update you with progress on a speed reductions within the Tasman region.

You have expressed concerns with the safety of current speed of a specific road(s) which has been included in a 'business as usual' review of our speed limits.

It was intended that we would be publically consulting on this in April. However when we looked at all the sites that were shortlisted for formal review, it was apparent there is a need to consider speed limits more widely across the district to ensure the next formal speed limit review can make a more significant impact on improving road safety, and implements "safe and appropriate" speeds across our district. Just changing a handful of roads is not necessarily logical.

We are proposing to work with our road safety partners (Police, NCC, NZTA) to carry out a joint public survey to test the appetite for these wide ranging speed limit changes with the community. This is planned to begin in early May.

I will email you the survey to complete once it is up and running. Please pass this onto as many people in your community as you can as we want to get back a really good amount of feedback.

This information will then be fed into the formal speed limit review which will follow.

I understand that it is frustrating waiting so long to get a speed limit changed—but it is part of a very lengthy legislative process set at national level that we must follow, and when we do it we want to get the most benefit out of it in terms of improving safety.
