#### Council's New Footpath Priority List – Request for Feedback

The Council maintains a list of proposed new footpaths that has been prepared over time based on requests from the community and identified needs. However the extent of the list far exceeds the Council's present ability to fund all of these projects, so we must undertake a prioritisation process to ensure the available funding provides the greatest benefits.

The Council has a prioritisation process which considers:

- The estimated number of pedestrian numbers (considering adjacent land use and proximity to CBD/shopping area, schools, urban areas)
- Road traffic volumes
- Speed limit of road
- Footpath deficiency type (eg is it a short missing link, is there already a path on the other side of the road?)
- Road geometry
- Source of request (was it an individual, or from a large group?)

This process produces a draft priority list, which is attached to this letter. However, to check that the prioritisation process has produced a result that reflects the community's needs, we are looking for feedback on the draft priority list from groups such as Community Boards, Community Councils, and Residents Associations. This feedback will then be considered to produce a confirmed list of projects, with the highest priority sites to be constructed in 2019/20.

Could the Motueka Community Board please review the attached draft priority list, and provide any feedback as you see fit. This could include comments on the relative priorities of proposed paths

# 1 Summary

- 1.1 Council has prepared its Proposed Annual Plan for 2019/2020.
- 1.2 We are aiming to maintain and improve our infrastructure, respond to continued population growth and manage natural resources. At the same time we remain focused on keeping rates affordable and Council's debt well managed.
- 1.3 As much as possible Council is keeping to its intentions for 2019/2020 as set out in the LTP 2018-2028.
- 1.4 The Proposed Annual Plan signals an increase in total rates revenue of 2.74% (after allowing for growth). This 0.32% higher than indicated for 2019/2020 in the LTP 2018-2028.
- 1.5 We expect debt to reach \$191.4 million by 30 June 2020. This compares with the LTP 2018-2028 forecast of \$194.4 million.
- 1.6 Both the rates revenue increase and the forecast debt level are below the caps in our Financial Strategy.
- 1.7 There are a few changes to the timing of capital projects planned for 2019/2020 for technical and operational reasons. None of these are located in Motueka.
- 1.8 As the changes from the LTP signalled in the Annual Plan for the 2019/2020 year are not significant or material, consultation will not be carried out on the Proposed Annual Plan. Instead Council is communicating the Annual Plan 2019/2020 through meetings with Community Boards and Associations, as well as through Newsline and on Council's website.
- 1.9 A copy of the information published in Newsline on 8 March 2019 is included as Attachment1.
- 1.10 Some of the projects planned for the Motueka ward in 2019/2020 are as follows:
  - Design of the Motueka library.
  - Motueka wastewater treatment plant upgrade (continuing to 2021).
  - Continuation of the development of the new water treatment plant at Parker Street and pipes.

- Continuation of the upgrade of the water treatment plant at the Recreation Centre.
- Thorp Street water main replacement (continuing to 2021).
- Motueka West water main development (continuing to 2021).
- Continuation of the Motueka and Riwaka flood mitigation planning.
- Development of the Motueka Stormwater Catchment Management Plan.
- Air quality monitoring in Motueka.
- 1.11 Attachment 2 provides more details of a range of District-wide programmes and projects on a ward by ward basis. The projects planned for the Motueka Ward are included in this document, which is available on Council's website.

# PROPOSED ANNUAL PLAN



# 2019/2020

The drought and Civil Defence response to the Pigeon Valley fire have been front and centre of the Council's work over the past month. Many Council staff put aside their usual work to take on leadership, welfare, logistics, planning, operations and public information roles within the Civil Defence Emergency Operations Centre.

Before the fire started on 5 February, we had been in the process of finalising the proposed work programme for the coming year. The key aspects of the Annual Plan for 2019/2020 are outlined below. Planning and preparing for natural hazards and civil defence emergencies will be an important focus for us both this year and in future years.

# BALANCING PROGRESS AND AFFORDABILITY

We have been busy planning for the 2019/2020 year to maintain and improve our infrastructure, respond to continued population growth and manage our natural resources.

Major projects we will be progressing include the construction of the Waimea Community Dam, developing the Takaka to Pohara cycle link, upgrading the Brightwater town centre, undertaking flood mitigation planning in Motueka and Riwaka, designing the new Motueka Library, and carrying out flood mitigation works at Neds Creek in Murchison. We will also continue to protect Tasman's precious environment. We intend to complete a biodiversity and biosecurity strategy, to carry out a survey of fish in the Waimea Estuary and assess the effectiveness of the Tasman Resource Management Plan.

The planned increase in rates revenue will be 2.74% (after allowing for growth) with anticipated debt of \$191.4 million by the end of June 2020.

Tasman Mayor, Richard Kempthorne said 'The ongoing impact of the fires and the drought will need to be considered during 2019/2020. In the meantime, we are keeping to our intentions for the year as set out in the Long Term Plan as much as possible. We will continue to keep rates at affordable levels and focus on managing our debt at acceptable levels. At the same time we plan to maintain and improve infrastructure and be responsible guardians of our environment'.



### Overall, we are planning our capital expenditure for 2019/2020 to be \$3.9 million lower than we forecast in the Long Term Plan 2018–2028.

The main driver of this variance is the delay of the Wakefield water treatment plant. Further testing of the raw water from its source is needed to ensure that we design the best treatment system. Construction has been rescheduled to 2020/2021.

For a range of technical and operational reasons we have also altered the timing of the following projects:

- Nelson Regional Sewerage Business Unit (NRSBU). Improvement works have been delayed to 2020/2021 pending resource consent decisions.
- Mapua water trunk main design (Moturoa/Rabbit Island). Design brought forward to commence in 2018/2019 and conclude in 2019/2020, prior to construction in 2020/2021.
- Water pipe renewals in Martin Avenue, Whitby Road and Whitby Way, Wakefield. We have advanced these projects to 2019/2020 so we can carry them out with other pipe renewal work in Arrow Street.

# WHERE THE MONEY COMES FROM


The majority of our income (58%) each year comes from rates. In 2019/2020, we anticipate the other 42% will come from other income streams such as fees and charges, government grants and subsidies.

The rates increase does not apply evenly across all ratepayers due to the mix of general and targeted rates that apply to each property. For some ratepayers the rates increase in 2019/2020 will be lower than 2.74% and for others it will be higher. To check your rates for 2019/2020 go to our rating tool, www.tasman.govt.nz/my-property/rates/search.

The total rates revenue increase for 2019/2020 in this Annual Plan is 0.32% higher than set out in our LTP 2018–2028. The main drivers for this increase are:

- Replenishing the Rivers activity emergency fund that was depleted through activities recovering from ex-cyclones Fehi and Gita.
- Reviewing the Tasman Resource Management Plan (TRMP) and Tasman Regional Policy Statement.
   This is required to ensure these plans guide the management of Tasman's natural and physical resources.
- Improving our ability to deliver our functions and meet community expectations now and in the future.
- Higher insurance premiums.

# FOR 84% OF RATEPAYERS RATES WILL RISE BY LESS THAN \$100





#### DISTRICT-WIDE ACTIVITIES AND SERVICES

In addition to the business as usual activity carried out by the Council, there are a number of projects that will be delivered over the 10 years of the Long Term Plan 2018–2028, including the 2019/2020 year.

#### A) CIVIL DEFENCE AND EMERGENCY MANAGEMENT

- Council funds 50% of the cost of running the Civil Defence and Emergency Management function.
- In order to respond to any emergency/disaster events in the Tasman District, Council is providing funding to a General Disaster Fund. In addition, we are building up reserves for disaster recovery for specific types of infrastructure, e.g. roading, water etc.

#### 

The Environmental Management work programme over the next 10 years includes reviews and changes to our resource management documents, including the Tasman Regional Policy Statement and the Tasman Resource Management Plan. This will include:

- Complete second generation reviews of
  - the pattern of urban settlement across the District. This includes ensuring we have enough serviced land available to meet our housing and business needs over the next 30 years. The joint Nelson Tasman Future Development Strategy 2019 will set the high level direction for where and how we manage growth for the Nelson/Richmond urban area and for all other settlements in Tasman. The Strategy will be implemented through changes (including possible re-zoning of land) to our resource management policies and plans.
  - » how we plan for and adapt to natural hazards across the District, including drought, fire, coastal, floodplain and slope failure hazards.
  - » outstanding natural landscapes and features, land disturbance, terrestrial biodiversity and riparian land management.
- Complete the development of freshwater and catchment management planning in order to implement the National Policy Statement (NPS) for Freshwater Management. This includes Waimea Plains water quality management, Takaka water management, water quality management policy, and urban stormwater management across the District.

- Review the current coastal planning provisions to identify how effective they are. This includes a review of our moorings and aquaculture management.
- Consolidate the review and combination of the Tasman Regional Policy Statement and the Tasman Resource Management Plan.
- Implement the new Regional Pest Management Plan.
- Further work on a regional biodiversity and biosecurity strategy. This strategy will provide clear direction to decision making, investment and programmes to enhance biosecurity and carry out biodiversity functions.

#### C) TRANSPORTATION, ROADS AND FOOTPATHS

- Minor improvements annual budget to improve overall road safety including intersection realignments, removal of roadside hazards and the provision of pedestrian crossing facilities.
- New footpaths annual budget to allow for construction of new footpaths across the District to join gaps and extend the existing footpath network.
- Footpaths rehabilitation annual budget to improve the condition of existing footpaths that are in poor condition.
- Sealed road resurfacing annual budget to renew sealed road surfacing to maintain waterproofing and skid resistance.
- Tasman's Great Taste Trail Construction progressive extension of cycleway subject to agreements with landowners and funding contribution by Central Government.

# D) WATER SUPPLY

- Waimea Community Dam the three year project is underway and will be carried out in stages with the first six months dedicated to accessing the Lee Valley site. Works are expected to take about 18 months and then a further six months will be needed to fill and test the reservoir.
- Ongoing upgrades and renewals to pumps, pipelines, values, telemetry, water meters and restrictors throughout the District.
- Significant programme of upgrading water treatment plants to meet Drinking Water Standards NZ.

#### E) WASTEWATER AND SEWAGE DISPOSAL $\overline{\mathbb{C}}_{\mathbb{C}}$

• Pump station upgrades and renewals throughout the District.

#### F) STORMWATER

- Catchment Management Plans for each Urban
  Drainage Area.
- Ongoing minor stormwater improvements.
- Progressive identification and protection of secondary flow paths.

#### G) SOLID WASTE 📮

- Renewals and small improvements to resource recovery centres.
- Maintainance of our closed landfills.


#### H) COMMUNITY DEVELOPMENT

- Work to improve our relationship and engagement with Te Tah Ihu iwi.
- Develop a Community Facilities Strategy.
- Prepare a Concessions Policy for commercial use of Council parks, reserves and community facilities.
- Review Council provision of community swimming pools, to determine the long term future needs and direction for these facilities across the District.
- Review Council provision of community housing to determine the long term future needs and direction.
- Develop a Public Toilet Policy that will cover the quantity and quality to be provided, design and construction standards, future toilet development needs and a renewal plan for replacement of toilets.



- Long Term Planning and growth strategy development.
- Moutere-Waimea Ward Reserve Management Plan commencing in 2019/2020.
- Tasman District Council triennial election October 2019.
- Freedom Camping Strategy to provide direction to Council's work to manage this activity in the District.

.1 This report requests decisions from the Motueka Community Board with regard to:

- Removal of three redwood trees from a group of four on the Motueka Golf Course.
- Removal of one totara and one conifer from Memorial Park adjacent to the bowling club.
- Removal of one paulownia from Memorial Park close to Pah St and adjacent to the Senior Net building.

#### Draft Resolution

That the Motueka Community Board receives the report RMCB19-04-4; and approves the removal of three redwood trees from the Motueka Golf Course, one totara and a conifer from Memorial Park, and a paulownia from Memorial Park.

#### • Purpose of the Report

.1 This report provides an overview of issues created by a number of trees and seeks to gain approval to remove trees on the Motueka Golf Course and at Memorial Park.

#### • Background and Discussion

- .1 Reserves and Facilities strive to find the balance of being a good neighbour while taking into consideration the community use and appreciation of parks and reserves.
- .2 We have had requests from various parties requesting removal of some trees.
- .3 The Motueka Golf Club has been approached by a neighbour at 10 Karo Place, and are requesting removal of three redwood trees from a group of four trees on the southern boundary of the golf course. The property owner is intending to build a house in the near future. The trees are directly to the north of the new building and will create a major shading issue as well as a risk to the property from broken branches. The trees are currently approximately half the height they could eventually reach. The Golf Club has stated that it 'has no problem with this request and would arrange for the trees to be felled at the section owners cost and dispose of the timber. The trees as positioned probably would detract significantly to quality of living. While the neighbour would prefer all trees to be removed, the consulting arborist (Brad Cadwallader) has suggested that a solution could be to retain one of the four trees. It is possible that the intention to build could change and therefore no work should commence until it is clear that construction is about to begin. Staff recommend that the suggestion of removing three trees and retaining one tree is followed, but that no work be undertaken until it is clear that construction is about to commence.
- .4 At Memorial Park, the Motueka Bowling Club have requested removal of two trees from the walkway behind their greens, (Attachment 1). The trees are directly to the north of the bowling club and create shading issues, particularly in winter. This can cause ice to form resulting in H&S concerns for the club. The club has requested that both trees are removed, however Mr Cadwallader suggests that only the totara is removed and the conifer is retained. From a staff perspective the conifer does not add value to the site and could be removed as well. If retained, this tree will need to be managed to keep the height in check. Staff recommend that both trees are removed.
- .5 In response to an ongoing complaint by Senior Net about leaf drop, shading and a risk of toppling, a paulownia tree adjoining the Senior Net building on the Pah St side of Memorial Park has been assessed by our arborist. It is recommended that the tree is removed in accordance with Mr Cadwallader's report.
- .6 Reports from the arborist are attached : Motueka Golf Course (Attachment 2) and Memorial Park Bowling Club and Senior Net (Attachment 3)

### Options

- .1 Option1 Tree removal as recommended above. The advantage of this option is that it eliminates issues for the neighbours and there will be one off costs associated with this. The disadvantage is that we lose semi-mature trees from the landscape.
- .2 Option 2 Trees could be managed by way of height reduction and side trimming to reduce the effects of shading and leaf drop, and lessen the possibility of toppling and damage to property. The advantage of this option is that we retain trees in the landscape. The disadvantage is that the trees will require regular and ongoing maintenance along with the associated costs. It can be difficult to retain good tree form when topping and side trimming is constantly applied.
- .3 Option 3 No action taken. This is not a recommended option. The advantage of this option is that there are no immediate costs to Council and trees are retained in the environment. Disadvantages are that it does not resolve the issues raised by the neighbours and will result in ongoing complaints about the effects that unmanaged trees are having. The paulownia tree is likely to impact on infrastructure in the not too distant future which could prove very costly.

### • Strategy and Risks

- .1 Removal of the trees as recommended will relieve an issue with the neighbours and reduce the risk of damage to property from shading, blocked guttering, broken branches and risk of toppling.
- .2 There is a risk with the Golf Course trees that the situation may change including that the property is sold. Therefore no tree removal should occur until it is clear that construction is about to commence.
- .3 There is an increased risk to one of the Golf Course neighbours from stray golf balls, however, there are other trees screening the boundary of this property which would lessen the risk.
- .4 Members of the public may have an affinity for a particular tree and could be unhappy that the tree is removed. This can be off-set to some extent in that both Council and the Golf Club are continually planting new trees, meaning there is a net gain of trees in Motueka.

## • Policy / Legal Requirements / Plan

- .1 The Reserves General Policies document states there is an expectation that Reserves are managed for public benefit while taking into account the interests of adjoining landowners.
- .2 It also states that Council has a responsibility as an adjoining landowner to ensure that the uses and activities that occur on reserves are reasonable in terms of their effects of surrounding properties. However, where a reserve and uses or activities on a reserve, existed prior to the transfer of ownership of an adjoining property any concerns raised by these landowners shall be weighed accordingly.
- .3 Where requested, Council shall take measures to prevent or remedy vegetation encroaching from reserves onto private land.

#### Consideration of Financial or Budgetary Implications

- .1 At the Golf Course, the neighbour has offered to pay for trees to be felled. Trees will be removed by a Council approved, arborist. Once on the ground the Golf Club would arrange for the clean-up and removal.
- .2 Costs for tree removal or maintenance at Memorial Park will come from the Parks and Reserves general maintenance budget. Tree removal would be a one off cost, while if the trees are retained, maintenance will be ongoing.

Removal of Trees on North side of Bowling Club

This letter is in support of our request to the TDC to have two Totara trees removed or reduced in height.

Our bowling club has two greens, a cotula green and a TigerTurf artificial green. The artificial green is the one we use during our winter season which runs from beginning of May to end of August each year. During the winter season we hold at least two tournaments per month and they are well supported meaning that we need to use all 8 rinks. The 8<sup>th</sup> rink is adjacent to the North boundary of the bowling green. Running parallel with this boundary is an access way to Memorial Park. There are two Totara trees, one mid-size and the other smaller, which appear to be self-sown as they are planted up against the boundary fences of the adjoining residential properties. It is these trees that we wish to have removed or topped to reduce their height. Our reasons for this request are as follows;

The trees shade the end (8<sup>th</sup>) rink and part of the 7<sup>th</sup> rink which greatly reduces the drying and thawing out of the green and bank. On a frosty morning there is still frost on the bank and green up until late morning. As our tournaments start at 10:00 am the bowlers allocated to these rinks find the surfaces slippery and run the risk of injury. I must point out that all bowlers are required to wear flat soled shoes with little grip so as not to damage the green surfaces. On a morning of heavy frost the damp sand under the TigerTurf surface freezes causing the surface to lift 5 to 10 mm in places. When this happens play cannot take place as the tracking of the bowl is affected. The surface lifting has caused some damage to the green in that some of the joints have come apart. We try to remedy this by re-gluing the joints, when dry, but there always remains a gap at the place where the joint / seam has come apart. The club has a big investment in the artificial green and cannot afford to have the life of the green reduced because of damage caused by frost. Removing the Totara tree will allow the sun to reach into the areas that are frosted and quickly defrost the green before the start of play. Allowing the sun into these areas will also reduce the ground dampness thus reducing or eliminating the possibility of frozen water lifting the green.

We have permission from the landowner (Malcolm Rau) adjacent to the access way to thin out foliage of trees on their properties. Some of which overhangs the fence bordering the access way.

In conclusion, although we are asking for the removal of trees we like the ambiance that trees bring.

Dear Lynne,

Thank you for your request to look at the redwood trees located at Motueka Golf Club. A resident of 10 Karo Place is concerned about the trees their property and has requested that they be removed. I carried out a site visit with you on the 7<sup>th</sup> March 2019.

There are 4 redwood trees (*Sequoia sempervirens*) situated along the northern boundary adjacent to a vacant lot at 10 Karo Place (see aerial image). The trees are planted in a line within the Motueka Golf Course with the main stems extending to near the boundary line (see image 1-3). There are stumps located between each existing tree suggesting the row of trees was previously thinned. The close planting of the row suggests the initial intention of the planting was for screening purposes. Management of the trees over the years appears to be limited to removal of their tops.

The trees are healthy and robust in stature from my observation of them. I did not detect any faults or defects that would indicate the likelihood of failure.

Notwithstanding the good health of the trees, it is clear that the number of trees growing in close proximity to each other near the boundary may prove to be troublesome to an occupant of a dwelling if it were to be built at this location. Therefore some discussion around the rationalisation of the number of trees may be in order.

Decisions around the tenure of the trees should also consider the role the trees play in screening adjacent properties from stray golf balls, especially those off the 9<sup>th</sup> tee (see Aerial image 2).

In conclusion, I consider that the trees are healthy and without defect and so in this respect I feel that there can be no justification for the removal of all the trees. Decisions around removal of any of the trees is simply one of balancing the reasonable use and enjoyment of the immediately property by the owners, considering what negative effects the removal of trees may have on other properties whilst also acknowledging the amenity benefits the trees provide to the course generally.

One possible solution to be considered is to retain a single tree adjacent to 10 Karo Place much like that which exists in front of 19 Titoki Place (see image 4).

Dear Lynne,

Thank you for your request to look at three trees located at Memorial Park, two at the Bowling Club and one near the SeniorNet building. I visited the site to view the trees on 12 Feb 2019.

#### **Bowling Club**

Two trees (an ornamental conifer and a totara) located on the rear boundary behind the artificial green are of concern to the club (see Aerial view 1 and photo 1). The trees cast shade on the green during the winter months and frost is affecting the play surface.

Both trees appear to be approximately 30 years old and are situated beside the rear boundary fence. The ornamental conifer is clearly a planted tree but the totara could be self-set given it is very close to the fence.

In the winter months both trees are likely to shade the northern end of the green toward the end of the day but I suspect the totara is more problematic as it is a much larger tree. The ornamental conifer is much smaller in profile and the neighbours palm and other vegetation would appear to be the greatest contributor to shade during winter at the end of the day.

Early morning light onto the green has greatly increased due to the removal and trimming of trees at the eastern side of the greens this past season.

The shading issue is somewhat complicated by trees located on adjoining property and not solely caused by these two trees in my view. Despite this I suggest the totara could be

removed as it will develop into a substantial tree and its proximity to the fence presents a problem in itself. I do not feel that the shade caused by the ornamental confer is sufficient to warrant its removal.

#### SeniorNet

A large *Paulownia tomentosa* is situated immediately in front of the SeniorNet building (see Aerial image 2). The tree's proximity to the building has been causing maintenance problems for the occupants.

The tree appears to have been planted in the 1980's within a former narrow planting strip with a cement edge. The root system has been constricted in its development by the cement border (see photo 2). At the time of planting it was clearly not anticipated to grow so large. Mature Paulownia can achieve 2 or 3 times the trees current size. The tree is in very good health and still growing rapidly as this species is well known for. There is a Mediterranean cypress immediately beside the tree.

My immediate impression of the tree is that it has clearly been planted in the wrong location. In addition to current maintenance issues, future damage to the adjacent hard surface, drainage and building foundations should be expected as the tree matures. It is on this basis that I recommend its removal and that a replacement tree is planted in the generous grass area toward the street. In my view the impact of the removal will be mitigated due to the large cypress that will be exposed with the tree gone.




Aerial Image 1: showing location of subject trees to the north of bowling green

It will seek to define the goals and objectives for freedom camping in the District, Council's role, and the best use of both regulatory and non-regulatory tools to achieve the objectives.

With the rise in freedom camping and the associated issues that come with it across NZ, Central Government is displaying greater willingness to work with local government to address the various issues we are experiencing. This has primarily been through funding via the Tourism Infrastructure Fund and the Responsible Camping Fund.

The Strategy will provide a framework for assessing freedom camping sites and any subsequent Bylaw changes that may be required. It will also identify opportunities to secure and utilise Central Government support.

The data shows:

- Average speed 47.9km/h
- 85<sup>th</sup>%tile speed 54.63km/h
- 39% of drivers are above 50km/h
- Less than 1% above 60km/h.
- Up to 40 vehicles per hour above 60km/h (between 4-5pm).

The data matches what Pam describes.

There are 40 vehicles per hour above 60km/h (one every 1.5min) with 3-4 going 80-90km/h per day. The data suggests at least one per hour going close to 80km/h, and some almost as much as 100km/h.

Subject: Grey Street, Motueka - speeding concerns

Good afternoon Megan, Toni, Damien and members of the Motueka Community Board. It was really good to see the speeding & stopping demo for all schools in the locality on Monday 11<sup>th</sup> March and I hope some of the more senior pupils at Motueka High School took the message on board. Megan, thank you for speaking with me at the time about the excessive speeds of some drivers using Grey Street as a regular thoroughfare on a daily basis.

Since living in Grey Street, I have observed on an hourly basis the speeds some drivers reach – sometimes as high as 80-90kms – and in reality, regular drivers on the whole also tend to exceed the speed limit (I would estimate up to 65% do). But there is a smaller more concentrated group of drivers (mostly young male) who deliberately accelerate at great speed in a short distance, deliberately emitting very loud valve-bouncing noise before roaring off at the Grey / Whakarewa Street intersection. They seldom hesitate at the intersection before accelerating into Whakarewa Street – or into Grey Street when exiting Whakarewa. These drivers use Grey Street often up to 3-4 times per day and each time they engage in the same behaviour speeding up or down Grey Street. It is concerning, disruptive and dangerous and I simply can't understand how they keep getting away with it.

What I and neighbours are hoping for is some immediate action to alleviate this behaviour and then some emerging solutions that will get the message across that Grey Street is not a racing street, it's just another ordinary street like any other in Motueka and that the same speed limits apply. A change of behaviour and attitude is urgently needed to address this issue, now and for the long-term.

I have also raised these concerns with Toni Bull at Motueka Police who invited me to copy her into these concerns. Thank you all for taking the time to read this email.
