2 REPORTS

2.1 MENACING DOG CLASSIFICATION

Decision Required

1 Summary

- 1.1 An objection to a "Menacing" classification of a dog has been lodged under Section 33B of the Dog Control Act 1996 (the Act) by Ms Joanne Dippie and she has requested to be heard.
- 1.2 Nelson is an 18 month old male Hungarian Vizsla currently registered to Ms Joanne Dippie of 277 Rutherford Street Nelson. Ms Dippie also owns property at Pakawau.
- 1.3 Nelson was classified as menacing after a dog attacks person incident on 27 October 2020.
- 1.4 The dog Nelson is registered to Nelson City Council, however as the attack occurred in the Tasman District, Tasman District Council has jurisdiction.
- 1.5 Actions available to the Council under The Act range from prosecution and destruction of the dog; classification as dangerous; imposition of financial penalties and classification as menacing. The scale of the injury and the associated factors led to a decision to classify the dog as menacing. This decision is now under challenge.
- 1.6 The Hearing Panel may uphold or rescind the classification.

2 Draft Resolution

That the Animal Control Subcommittee:

- 1. Receives the Menacing Dog Classification Hearing; and either:
- 2. Upholds the menacing classification for the dog Nelson owned by Joanne Dippie or:
- 3. Rescinds the menacing classification for the dog Nelson owned by Joanne Dippie

3 Purpose of the Report

3.1 To explain the process and reasoning behind the imposition of the 'menacing' classification on the dog Nelson and to allow the panel to decide on whether this is the appropriate classification in the circumstances.

4 Background and Discussion

4.1 The Council has classified Nelson as a menacing dog, in order to do this the Council must consider the requirements of Section 33 of the Act:

33A Territorial authority may classify dog as menacing

- (1) This Section applies to a dog that:
 - (a) has not been classified as a dangerous dog under Section 31; but
 - (b) a territorial authority considers may pose a threat to any person, stock, poultry, domestic animal, or protected wildlife because of:
 - (i) any observed or reported behaviour of the dog.

It is staff opinion that the reported behaviour (which is uncontested) warrants the imposition of the classification which will protect the public from Nelson.

- 4.2 On the morning of 27 October 2020 Ms Dippie was exercising Nelson of lead on Pakawau Beach at the same time Mr Brian White was also walking on Pakawau Beach. Nelson has rushed Mr White, jumped up on him and bitten/nipped him on the lower jaw. Nelson attempted to jump up on Mr White a second time and was discouraged by "a smack to the face".
- 4.3 Mr White did not suffer any serious injury, he was however shaken by the experience and concerned that Ms Dippie showed little appreciation for the distress her dog had caused stating Nelson "was only playing".
- 4.4 Section 5(f) of the Act requires owners of dogs to take all reasonable steps to ensure the dog does not injure, endanger, intimidate, or otherwise cause distress to any person.
- 4.5 Section 52 of the Act requires a dog to be under control at all times. Under control means that the dog is on a leash and restrained by a person capable of doing so or that the dog responds immediately to voice, hand or other commands. Although Ms Dippie was present she was unable to exercise such control over Nelson as to prevent the attack.
- 4.6 On 18 March 2020 Nelson was involved in a dog attack dog incident at Pakawau Beach. It is alleged that Nelson rushed up to another dog and a dog fight ensued. Statements from both owners are conflicting and no further action was taken.
- 4.7 When considering the Council's response to the incident, staff decided that the incident did not warrant any punitive action. Staff did however consider that Nelson posed a threat to the general public and should be muzzled when in a public area. A Menacing Classification under Section 33 of The Act is the means by which Council can require dog owners to muzzle their dogs.

5 Options

5.1 In considering the objection the Sub-committee may either uphold or rescind the classification. The Act indicates that the following must be considered:

33B Objection to classification of dog under Section 33A

- (1) If a dog is classified under Section 33A as a menacing dog, the owner:
 - (a) may, within 14 days of receiving notice of the classification, object in writing to the territorial authority in regard to the classification; and
 - (b) has the right to be heard in support of the objection.
- (2) The territorial authority considering an objection under Subsection (1) may uphold or rescind the classification, and in making its determination must have regard to:
 - (a) the evidence which formed the basis for the classification; and
 - (b) any steps taken by the owner to prevent any threat to the safety of persons or animals; and
 - (c) the matters relied on in support of the objection; and
 - (d) any other relevant matters.

6 Key Points

- 6.1 An attack did take place
- 6.2 The attack was unprovoked
- 6.3 The injury was relatively minor
- 6.4 The classification relates to the behavior of the dog and the ongoing threat.

7 Decision on What Action To Take

- 7.1 Dogs attacking persons are considered to have committed a serious offence under the Act. The punitive options available to the Council in this instance are:
 - 7.1.1 **Prosecution under Section 57** (Dogs attacking persons) which carries a maximum fine of \$3,000 plus reparation to the victim. The dog involved must also be destroyed unless there are extenuating circumstances.
 - 7.1.2 Classification as "Dangerous" under Section 31. This puts requirements on the owner to ensure that there is a safe access way to their property, muzzling of the dog in public, neutering of the dog, increased registration fees and consent from the Council to transfer ownership to another person.
 - 7.1.3 **An Infringement Notice** for \$200 for failure to keep a dog under effective control.
 - 7.1.4 Classification of the dog as "Menacing".
- 7.2 Given the facts, a decision was made by on 5 November 2020 to classify Nelson as "Menacing" under Section 33A(b)(i) of the Act:

33A Territorial authority may classify dog as menacing

(1) This Section applies to a dog that:

- (a) has not been classified as a dangerous dog under Section 31; but
- (b) a territorial authority considers may pose a threat to any person, stock, poultry, domestic animal, or protected wildlife because of:
 - (i) any observed or reported behaviour of the dog; or
 - (ii) any characteristics typically associated with the dog's breed or type.
- (2) A territorial authority may, for the purposes of Section 33E(1)(a), classify a dog to which this Section applies as a menacing dog.
- 7.3 A copy of the Menacing classification notice and other supporting information is attached to this report.
- 7.4 The primary effects of the classification are that Nelson must be muzzled when in public.

8 Process

- 8.1 The objector Joanne Dippie has the opportunity to make a statement to the Animal Control Subcommittee Hearing Panel.
- 8.2 The Regulatory Administrator will explain Council's position.
- 8.3 Joanne Dippie has the right of reply.
- 8.4 At any time, the Hearing Panel may ask questions of those present.
- 8.5 The Hearing Panel will go into Committee and make its decision.
- 8.6 The objector is informed of the Hearing Panel's decision.

9 Legal Requirements

- 9.1 Dogs attacking persons are considered to have committed a serious offence under the Act. The punitive options available to the Council in this instance are shown in Section 7 above.
- 9.2 Failure to take any action in such circumstances would be extremely unusual and would need to be justified by some form of extenuating circumstance, none was found.
- 9.3 After the panel makes it decision it must, as soon as practicable, give written notice to the owner of:
 - (a) its determination of the objection; and
 - (b) the reasons for its determination.

10 Conclusion

10.1 The Council has a responsibility to impose on the owners of dogs obligations designed to ensure that dogs do not cause a nuisance to any person and do not injure, endanger, or cause distress to any person. By upholding the menacing classification, the Council will be seen to be taking the action necessary to significantly reduce the chances of Nelson being involved in any future biting incident. If the classification is rescinded, it would make it very difficult to consistently deal with any future dog attacks of a similar nature.

11 Next Steps / Timeline

- 11.1 The Council must, as soon as practicable, give written notice to the owner of:
 - 11.1.1 The Council's determination of the objection; and
 - 11.1.2 The reasons for the Council's determination.

Dog Not Under Control

As you are aware council has received a complaint alleging a dog attack incident attributed to your dog Nelson. The complainant alleges that on 27 October 2020 at Pakawau Beach, Nelson has rushed the complainant jumped up on him and bitten him on the face. The complaint is not in dispute.

The complainant did not suffer any serious injury, he was however shaken by the experience and concerned that you showed little appreciation for the distress your dog had caused.

At the time of the incident Nelson was at large and not under control.

Dog Control Act 1996 (DCA) Section 52 relates to the control of dogs specifically that, when not confined or contained, a dog must at all times be under the control of a person capable of controlling them. Under control means on a leash or that the dog responds immediately to voice, hand or other commands. It is apparent that Nelson does not respond to any commands and should therefore be under leash control when in a public place.

The DCA Section 53 makes the act of failing to control a dog an offence, the penalty for which ranges from a \$200 infringement fee to a maximum fine of \$3000.

Furthermore under the DCA Section 33A(1)(b) Council may, if it believes a dog may pose a threat to persons or animals, classify that dog as "Menacing", requiring the dog to be leashed and muzzled when in a public place. Council does believe that Nelson may pose such a risk, this is due to his propensity to rush and jump at people and your inability/reluctance to exercise proper control over Nelson. A notice of Menacing Classification is enclosed a statement of your rights can be found on the back page.



EFFECT OF CLASSIFICATION AS MENACING DOG

Sections 33 E&F, Dog Control Act 1996

- Section 33E. If a dog is classified as a menacing dog under section <u>33A</u> or section <u>33C</u>, the owner of the dog
 - a. must not allow the dog to be at large or in any public place or in any private way, except when confined completely within a vehicle or cage, without being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction; and
 - b. must, if required by the territorial authority, within 1 month after receipt of notice of the classification, produce to the territorial authority a certificate issued by a veterinarian certifying
 - i. that the dog is or has been neutered; or
 - ii. that for reasons that are specified in the certificate, the dog will not be in a fit condition to be neutered before a date specified in the certificate; and
 - must, if a certificate under paragraph (b)(ii) is produced to the territorial authority, produce to the territorial authority, within 1 month after the date specified in that certificate, a further certificate under paragraph

You will commit an offence and be liable on conviction to a fine not exceeding \$3000 if you fail to comply with any matters in paragraph a] above.

In addition if you fail to comply with the above requirements a dog control officer or dog ranger may seize and remove the dog from your possession and retain custody of the dog until the Tasman District Council has reasonable grounds to believe that you will comply with these requirements.

Section 33F. Owner must advise person with possession of menacing dog of requirement to muzzle dog in a public place

This applies if the dog in the possession of another person not exceeding 72 hours. Failure to comply if convicted may result in a maximum fine of \$500.00

3. Section 33B. Right of objection to classification. You may within 14 days of receiving this Notice of Classification, object in writing to the Tasman District Council in regard to this classification. You have the right to be heard in support of your objection and you will be notified of the date, time and place when your objection will be heard.

Full details of the effect of classification as a menacing dog are provided in the Dog Control Act 1996.

I am writing to object to your classification of my dog as menacing.

am, frankly, surprised at this move, given that the dog control officer I spoke with about this incident said she would recommend that the matter would go no further. She then added there might be a fine, but she didn't think so, in the circumstances.

The facts, as I explained to her, are repeated here...

My dog Nelson is still a boisterous puppy and so I take extra care when walking in public to ensure he doesn't bother others. My previous dog, Friday, was a anxiety based and although we did one-on-one training with Sue from Dog Almighty, and used an electronic collar, I couldn't trust her so sadly had her put great puppy but as she got older she was less reliable around other dogs. She would also escape any fence put in her way. The vet said her aggression was down at 3.5 years of age. This made me more determined than ever to ensure Nelson is trustworthy.

the beach. Given I was already soaked, it seemed a fine idea. I patted one pocket to check I had the lead, another pocket to check for poo bags, a third pocket to On the day in question, we had just driven from Nelson to Pakawau in the pouring rain. I unpacked the car in the pouring rain and Nelson was keen to run on check for dried liver treats in case we wanted to do some training, and we set off.

beach. Nelson was running ahead of me, off-lead. I immediately put out my hand to BJ, saying hello, please just wait. I called to Nelson and he ran instantly to me and sat as requested. And this is where it came unstuck. I should have dropped the bag of dog poo I had scooped up earlier. I should have grabbed Nelson We walked down as far as Totara Ave in the rain, then turned to walk back as the rain eased then stopped. Just past BJ's home, he appeared suddenly on the by the collar while I was reaching for the lead, stuck in the pocket of my sodden jacket. But I didn't, and I was too slow. I had just pulled the lead out of my pocket and was about to attach it when BJ stepped forward, talking. Nelson immediately turned his focus from me to BJ.

BJ has been to my property several times, he has been in my house at least twice. Nelson thinks BJ is his friend. Nelson wanted to say hello. He ran over to BJ and in his excitement, he jumped up. That is not in dispute. Did he bite BJ? I strongly doubt it. Nelson doesn't have an aggressive bone in his body. One of his

best friends in Pakawau encourages him to jump (1 no longer allow John unsupervised visits because of this) and he has never bitten John or anyone else. What is more likely is that Nelson's claw possibly grazed BJ's cheek. But that is a moot point as Nelson shouldn't be jumping, I understand that fully. However Nelson's leap of joy certainly couldn't be called an attack

talk and he stormed off. No one else was on the beach so I took the lead off and we walked back home. I contacted John as he knows BJ very well and told him his face but he took a step back and started going off about birds and all sorts of nonsense. I again took a step towards BJ, saying sorry, but BJ said he couldn't what had happened. I asked John If I should go visit BJ. The advice I got was not to. To now have BJ say, 'you showed little appreciation for the distress' cuts called Nelson back and he responded instantly. I said to BJ, oh no, are you hurt, are you okay? as BJ took a step backwards and put his hand to his face. He shouldn't be doing that, BJ said, I totally agree, I said, I am so sorry, as I clipped Nelson's lead on him, as he sat beside me. I took a step toward BJ to look at me to the core. I tried several times to show my concern, BJ held up his hand to stop me from coming closer and he said he didn't want to talk further.

Nelson has only ever been on the beach with me (or John). During the recent school holidays there were lots of people on the beach so I used his long training The dog control officer I spoke with on the phone said Nelson had previously wandered the beach on his own - this is totally untrue. My dog Friday had twice (as far as I know) gone wandering alone on the beach. After I discovered that, I had her on a long tie every second she was outside so she couldn't escape. line to walk past the family next door building sandcastles, to the deserted bit of beach further down the way. The control officer suggested I should walk Nelson on a long lead until his training proceeds further, I said I already use a long line when people are about.

other dog. This time the dog straddled Nelson's back with Nelson's head in his jaws and I thought it would kill Nelson. Nelson was screaming in terror. I called the sand, yelping in fear as the other dog stood over him, holding him down. I called Nelson and he struggled to his feet to be then knocked down again by the head, and two long strips of skin off the other. Luckily the dog had missed his eyes. I didn't discover he had a long gash on the underside of his rear leg till the Earlier in the year, a dog viciously attacked Nelson. The two dogs were standing nose to nose one second, tails wagging, than poor Nelson was on his back in over and over as Nelson struggled to get the heavier dog off him. The dog's owner was standing a foot from his dog who was viciously growling and shaking my dog, and the man did nothing. He didn't call to his dog or tug the collar - he just stood passively as his dog shook mine. Nelson was finally able to get up and he ran to me. We hurried back to my property and I put him inside the gate and checked him over. He had lost one long strip of skin off one side of his following day. The scar is still visible. After checking Nelson, I closed the gate and walked back out on the beach to go talk to the man. I passed my neighbour Joy who lives two doors along with her small dog, she had watched the whole thing. I asked her if she knew the man, she said no. The man saw me following and he walked faster with his dog, but his unable to take the matter further. I was shocked when later I found he had reported my dog. But I think he did that to avert blame from his own dog. btw, on my dog stopped to do a poo and I caught up. I told him my dog had lost a considerable amount of skin. I said my pup wasn't even a year old and his dog should be on a leash if it attacks other dogs. He said, with a smirk, Your dog attacked mine. I said you know that isn't true. He leaned forward and said, Lady, walk back walk back to my property after leaving the man, I passed Joy again. I was in tears and she asked if I was okay. I said he said Nelson had attacked his dog. She home, I know where you live. It was said with menace and I am ashamed to admit I was scared, and so I went home and as I didn't know who he was I was said, that's nonsense, his dog was the one who attacked.

the jumping when very excited is still an issue, but we are working through this. Before lockdown I had two long (and expensive) phone consultations with dog trainer Mark Vette on how to keep Nelson focused my me all the time, not just when it suited him. I was surprised to learn Mark uses a shock collar. I have one Your comments, 'it is apparent Nelson does not respond to any commands' and 'your inability/reluctance to exercise proper control over Nelson' is wounding. Nelson has had excellent recall from a very early age. We are on the beach and he doesn't even look at birds as he knows they are not to be bothered. I admit and have taken it out to Pakawau for further training, but on the days he's worm the collar to test our new training we haven't met anyone else on the beach.

I request you reconsider the menacing dog classification on Nelson. He is a laid back, happy, friendly dog, not the out of control horror described to you.

Hi Jo, happy to review the classification in 4months (or earlier) just need to be satisfied that Nelson will respond to voice commands and has got over his tendency to jump up on people. I agree that the incident was on the on the low side of the scale as far as dog "attacks" go which is why Council took no punitive action against you, however Council is required to protect the public against intimidation, nuisance or distress caused by dogs. That said you are still entitled to have a hearing. The hearing is run by 2-3 Councillors and is a relatively informal process. They will review the case and decide whether the Classification stands or not.

Let me know if you would like to proceed with a hearing.
