4.1 FREEDOM CAMPING BYLAW PROPOSED AMENDMENTS HEARING REPORT

1 Summary

- 1.1 The submission period on the proposed amendments to the Freedom Camping Bylaw closed on 16 November 2020.
- 1.2 The review was deemed necessary to have additional controls over freedom camping before this summer.
- 1.3 There were over 120 submissions. The removal of sites at Taupata and Waitapu Bridge was well supported and the inclusion of a new site at Rototai was subject to mixed reactions. The concerns about using the site were primarily related to site safety and environmental impacts on wildlife.

2 Draft Resolution

That the Submissions Hearing Panel:

- 1. receives the Proposed Freedom Camping Bylaw Amendment Submissions Report RSH20-11-2; and
- 2. following deliberations, provides staff with recommendations on matters raised in the submissions received on the Proposed Freedom Camping Bylaw; and
- 3. notes that the recommendations of the Hearing Panel on the Proposed changes to the Freedom Camping Bylaw will be reported to Full Council for consideration at its meeting on 3 December 2020.

3 Purpose of the Report

3.1 This report provides the Hearing Panel with a copy of the submissions received and requests the Hearing Panel hear the submissions from those that have indicated they wish to speak. Furthermore, it requests that the Panel deliberates on the matters contained in all of the submissions and gives recommendations on whether the proposed amendments to the Freedom Camping Bylaw 2017 should be adopted. The final decision on adoption of any amendments or otherwise will be made by the Full Council meeting on 3 December 2020.

4 Background and Discussion

- 4.1 Following adoption of the Responsible Camping Strategy (RCS) in April 2020, the Council requested staff to review the Tasman District Council Freedom Camping Bylaw 2017, (the Bylaw) to have any changes in force by 01 December 2020. Due to Covid-19 and other issues it has not been possible to fully review the Bylaw in this period. In order to address the main concerns raised by some members of the community, it was proposed to amend elements of the Bylaw which are contentious and put in place alternative solutions.
- 4.2 At a Regulatory Committee meeting on 15 October 2020 the following resolution was passed:

RC20-10-3

That the Regulatory Committee

- 1) receives the Regulatory Manager's Report Amendments to the Freedom Camping Bylaw RRC20-10-1; and
- agrees that the proposed amendments to the Freedom Camping Bylaw
 are the most appropriate way to control perceived issues dealt with in the proposed amendments; and
- 3) notes that the proposed amended draft Consolidated Bylaw Chapter 11 Freedom camping Bylaw 2017, does not give rise to any implications under the New Zealand Bill of Rights 1990; and
- 4) agrees to start a Special Consultative Procedure to propose amendments to the Freedom Camping Bylaw 2017 as indicated in this report, including Attachments 1 and 2 including as amended by not including the Aorere Bridge site and including a ban on camping in non-self-contained vehicles, except in identified areas; and
- 5) agrees to the statement of proposal contained in Attachment 1 and the summary of information contained in Attachment 2 to this report as amended by resolution 4 being made available on the Council website and at all Council offices and libraries. Notices will also be posted in Newsline and local Newspapers; and
- 6) agrees to establish a hearing panel to hear and deliberate on submissions on 18 November 2020 and to report back to Full Council with recommendations

comprising Councillor Bryant as Chair and Councillors Hill, Walker, Turley and Maling as members with the Chair having authority to co-opt in the event of any unavailability of a member; and

7) agrees to write to the Government requesting a review of the Freedom Camping Act to allow greater regulation of non-self-contained forms of camping.

6 Options

- 6.1 The role of the Hearing Panel is to consider the submissions received and recommend to the Full Council what amendments, if any, should be made to the existing Bylaw.
- 6.2 Some changes are driven by circumstances and must be made i.e. the change in control over areas such as Waitapu Bridge and Waikoropupu Springs Road, meaning we have no jurisdiction.
- 6.3 A report to the Council will outline the recommended outcome.
- 6.4 The obligation is now on the Hearing Panel to deliberate and make decisions on the submissions received.
 - 6.4.1 Option 1: Recommend that Council proceed with the proposed amendments as consulted on.
 - 6.4.2 Option 2: Recommend that Council proceed with different amendments that fall within the scope of the review based on submissions.
 - 6.4.3 Option 3: Recommend that Council proceed with no changes to the existing Bylaw.

7 Submissions

7.1 Any bylaw relating to freedom camping will attract differing views. Then Committee is charged to hear and consider the submissions and recommend what changes should proceed.

- 7.2 There were over 120 submissions (**Attachment 1**). Staff comments on the themes arising from the submissions is attached as **Attachment 2**. An overview of the submissions is as follows:
 - 7.2.1 Near universal support for closure of Taupata Point
 - 7.2.2 Majority support for closure of Waitapu Bridge
 - 7.2.3 Mixed reaction to Rototai Tip site, with some support. Main points against use of the site were:
 - 7.2.3.1 Safety Concerns being a former landfill site.
 - 7.2.3.2 Wildlife concerns
 - 7.2.3.3 Noise concerns

Ensuring site safety, use of fencing and site controls, along with provision of toilets and bins deemed to be necessary for success. Some people seem to confuse the Rototai Reserve with the tip site. A resource consent will be needed to change the use but the risk of gas escape is considered low.

- 7.3 Some confusion that Waikorupupu Springs was a FC site; it was not.
- 7.4 There were also many comments about banning all freedom camping and some suggestions about allowing NZ campers only.

8 Policy / Legal Requirements / Plan

8.1 The Special Consultative Procedure (SCP) conducted in reviewing the proposed amendments to the Freedom Camping Bylaw is compliant with Council's legal obligations in the Local Government Act 2002 and the Freedom Camping Act 2011.

9 Consideration of Financial or Budgetary Implications

9.1 Some costs will incurred if changes are made to the existing Bylaw i.e. site modifications, new signage and leaflets.

10 Significance and Engagement

10.1 The recommendations are likely to be of moderate significance. The treatment of freedom camping is of interest of many ratepayers and there is a need to make appropriate provisions for freedom camping going forward. The SCP process provides for appropriate engagement with the community and is required.

No -	Yes - We own the dairy farm that this stream (Taupata) runs from, so the site is connected to us via the stream. We have had problems with camp people using our cow race as a walk track (google maps has it as an unnamed road!). They walk up the stream during summer when it is dry and access our farm property from there also. We have signs up, they get ignored. Before the forest and bird supporters put up there many many signs at the Taupata sight warning of disturbing shore birds, we had them taking refuge in our cow paddocks. Although it was amazing to get so close to renowned birds, I knew it wasn't good that they were constantly shifted off the area from nesting and feeding. Camp people would go collecting cockles at low tide and frighten them off, when the birds where foraging. I notice the birds use the embankments now more when campers aren't there. The sight was only suppose to support overflow from the registered camping grounds and be seasonal. They were used past the cutoff dates of 1 Oct to end April. Non self contained vehicles would use the site when no toilets where there. It would get excessively overcrowded with campers vehicles during 'silly season' and it wasn't policed effectively because of its location. No funds where available to pay a local to police it properly. I read a one stage the old school cafe was subsiding the toilets. As a ratepayer I would resent having to pay for toilets/rubbish bins for them to use freely and them be a nuisance to our farming business. I wholeheartedly fully support the removal of Taupata gravel pit Campsite for use as freedom campers/ing.

The Nelson Branch of Hospitality New Zealand (HNZ) therefore welcomes the recommended changes increasing the number of prohibited areas, however we would like to see further clear signage educating campers around usable nights, and restricting the use of public facilities to be used only as they are intended, i.e showers must only be used for showering, as opposed to washing dishes. Responsible Freedom Camping affects the amenity of an area negatively through rubbish, waste and congestion in public areas and the flow on affect impacts our members. In 2016 there was a tipping point around freedom camping, with numerous local and international media articles highlighting problems around human waste, rubbish and significant damage to the environmenti. We understand that the Council believe these incidents to be 'perceived' rather than 'tangible', although there are numerous examples cited in the media, and needs to be taken into consideration. HNZ members such as holiday parks, are predominately impacted by freedom camping, as this is where most freedom campers and travellers would have traditionally stayed, yet now find themselves out of pocket with additional issues arising such as: freedom campers stealing showers; dumping rubbish, and using their facilities without paying. Forest and Bird has worked with both the Department of Conservation and Tasman District Council at Rototai to achieve better protection for shorebirds including meeting the cost of educational signage there. We have a commitment to ensuring places are set aside for shorebirds on our coastline to rear their young, to rest and to forage undisturbed. Previous freedom camping sites adjacent to the coast or river have been the subject of littlering with rubbish either washed down into the coastal environment by heavy rain and plastics blown into the sea in windy weather. Inadequate toilet facilities have contributed to further pollution problems. Disturbance to shorebirds has seen sensitive species such as our migratory godwits abandon their roosting site. Forest and Bird oppose the Rototai site for freedom camping on the grounds that freedom campers should not be placed in such an ecologically sensitive area. In this instance protection of our biodiversity must come first. Freedom camping is no longer suitable due to the lack of appropriate areas that do not effect wildlife or natural values.

The current maps show that the area would become an island even under current sea level predictions. It is not appropriate management to be utilising this site. Forest & Bird suggests that a specific site that is removed from sensitive areas and is safe from flooding, e.g. a paddock or carpark with toilets, etc is provided for freedom campers in Golden Bay to stop this ongoing pressure in sensitive areas. It seems the current model is to move from one problematic area, and create a problem at yet another area. That type of management must stop. Making this area a freedom camping site will mean that the area will not be able to be restored and protected for the ongoing needs of shorebirds in the Rototai area (as outlined in the Golden Bay Branch submission), e.g. as a high tide roost site in storm events, etc. There are requirements also under the New Zealand Coastal Policy Statement for sites like these to be better protected.

My reasons for opposing this change are below: 1)I note that according to the freedom camping act of 2011, Golden Bay is not required to provide for freedom campers. 2) Rototai should be fully protected for its vulnerable ecology in the estuary alone, let alone for it's International significance for Birdnesting. 3) Having spent a lot of time over the recent years at Rototai, I have seen the significant adverse affects that freedom campers have brought to the area. I have found myself almost always having to educate freedom campers (on a arrogant and sometimes abusive ear) about the signage and the rules, that I can honestly say I have almost never been adhered too. Most of this relates to lack of use of the toilets provided and fires. 4)We are an isolated community at the best of times. TDC is proposing 60 Freedom Camping spaces in addition to the 12 at Motopipi Street, a total of 72 spaces. In other words, GB would be providing 1 Freedom Camping space per 52 residents. If Auckland, on a per capita basis, wanted to catch up with TDC proposed additional spaces, it would need to provide 33,029 Freedom spaces! However, Auckland does not accept the idea that they need to provide more spaces simply because visitors want them. Other Local Authorities with lots of tourists such as Rotorua provide far less spaces than Tasman district. As a resident, I already pay for my own septic system, water system, toilet paper, rubbish and wifi. TDC cannot rationally justify expecting resident ratepayers and taxpayers to foot the bill for all these services so that visitors can have subsidised holidays at our expense. TDC has an excellent set of criteria for site selection in its Responsible Camping Strategy. It appears that these criteria were ignored when the former Rototai Tip site was proposed. It is hard to imagine a worse place to establish a Freedom Camping site, dangerous for campers and bad for the environment. We already had to evacuate Freedom Campers from Waitapu so why is another flood zone proposed? Visitors to Golden Bay are fortunate to be able to choose from a very wide range of accommodation providers. We have a lot of accommodation and that is why the population of Golden Bay swells in the summer season. TDC ratepayers don't want to purchase land to provide more Freedom Camping sites. Most are are unaware that holiday parks now cost between \$40 and \$50 per night for two people – that's more than rent on a house in many situations, and prohibitive for people on low income or part-time wages. The people who avail themselves of freedom camping for financial reasons still spend considerable money on petrol, groceries, and supplies. They are contributing to the financial well-being of the communities where they park up. We are visitors from the United States, who arrived here in early March but have stayed for (legally) a good number of reasons. We have stayed in posh hotels, backpacker accommodations, holiday parks, we have freedom camped, and we are now renting a house in Golden Bay. Freedom camping is an important component of the ability to travel the country, and experience your many natural wonders, and Kiwi hospitality. As mentioned above, freedom camping is valued highly within native Kiwi society. Removing opportunities for freedom camping is flat wrong. Additionally, freedom camping is providing a safe and sanitary location for many essential workers to live – agricultural workers are frequently tenants of freedom camping locations. They don't make that much money, and removing a free housing option from them is simply not right.
