6 REPORTS

6.1 Community Grants Surplus Funds 2017/2018

Cr Greening was in attendance and spoke to the Special Grants funding report.

Cr Greening noted a Resolution at the Full Council meeting on 28 September 2017 was to bring the Tasman Rugby Union application to this meeting to consider.

Mr Tasman-Jones, Community Partnerships Coordinator outlined the application from Tasman Rugby Union was considered as recommended, but did not fit the criteria for Special Grants funding.

Ms Edwards, Community Development Manager who was in attendance at the meeting reiterated the application submitted did not demonstrate meeting the criteria.

Mike Tasman-Jones, Community Partnerships Coordinator spoke to the Surplus Funds report in reply to a question to advise the surplus funds were closed funds. Mr Tasman-Jones also advised the funds could not be transferred to the Sport NZ Rural Travel fund as these funds are Council administered on behalf of Sport NZ.

There was some discussion around the possibility to make this funding available for rural schools travel costs. Cr Wensley's proposed an amendment to the resolution but this lapsed for want of a seconder.

6.2 Special Grants Fund Project Report

Mike Tasman-Jones took his report as read.

Mr Tasman-Jones spoke to the Golden Bay community programme main purpose to set up a course working for tertiary education, and to create an income stream for the gardens.

A question was asked if the course could be recognised, it was advised it was a process they were working through.

It was demonstrated in the application that economic and social development were part of the criteria of the fund and this was met on many levels.

Mr Tasman-Jones spoke briefly to Tapawera Armistice Weekend which will be a large regional event.

It was advised that Corporate Services are meeting the funding for the Tasman Rugby Union application from the rates growth fund surplus as per Full Council resolution CN17/09/23.
