Spraying Update

This month aerial spraying was done for 6 days between 26/4 and 2/5 on the hill country behind Ligar Bay, Pohara and Clifton. Spray drift occurred in Clifton in the early afternoon of Wednesday 30/4, and several complaints to council have been made. I haven't yet got details back from Jane Baker, TDC's compliance officer, but I expect I'll get the usual response, "that the resource consent conditions are being adhered to".

My breathing has been stifled since then, and although I'm an emotionally resilient person, I admit to feeling despondent about the prospect of living in these times.

I implore the Community Board to understand that i am but a canary in a coal mine, and that EVERYONE is vulnerable to the toxic effects of chemical spray drift inhalation.

I urge you to take increased responsibility for the advocacy of public health in Golden Bay. There is legislation to support this; TDC's own TRMP, Policy 34.2.3.1 says it seeks "To avoid, remedy or mitigate any adverse effect on human health or the environment from the discharge of pesticides, particularly through spray drift or discharge into water bodies".

Please may I have some answers to my questions?

- = On 11/3, regarding riverbank spraying, your action sheet recorded that "an email about increased community input into resource consents was forwarded to Leif Piggot, who has asked Gary Clarke to comment". Have you received any feedback?
- = On 19/3 Jenna Voight was emailed by the Community Board about getting the text notification that Felicity and I used to receive, re-instated. Did she reply?
- = On 8/4 I requested that the Board consider the email I'd written to Dennis Bush-King on 12/3 and forwarded to Martine, Carolyn and Laura on the same date. It hadn't appeared in the incoming correspondence of the April meeting's agenda and I asked that the Board email Dennis expressing concern for the lack of notification; so I was dismayed to see in the 9/4 actions sheet, no action, just the statement, "the engineering department has written to Iona and Felicity explaining the reason why they do not receive text notification any more". The reply I got from Dennis was that the resource consent had no conditions of notification attached, period. He advised that an opportunity to influence the situation existed when the resource consent is up for renewal in May 2015. I hope you can see that public notification of spraying operations needs to happen and choose to support our efforts to effect this. Please would you commit to writing to Dennis Bush-King?
- = On 16/4, Giles Griffith emailed me to say that signage will be used this year at swimming holes on the day of spraying and for a couple of days afterwards. I'm in communication with him about which swimming holes and the withholding periods of the chemicals to be used.

The Spray Updates that I've been giving at the Community Board Public Forums are no longer permitted to be included in the minutes, so I rely on good

Rural Women NZ celebrates Road Safety Week with good news from 20K school bus signs trial

A year-long school bus safety trial in Ashburton has shown that illuminated 20K signs on buses can have a big impact on driver behaviour.

"For years Rural Women NZ has called for clear signage on school buses to indicate the 20K speed limit in both directions when passing a bus that's stopped to let children on or off. This is great news and a perfect way to celebrate Road Safety Week," says Rural Women NZ vice president, Kerry Maw.

"Every day motorists speeding past school buses on rural roads put children's lives at risk."

During the 'Either Way It's 20K' trial in Ashburton there was a marked drop in speeds when the 20K signs were in operation, with many motorists slowing to between 25 and 35 km/h.

The bright LED signs lit up automatically when the bus door opened, and flashing amber lights operated for 20 seconds before the bus stopped and after it had pulled away, giving approaching drivers plenty of warning of a hazard ahead.

The three-stage trial was carried out by TERNZ Ltd with funding from the Road Safety Trust. It began with an awareness campaign, followed by installation of the signs on Pearsons Coachlines' school buses. The final stage was an enforcement operation by the police.

While the awareness campaign increased knowledge of the 20K rule, alone it had little effect on driver behaviour. However installation of the signs on the buses had an immediate and marked impact.

Rural Women NZ hopes the 20K signs will be approved for use as part of next year's amendment to the Traffic Devices Control rule, if not sooner.

TERNZ's final report and recommendations will be submitted to the New Zealand Transport Agency by the end of June.

In New Zealand buses are multi-purpose and come in all shapes and sizes, the only
requirement being to display a SCHOOL or KURA sign when they are used on a school bus
run.

 Despite good education programmes in schools and through the police, children will sometimes behave unpredictably and have poor ability to judge the speed of oncoming traffic.

Key Outcomes of the Trial

- 26% more respondents in the post survey knew the legal speed limit past a school bus when stopped to drop off or pick up children.
- 22% more respondents in the post survey claimed to normally pass a school bus at 20km/h
 when stopped to drop off or pick up children.
- There was a 19% increase in the post-trial survey respondents that thought 20km/h was a safe speed past a school bus when stopped to drop off or pick up children.
- More respondents agreed / strongly agreed that the sign combination (LED sign and school sign) was safer than the original school sign.
- All stages of the trial showed a decrease in motorists speed past a school bus in 100km/h zones.
- The enforcement + signs installation + awareness campaign showed the largest reduction in speed overall.
- Long term results indicate the signs are effective at maintaining lower speeds past school buses with no accompanying targeted enforcement and awareness campaign.
- The large external signs were legible from approximately 200m
- The fields of sign performance exercise indicated that those motorists braking 200m prior to passing the school bus were able to reduce their speed to the 20km/h legal limit in a 100km/h area.
- A set of signs on the front and back of a school bus is likely to cost in the region of \$2000 installed.

Purple Pampas (Cortaderia jubata) at Ligar Bay

Purple pampas is distributed throughout Tasman District, mostly on steep hill country. Because of its widespread distribution, it has been included as a Containment pest with the objective of preventing any increase in its density or distribution. The Regional Pest Management Strategy requires landowners to control Purple Pampas on their land but it is a difficult rule to enforce. It has been an ongoing issue for many years at Ligar Bay. The light wind-blown seed has the ability to travel long distances downwind and infest bare land. The presence of this pest on adjoining land can create a problem for exotic forest owners when their forests are harvested, with the newly cleared land providing an ideal seed bed until canopy closure.

When owners are asked to control a pest plant, they are requested to undertake control within a certain time frame. If the work is not been completed on time, a Notice of Direction is issued that legally requires the work to be done within a given time. If the work is not completed, Council can arrange to have the work done and on charge the landowner.

As a result of the extreme storm event at Ligar Bay in December 2011, some landowners were hit with extensive slipping and access damage. Council staff agreed to waive the pest plant control requirement for the following year. This year, these owners have been asked to control the pampas. If this is not completed on time, a Notice of Direction will be used. In the past, two Notices of Direction have been issued.

A forestry company, PF Olsen & Co Ltd, is arranging the logging of the small forests in Port Ligar for the three different landowners, and will be recommending that the forests be replanted. This will require control of competing weeds including purple pampas in the short term and eventually shade out the pest from much of the area. There is also a requirement in the resource consent issued for the logging and roading that the parts of earthworks are revegetated following disturbance. Logging is due later this year. Enquiries should go to the Council's Biosecurity Officer, Ken Wright.

I have written to Jane Baker and will give a copy to Laura to send to you. I have asked Jane questions and clarification which is in the covering letter for a quick reference. If you wonder why I have asked a question you'll find further background information in the text.

I found the following information in MWH Application for Discharge Permit, Applicant's changes accepted and further edits made by MD, (Michael Durand, Co-ordinator Natural Resource Consents) for the road reserves resource consent. Last page;

The conditions of this consent may be reviewed in accordance with sections 128 to 133 of the Resource Management Act, within three months of the anniversary of granting of this consent, in particular within three months of the third and sixth anniversaries of the granting of this consent, for the purposes of;

-dealing with any adverse effect on the enivironment arising from the exercise of the consent;

-requiring the applicant to adopt the best practicable option to remove or reduce any adverse effect on the environment;

-reviewing the monitoring requirements placed on this consent.

The consent was granted on 24 February 2009, so the sixth anniversary will be in February next year.

Iona says she will look into sections 128 to 133 of the RMA for further information. She says in the RMA people are included in the environment.

I am not sure if the state highways resource consent is also bound by these sections of the RMA. It was granted on 4 March 2009. If it is it may be up for reveiw next year too.

I hope this is useful information for you.

Hi Jenna,

As discussed, here are some of the issues that have been raised at the recent Golden Bay Community Board meeting:

- A number of people are asking for clarification of Swiftsure Street's residential status. This question is difficult to answer, it could be interpreted many ways. Need a more specific question. Note Jo Pomeroy has applied for a new access crossing and this has been approved.
- Can the culvert pipes be removed from Swiftsure Street before the hard surface is installed? In short no. At the time of reconstructing Swiftsure St these culverts were filled with concrete so that water can no longer pass through them. They are redundant.
- Can the Blackwood be sprayed on the cliff face of Swiftsure Street? Swiftsure St is not a maintained road. There is no funding allocated at present for this work.
- The back of Mr Foster's property is on Swiftsure Street, would he have access rights once the road is complete? Mr Foster is welcome to apply for a vehicle access permit however it is very unlikely this would be granted as he already has access to Gibbs Road. Council do not allow construction of a second access in a residential area.
- Gibbs Road Track, they are still waiting for the light and handrail to be installed. As discussed with Carolyn, refer to previous correspondence.

As I have explained in previous correspondence a handrail would only be constructed if required by the Engineering Standards or Building Code.

In the instance of Gibbs Road walkway it does not meet any of the triggers which would require the installation of a handrail.

I discussed this issue with Carolyn prior to the recent GBCB meeting to try and gain a better understanding. The outcome of that discussion was it was clear that the desire for a handrail was to assist elderly pedestrians who use the walkway and find the grade too steep.
