### UPDATE OF TDC ROADING RESERVE SPRAYING REGIME

As of 7/3, Council is posting a weekly spray notification on it's website. This indicates a window of time within which spraying will occur (weather permitting), but does not give times of when spraying will actually occur.

In his letter of February 26th, TDC's Transportation Manager, Gary Clark, states that "in providing this service we are confident that we meet the requirements of the resource consent". Yet to fulfill the degree of protection stated in the TRMP (34.2.30 and 34.2.3.1) and the NZ Standard Management of Chemicals Code of Practice (Appendix M.M4.c), txt notification on the morning of actual spraying operations is necessary. Felicity and I haven't been notified in this way since June '13, and our lives have been significantly adversely affected as a result.

On Monday 3/3, outside the advertised time-frame of due spraying to be done, a Fulton Hogan vehicle passed me along Glenview Rd as i was walking to work. The vehicle stopped just ahead of me and had a spray-tank on the back, but I hoped for the best, focusing on the "Road Marking" sign displayed. A guy hopped out of the vehicle and I could see him getting ready to spray so I put on my mask. It was 10am, a stiff breeze was blowing, and I couldn't believe the amount of liquid being sprayed into the ditch! Now I know what a cannon gun is....Luckily I was able to take refuge at my son's place and get a ride to work, but this sort of incident is outrageous! I wasn't the only one travelling by foot or bike along Glenview Rd that morning.

Tests show that toxicity levels as a result of inhalation of spray drift is up to1000x higher than those from oral or dermal exposure, and anyone can become chemically sensitive as a result of a single significant exposure. Unlike the resource consent for state highways, the resource consent for roading reserves has no condition 35, and spraying vehicles do not need to carry signage. Not that signage helps much if you are on foot; by the time you see it, you haven't enough time to get far enough away to be unaffected by the spray drift. My breathing has been severely compromised all week.

Jane Baker of Compliance was understanding when I spoke with her and was encouraging about the possibility of txting being re-instated to notify people of spray operations. However today I heard through Felicity that Dennis Bush-King has vetoed the idea. I have yet to speak with either he or Jane Baker, but will email them both and hope to speak soon.

In December '13 Felicity emailed Dennis Bush-King about several significant irregularities with the resource consent for roading reserves, all of which remain unanswered.

Namely,

- = That the Environmental Impact Report used to inform the 2009 resource consent application and approval dates back to 1993.
- = that in the resource consent Metsulfuron / Escort is quoted as having "very low toxicity to aquatic life", yet in the NZ Novachem Agricultural Manual it's quoted as being "Ecotoxic and very toxic to aquatic organisms with long-lasting effects".
- = Also Picloram / Triclopyr is not approved in the resource consent and yet it's being used.

I will email Dennis Bush-King again about these concerns , requesting his response to these anomalies.

As always, thankyou for your continued advocacy, it is much appreciated.

#### Dear Geoff

I am writing to express my concern about the speed limit at the cross roads intersection just south of the township of Takaka. The opening of the Golden Bay Integrated Family Health Centre last October has had a significant impact on traffic volumes on this stretch of State Highway 60.

The new health facility comprises a hospital, a rest home, a maternity unit and community health and general medical practice facilities. As you will appreciate, this has resulted in considerably more traffic travelling down Central Takaka Road and turning right on to State Highway 60. This includes the Golden Bay ambulance.

Visibility at this intersection has never been great and with the increasing traffic flows, residents have expressed concerns about the 100 km/h speed limit that currently applies on this stretch of the road.

I note that a temporary speed limit of 80 km/h applies on this road during the summer months when there are a great number of visitors and tourists in the district.

I would appreciate, as a priority, the reduction of the speed limit on this stretch of road and erection of appropriate signage to warn motorists of the hospital.

#### Dear Carolyn

Thank you for sending the letter from Heather Wallace regarding beach fires in Golden Bay for comment. Heather attended our recent Community Forum to express the same concerns.

The management and suppression of fires within Golden Bay is the responsibility of the Waimea Rural Fire Authority. Within Golden Bay, the Department of Conservation issue permits for fires west of the Parapara Estuary and Rural Fire Network (Ian Gardiner) issue permits for central and eastern Golden Bay. Those wanting a fire permit from the Department over the Christmas/New Year period can obtain one from the Duty Officer, whose number is given on the office after hours answer phone message.

Both organisations issue many permits for beach fires over the Christmas/New Year period. Beach fire permits have a set of standard conditions that include that a fire must not be lit at times of high winds and that the fire must be lit below the high tide mark. Unfortunately high tide this New Year's eve was around 10pm meaning that most fires were lit high on the beach.

I agree with Heather that beach fires are a potential threat, particularly if they are unpermitted and lit in unsafe conditions. The Waimea Rural Fire Authority is considering how to best work with the Golden Bay community to reduce the threat from beach fires next summer.

Hi Laura,

Yes we have already said we will put signs up when spraying around know swimming holes, I have received a proof from our contractor for the signs and we are still a way off spraying these areas.

I do not think having them up when we are spraying upstream is worthwhile. The question is how far upstream? the signs will lose their value if we have to put them out anytime we are spraying upstream (i.e. this will be much of the time).

The intention of the signs is to give people a choice of whether they enter the area or not on the off chance of any chemical residues that may be present on sprayed vegetation or ground - any chemical that gets in the water is just about instantly diluted to undetectable levels given the river flow and is quickly transported downstream in any case becoming further dispersed.

Dear Hamish,

Since 2011 my friend Iona Jelf and I have been requesting that the council notifies the public before roadside spraying commences as there are a number of people who live in Golden Bay who experience health issues when exposed to the spray drift. I have been very sensitive to herbicides for 21 years and take the precaution of wearing a respirator when driving a vehicle. Iona and I used to receive a txt message from the contractor the night before roadside spraying was to commence. Since June 2013 he has been taking long term leave and so we have not received any txt messages.

#### **Incidents**

On 27<sup>th</sup> January 3.00pm I was driving to town along Able Tasman Drive when I noticed a Fulton Hogan truck approaching. It had no signage on the front. When I realised it was spraying I immediately pulled over onto the verge and did a U turn. By then the spray vehicle was opposite me and I noticed that the driver had this window half down and he was not wearing a respirator. I returned home and thoroughly hosed down my vehicle before removing my respirator.

7.00am 28<sup>th</sup> January I heard helicopter close by. I noticed it once above the brow of a small rise above the pine trees a couple of hundred meters away with booms extended. There was a light swirling wind. An hour later I was experiencing muscle spasms and spent the following 9 days more in bed than out. There were three other people in the vicinity but they were unaffected. I am still recovering.

## Council/Compliance

I txted our local councillor Martine Bouillir and she got in touch with the compliance officer at Tasman District Council. It was 5 weeks before Jane Baker and I finally had a phone conversation regarding these incidents. She had to be reminded by Martine to contact me because she had forgotten. I gave her the details of what had happened and asked her to find out who was aerially spraying and what chemical was being used. She asked me if txt notification would be useful, to which I replied "yes".. A week later she had no answers to these questions who was aerially spraying or what they were using. She reminded me of a letter sent to me by Dennis Bush-King of Environment and Planning at TDC that states, "under the Consent there is no obligation to notify the wider community when spraying is being under taken, and it would be impracticable to do so." (24 December 2013)

We received an email from him on 26<sup>th</sup> February 2014 to say that council will now be posting its roadside spray notification weekly on its website. Unfortunately I do not have a computer that connects to the internet so it is of no value to me. I said that receiving txt messages was the only effective way to contact me,

This week I have spoken to the manager/share milker of the property were the helicopter was spraying. He confirms that the spraying was done by Coast to Coast Helicopters Ltd.

#### Legislation/resource consents

TRMP (Tasman Regional Management Plan) chapter 34

34.2.30... "the Council's view that the seriousness of the level of concern about adverse effects resulting from the use of pesticides is a significant issue, The seriousness and level of concern about the issue of pesticide spray drift make it imperative to avoid any significant adverse effect."

34.2.3.1 "To avoid, remedy or mitigate any adverse effect on human health or the environment from the discharge of pesticides, particularly through spray drift or discharge into water bodies."

#### Resource consents

Condition 35 of the state highways resource consent (RM090020) states;

Vehicles associated with the spraying must display signs (front and back) warning the public that spraying with herbicides is taking place.

There is no similar clause in the road reserves resource consent (RM080624) which covers Abel Tasman Drive.

Both roading resource consents state that the use and application of herbicide are carried out in accordance with the NZ Standards of Agrichemicals.

#### NZ Standards of Agrichemicals, Appendix M

#### M2.1 Application of agrichemicals including fumigants

Notification of the intention to spray is intended to inform people who could be affected, and provide the opportunity for them to take action to avoid or minimize potential exposure of themselves, their children, or their property to specific applications of agrichemicals.

Notification to satisfy the requirements of this Standard for different use situations is set out below. In each case however, check and comply with appropriate local authority requirements.

#### M2.4 Application in public places and amenity areas (shall means mandatory)

Notification shall be by way of notices in local newspapers, or other recognized methods such as "information drops". Notification shall be given not less than one week prior to application and shall be in accordance with local authority requirements. Information shall include:

- (a) The district, street or location to be treated;
- (b) The period of use;
- (c) The reason for use (e.g. vegetation control).

In addition the notice shall indicate where or how further information can be obtained.

- (e) Vehicles or equipment used for applying agrichemicals **shall** have an appropriate sign, e.g. "Agrichemical Application in Progress, (herbicide/Insecticide/Fungicide)". The name of the local authority or contractor **shall** be displayed;
- (f) Appropriate temporary hazard warning signs shall be used where spray vehicles are likely to be a hazard to motorists. Such signs must comply with requirements of the Traffic Regulations-check with the Land Transport Safety Authority;
- (g) Other temporary signs shall be appropriately placed so that any people approaching the target area see them.

#### M3 Signage

Signs can be used at the application site to advise that agrichemical application is being, or has been carried out. To satisfy the requirements of this Standard the sign **shall** clearly indicate the type of agrichemical used e.g. herbicide, insecticide.

# M3.1 Special requirements

Put signs on all normal lines of approach to an area treated with agrichemicals in the following situations: (a) Public places, for any agrichemical use;

(b) Other areas that may be accessible to the public.

Signs shall be there during agrichemical use, and shall remain in place for a period equivalent to the contact re-entry time for the agrichemical use (refer to product information or supplier).

Users shall check with the appropriate local authority for any specific information to be included on signs.

p 154, M4 under Spray Plans/Protocols,

c) ..... lists of people (and their contact phone number) who want to get a phone call just prior to any spraying, any other mutually agreed strategies to manage risks.

This is the legislation that I have found and sent to council to ask for notification to avoid meeting the roadside sprayer.

Jane Baker has phoned me to say that the aerial sprayer used Dicamba.

# Submission to GB Community Board 8/4 by Iona Jelf

### Spray update for March 2014

- = On 11/3, sprayers were spotted under the Kotinga Bridge, and when Felicity enquired, Giles Griffith said that they were Council contracted and doing routine spraying. The online spraying programme for that week was for the Waingaro river 0-6km from its confluence with the Takaka river, and for the Takaka river 13.8-17km from the river mouth. The Kotinga Bridge is about 7.5km from the river mouth, almost 6km out of the advertised area. I have e-mailed Giles Griffith about this discrepancy. This is how people are exposed to hazardous chemicals unnecessarily.
- = Jane Baker of Compliance is following up my complaint about the spraying incident on 3/3 in Glenview Rd.
- = Item 3.6 from the March Public Forum Report states that "Council have made the decision to make information available to everyone rather than individuals" and infers that the online notification is sufficient. But as we stated last month and has been proved yet again above, these spraying updates are inaccurate, not only because the areas and time-windows are not adhered to, but also because spraying operations are weather dependent. A txt after the decision to spray has been made on the day is the only certain way to know that spraying is happening. A multiple texting system (that would be easy to set up), would save Felicity the hours of texting others that she has undertaken in the past.

Thankyou for emailing Jenna Voight on 19/3 about getting the txt notification re-instated. Has she replied to you yet?

= On 12/3 I forwarded a letter (to Martine, Carolyn and Laura) that i wrote to Dennis Bush-King, outlining parts of the TRMP, RMA and NZ Standard Management of Agrochemicals that support the notification of people prior to pesticide applications. (This doesn't appear in your "Incoming Correspondence" and I wonder if you have received it?). I spoke with Dennis and he says that the resource consents are the guiding documents and don't have conditions of notification attached to them, but that when the resource consents are up for re-application the notification issue can be challenged.

Please would you email Dennis expressing your concern for the lack of public notification? I believe that if we keep on about this consistently leading up to the resource consent re-application (probably in November of this year), we may have some chance of influencing it.

= On your Action Sheet, in response to Rebecca Reider's request for signage at swimming holes when riverbank spraying is happening, there is no-one tagged under the "Responsibility" column, and nothing under the Completion Date/Status" either. Please would you follow her request up with Giles Griffith?Thankyou.

We know that all of this is very controversial; it's even played down through being frequently omitted from the Community Board Meeting Report by a GB Reporter! We so value your ongoing commitment to advocating for Public Health in this way.

#### GIBBS ROAD TRACK -- A BRIEF HISTORY OF DEVELOPMENTS SINCE 2004

Terminology & Background: "Gibbs Road Track" is the footpath segment connecting lower and upper Gibbs Road, Collingwood. Technically it is "road", and therefore the responsibility of Engineering Services, Tasman District Council. (Sometimes referred to as a walkway.)

Its upgrade was part of a wider proposal to improve visitor awareness of and access to the Historic Cemetery in Orion Street, and which included installing a footpath in Washington Street as well as signage. The Gibbs Road track is the only safe pedestrian access from/to Collingwood village for visitors, residents of Gibbs Road and the subdivision, and Area School/Playcentre students.

2004 (May) Proposal to upgrade access & signage is accepted by Golden Bay Community Board (GBCB). TDC budgets \$15,000 (half the estimated cost) from DILS finding; community commitment is to do plantings and maintain Historic Cemetery tracks.

2005 (June) First community working bee on the banks of the stormwater channel and top end of Gibbs Road Track and carry out first plantings. (*Photos available*)

2005 Washington Street--gravel footpath installed; subsequent tarsealing (planned) has not yet been done (2014). Grass planted on either side of gravel path.

Potholes on Gibbs Road Track repaired for the October bicentenary of Battle of Trafalgar and the path was swept.

2005 (Nov+) Signage installed (red-topped posts and directional panels).

Submission that reconstruction of the Gibbs Road track be a priority for the 2006/2007 work plan. Increased usage of Gibbs Road Track by tourists due to heritage panels and signage.

2007-2008 Further submissions to TDC annual plans for completion of work on Gibbs Road Track. Ongoing requests for path-up jobs on the Gibbs Road Track (*Photos available*.)

2009 (June) Gibbs Road Track widened and asphalted following damage by a severe storm; conduit laid for electrical supply; seat installed.

Planting alongside the path could therefore finally begin--and has continued since, subject to weather and completion of Swiftsure St stormwater control work. (Plants since then provided by Stream Care, Coast Care and the community-value approx \$1000 to date and ongoing)

2009 (May) Steve Elkington (Assets Engineer Roads) reported to the Golden Bay
Community Board that the upgrade work would include a "hand-rail ... on the
steeper section of the path" and "provision for a [centre light] can be made".

2010 (April+) Asked Steve Elkington re progress on lighting. He said he would investigate. Solar cats eyes installed in centre of path had to be removed as blinding (or not working) and easily tripped over.

2012 Swiftsure Street stormwater control work carried out. Further plantings on Gibbs Road Track were then possible.

2013 (July) (and December–for update) Request to GBCB for maintenance (clearing around plantings) to be taken over by TDC and for unfinished work (handrail & light) to be completed. *Nothing has happened.* 

2014 (March) Healthpost takes on responsibility for clearing the Historic Cemetery tracks, and do trapping.

2014 (April) Request for update on progress re TDC taking over maintenance at GBCB.

<u>Answer:</u> declined by Engineering. Decision to include the maintenance in annual plan submissions.

Just a quick word of caution, any extra signage as you have suggested would first need to be approved by NZTA If it was to go on the state highway.

Hi All, received this from Jenna this morning and it looks to me like a good option that is not too difficult or expensive. Jenna knows and understands that the Trust are not in a position to do costly intersection work. The Community Boards position all along has been that we have sought to have an 80ks from Paynes Ford all year around not just seasonal as at present. Unfortunately this option is not supported by all the heavy transport operators although Fonterra have said they would work in with whatever the community wants. The other thing we could fund is signage that says Hospital/Health centre/Elderly Quiet / please slow down-you see these in other areas and often

If we could fund that signage on SHW60 to go up at the same time as we do the Stop signs(if we all agree) there would hopefully be some savings. The Community Board met yesterday and we will be in touch with NZTA to ensure that they understand that the Board are not promoting costly intersection works.







Bridge and Drain out to sea at Clifton – Council have dug a ditch from Totally Roasted to Laurie Healy's house on Selwyn Street and the dirt has been placed on the southern side of the creek. This dirt needs moving to the other side to protect the houses. The water is now ponding on Laurie's property due to the culvert being too small. In response to your concern expressed at the community Board meeting regarding the foliage at the end of Richmond Road, the Board contacted the engineering department to investigate. Here is there response:

I have had a look on site and unfortunately there is very little we can do.

The plantings are behind the boundary, and when looking at it on-site they are reasonable well trimmed. I note that the intersection is controlled by a stop sign instead of a give way sign which will be due to the poor visibility.

Whilst the visibility is restricted, if drivers come to a stop near the limit line there is sufficient sight distance to pull out of the intersection safely.

## Notes from a meeting held in Collingwood, Tuesday 15 April 2014, 1.20-2.30pm

The meeting with PHO representatives held in the Collingwood Fire Station was at the invitation of the Collingwood Surgery Group (CSG). This document records brief notes of key points raised at the meeting, grouped together but not necessarily in the order in which discussed.

The need for such a meeting was created by the unanticipated withdrawal of doctors' surgeries at Collingwood following the opening of the integrated health facility in Takaka (October 2013). Withdrawal of services has caused deep concern and inconvenience in the community of westem Golden Bay (population over 1000). Correspondence between CSG and the Minister of Health had suggested the need for PHO consultation with the community.

<u>Present (CSG)</u>: Graeme Miller (Chair of the meeting), Carolyn McLellan, Joy Warren, Noeleen Hunter, Jason Lockwood (until 2pm), Sue Brown, Chantelle Riordan, Vincent Andrew (until 1.40)pm, Jean Beatson, Wendy Drummond. <u>Note-taker</u>: Penny Griffith. <u>Apologies</u>: Janelle McKenzie, Lynne Etheredge, Michelle Riley.

<u>Present (PHO)</u>: Andrew Swanson-Dobbs (**AS-D**), Rhoda McDonald (**RMcD**). <u>Apologies</u>: Struan Clark.

# Introductory:

CSG: Introduced themselves and who they were representing.

#### AS-D:

- Explained his 8-year involvement in the project, the point of which was/is sustainable rural GP services. (<u>Note</u>: PHO funds only services (not buildings); Takaka GPs are the only group of mainstream GPs that are employed by the PHO.)
- The development of the Takaka facility had been possible only with the goodwill and financial support of the whole GBay community.
- Would love to deliver all the services people want, but have had to make it viable for the whole of GBay, and need a critical mass in 1 place.
- Decisions had had to be made within the available \$s and one decision made was to NOT have GP services in Collingwood.
- Struan Clark had said that even under the old regime doctors wouldn't have been to sustain safe services at Collingwood indefinitely.
- Could have communicated this and consulted better -- "Sorry". He is responsible for that
  and the decisions made.
- A specific problem affecting services in Collingwood was lack of a building—now resolved, but need to find how to improve it.

# RMcD:

- Has a 2.5-year involvement and is responsible for clinical safety.
- · Doctor time at former Collingwood surgery was being wasted.
- Services are constantly being reassessed to find better ways of delivery.
- Services at Collingwood might increase, but would be at the expense of something else in overall services to Golden Bay.

#### **DISCUSSION ON SPECIFIC TOPICS, WITH ACTION POINTS:**

#### 1 Current building at Collingwood (ex-dental clinic at CAS):

- Ownership/administrative arrangement with PHO needs to be put in writing by CAS.
   Action: CSG (CAS)
- Aim to fit admin structure within existing framework rather than set up a new group.
- Needs some work (e.g. replacement of louvre windows) to make it safe for staff and users, especially babies. PHO can't help with funding. <u>Action: CSG</u>
- Possibility of a surplus CAS building becoming available to add on to the dental clinic. This could increase the usefulness, e.g. for Well Child, physio.
- PHO advised against embarking on major investment in anticipation of additional services that may not eventuate.
- Current cost to PHO is \$35/month (for electricity).
- <u>Parking issues</u> (re school bus activity): Need to keep clear 8.30 to 9am & 3 to 3.30pm.
- Agreed: need to work together to achieve better facility and outcomes at Collingwood. Action: PHO & CSG
- <u>AS-D</u>: Acknowledges that the PHO needs to repay some of the community goodwill; they will look at the building and ask staff what is required.

# 2 Current Services at Collingwood:

- Described by PHO as "briefcase" level, i.e. below the range of accreditation as a full clinic. Means that only certain services can be provided.
- Services can't be extended into the afternoon because of processing schedule for blood tests.
- Clinics will continue only if they are used; there is no long-term commitment.
- Nurses volunteer to do the Collingwood clinic.
- Any registered nurse can provide the service, but not possible to spare more than 1 nurse at a time, which means clinic can't do injections. (It would be possible to do injections if local people with current First Aid certificate were also there.)
- A Collingwood clinic for flu injections will be considered on that staffing basis.
   Action: PHO
- A men's cardiovascular etc clinic in Collingwood to be organised in conjunction with Fire Service. Action: PHO
- Other services, e.g. BreastScreen bus—can campaign for it to come to Collingwood.
   Action: CSG.

#### 3 Signage and information (Collingwood Clinic)

- Services available and the location are not well understood and have been poorly advertised in the past--need more publicity and signage. <u>Action: PHO</u>
- Lack of adequate and accessible information (e.g. website, GBWeekly, CAS Newsletter). Website very out of date; to be upgraded. <u>Action: PHO</u>

#### 4 Other issues & questions:

• Is isolated rural funding available for Collingwood?--AS-D: Is allocated to Golden Bay as a whole; no longer a separate allocation for Collingwood. Confident this will

- apply into the future as GBay will always be "rural". **RMcD**: Policies and allocations for this may change; points system is under review.
- <u>Residual Funding</u> (from Joan Whiting sale) to assist with essential clinic work in recompense for broken promise?--<u>AS-D</u>: No; tied up with DHB arrangements to keep Joan Whiting open.
- Wrinklies transport from Collingwood: Only available to a few who are also members of another group; delays at Takaka end. Usage to be reviewed as cost of subsidy may be better spent on a second nurse clinic at Collingwood. <u>Action: PHO</u>
- Holding earliest appointments open for western Golden Bay residents is good; maybe this could be extended?
- <u>Takaka facility--doctors' services</u>: Currently have problems in meeting demand due
  to unexpected absences among the 6 doctors (none of whom are fulltime). Level of
  medical services at Takaka is being reviewed; some work may be more
  appropriately carried out (and funded) in Nelson.
- How can the community participate in rural funding review, especially given low level of rural representation in the health sector governance? AS-D: Not easily; the guiding principle is: "Clinically led and community supported". Big complex debate that has run for 5 years.
- Golden Bay Health Alliance and where it fits into the bigger picture (e.g. Top-of the South Alliance): AS-D: It comprises DHB, PHO and local trust that built the building; it now meets quarterly since the building completed. Very specific focus. Top-of-the-South Health Alliance is trying to establish overall standards, and links upwards to national rural health strategy. RMcD: Takaka facility has a number of contracts for particular services.
- <u>Endorsement of service decisions</u> by Golden Bay Health Alliance--Te Hauora o
  Mohua Trust (GBHA-THoMT) would be inappropriate as it's responsible only for
  bricks and mortar. <u>Action: Followup by CSG</u> (C. McLellan).

#### Conclusion:

Commitment to work together on development of services and facilities, and public information.
