Dear Golden Bay Community Board,

Please strongly encourage Tasman District Council (TDC) to open the new shared recreation facility in Golden Bay immediately.

I know that it does not have its Code Compliance Certificate (CCC). But I also know that the whole complex has been fully open at least twice before. One of the CPU's issued for such an occasion made provision for parking off site. I know that another CPU can be issued using the adjacent A&P land. I know that there is no lease agreement currently in place for this but I also know that TDC knows that this is not a problem. The CPU can allow the new building to be fully used while the grandstand remains in place, until the CCC is issued.

Moving forward, I also know that the car park has been redesigned for TDC, with the grandstand still in situ, providing three more sealed car parks than in the consented plan. I know that TDC can vary the building consent to reflect the changed layout. The cost to amend a building consent is approximately \$260. And I know that TDC knows this too. The CCC could then be issued and the building opened permanently.


I know and you know and TDC knows that the CPU could be issued TODAY.

The running of the Golden Bay Community Centre is of concern. I think it is time for the Community board and the council to take control of the situation. The Recreation Committee have become involved in day to day management instead of governance.

The community is not being consulted or informed and there is no clear information as to what is available and who can hire what, the cost and what conditions of hire are. The lack of a website and newsletters (which other community centres have) is not encouraging of involvement by the greater community.

The plan for covered shelter in the middle of the grounds and removal of line of trees being put to full council with no consultation is an example of poor decision making without consultation. No effort was made to work with the group trying to save our heritage grandstand and every effort has been made by the Rec Centre Committee to be obstructive. The job of the Rec Centre committee is to consult and work with the wishes of the community not to divide community in order to get their personal wishes. Working together when it was realised the grandstand was threatened against the wishes of a large portion of the population could have created at least an understanding of the need to remove the grandstand if that was need. The current committee have done a good job getting the centre established. But personality's and lack of communication and consultation with the wider community are now adding to division in the community.

With options now being considered to relocate the Grandstand and a new structure being promoted by the Recreation centre committee we need to be sure the views of the whole community are considered and the best decision is make.

The current Community Centre Committee are not the right people to facilitate that decision and are not representative of the community. The relocation of the grandstand slightly to the west were the old squash courts are and a bit closer to the grounds could be a good compromise and save the cost of deconstruction and storage.

The Community Board should take the lead and consult whole community.

There also needs to be fresh elections for a Rec Centre committee. Involving the whole community.

Good afternoon Golden Bay Councillors and Golden Bay Community Board,

I just wanted to give you a heads up regarding next steps in our public education campaign around tsunami hazard. You may have noticed a while ago that we released updated tsunami evacuation maps. Next, we are commencing putting up some signage. This is starting in Golden Bay this week, and an example is attached for you to see – these are about A4 size. This follows similar signage put up in Marlborough and other parts of the NZ coastline. We are working with DOC and NCC so that signage and messages are consistent around the coastline. We are supporting this with ongoing public education work, including the recent 'emergency mobile alert' campaign. We also plan to add some more detailed information in places like I-Sites.

Well here we are again, early in the season having problems with dogs on the beach. Most people are very aware they are not to take them down and often stop to read the signs and then carry on with their dogs onto the beach. We live at the Southern end and when we politely let people know their dogs should not be on the beach during daylight saving time we either get ignored, had abuse hurled at us etc etc. Occasionally we have dog owners who take note and don't take offence and take their dogs off the beach. We have a shag colony on our beach, penguins and other wild life which is partly why there is a restriction. Its also not a great beach for walking dogs anyhow. There was a big NO DOGS sign nailed to the board right on the foreshore of the beach but someone of course ripped it off. Could we please have that reinstalled. The other problem is down the other end of the beach (northern side) which we try to ignore, are often many dogs, some owned by beachfront properties, not naming any company who allow their dogs to roam freely. I have seen the dogs chasing birds, and its only a matter of time before a child is attacked. Those that we do tell down our end of the beach to please remove their dogs often say "well look at those other dogs down there allowed on the beach". The dog ranger is very rarely here. 

Grant I am sending this to you to raise at the Community Board because my old Dad in Waiuku is nearly 102 years old and is living at home with my daughter as his carer. I am having to go there to provide assistance and relief at frequent intervals so I am not able to attend meetings as I used to. I have written what follows as if I were able to attend and present it myself to the Public Forum. Please present it for me at the most appropriate part of the agenda, preferably during the Public Forum so that residents present (and hopefully the GB Weekly) will be informed.

FOR THE PUBLIC FORUM. On Wednesday 17 January at Pohara we had 105 mm of rain between 9 am and 4 pm and 157 mm in total during the 24 hours to 9 am Thursday 18th. We had flooding in all the usual places. I took photos at about 4.30 p.m. Rudi from Downers was putting up the health risk toxic signs at the Kohikiko corner and told me that it is standard practice any time it rains more than a shower to expect sewage overflow at that manhole and to erect the signs. The extra water in the sewer can only come from stormwater intrusion into the sewer and Rudi says it is the result of property owners in Pohara Valley and Richmond Road and Bayvista Drive and probably elsewhere sending their excess surface water into their gully traps. He or Downers have recommended to TDC in the past that property inspections be done by council staff to identify offending properties and issue a formal cease and desist order. The response was that there is no money to fund such an inspection. It is ironic that there IS money to put up the signs and clean up the mess.

The photos will show you the situation yesterday during the rain and again today after the rain ceased. On both days the photos were taken at about 4.30 pm. The water spouts issuing from the manhole cover at the rim and at the two lifting holes are about 150 mm high so an extra collar sealed to the existing collar ought to be enough height to prevent any sewage escaping. At present the manhole is in fact higher than the ground which ponds between the road and the fence so the problem is not surface water entering the sewer at the manhole. The problem is entirely caused by storm water entering the sewer upstream and eastwards of Kohikiko corner. A riser as I have suggested should solve the exit of sewage but will not solve the upstream illegal entry of stormwater into the sewer.

Today's photos will convince you and anybody else that this is a public health issue. There is ample evidence of toilet paper at the cast iron lid and ring. There is ample evidence of toilet paper coating the

ground between the manhole and the fence and extending westwards about 30 meters. There is ample evidence of sewage stink. This is at the entrance to our village and to the camp. The locals may have learned to live with it but the tourist visitors will surely see it as a third world situation and not what they came to Pohara to "enjoy." If the engineers decline to deal with it perhaps the health inspectors might be more forceful.

I look forward to a more pleasant situation at that location. Thank you for your attention and your involvement. END OF PUBLIC FORUM STATEMENT.

I'm Jenny, a Project Manager with Engineering Services in Richmond. One of my projects will impact Pohara so I'm working on my Communications Plan. Robyn Scherer suggested I contact you.


The project is called the '4 Winds Pumping Station and Rising Main' and involves building a new waste water pump station next to the Totally Roasted Café, close to the existing one which will become redundant. We'll also dig up the western lane of Able Tasman Drive (western lane) to lay a new pipe from there down to Clifton.

The project should bring benefits to the community e.g. fix pipes that keep breaking, provide more emergency storage, cater for the growing population, increase seismic resilience etc. Approximate timeline is: Tender - Start construction – July/Aug 2018 (3 months construction) Finish Construction — by Nov 2018 — before Summer season.

I'll be doing all sorts of communications in the run-up e.g. visiting Pohara to see local Café/Gallery and Manawhenua ki Mohua, doing articles in GB Weeky, Newsline, Fresh FM, info on our Website, intranet information for customer services, and letters to residents closest to the work.

Can I get your views and advice on best way to inform the community, specifically the Takaka TDC Office and the GB Community Board e.g. if I'm doing a letter drop to the affected residents, could I just copy in Takaka Customer Services and the GB Councillors? Would that be enough – or should I attend a GBCB meeting and visit the Takaka office? Also, is there a report which they receive that I could provide an update for?

To The Tasman District Council and the Golden Bay Community Board-

Re- The Takaka Grandstand and the Recreation Facility

I see from correspondence, that the council has decided to demolish the Golden Bay historic grandstand, and that this decision has been largely determined by the wishes of the Recreation centre committee fighting against local action to save it.

I am a rate payer of 3 big properties in Golden Bay. I pay 3 recreation rates. I have never been asked by the Recreation Centre Committee how I feel about the grounds or what my family uses. We are part of the soccer, and we are regular A&P show participants, etc. There has been no open community conversation about it. Other than the parking, there has never been a single good reason to tear down the Grandstand. In regard to the parking issue, this is a NON issue. As we know that there are some ways around it.

We know that there are many possible solutions other than tearing the Grandstand down. For example-

We could leave the Grandstand where it is for now, and work over a time period to restore it. We could use the money that TDC has set aside for demolishing it, to remove the squash

courts and to restore the stairs. TDC could give a variation to the building consent, for a low cost solution.

We could put the car parks elsewhere- there are many options!

The Recreation Centre committee got an architect to draw up plans for another "grandstand", which they suggested be sited at the end of the field. This thing is a monstrosity- ugly and unsuitable. It would cost \$500 thousand dollars to build, and would require the cutting down of trees, and it would provide no protection from the elements due to the prevailing winds, etc. Our community was not consulted in anyway about this new idea, and it was insulting to me. Do they think we are made of money? We have perfectly good raised/covered seating, that could be a source of pride and sit beautifully by the recreation centre- all that is required is some compromise on behalf of the recreation committee and the TDC. Compromise is possible.

The suggestion that we remove the Grandstand and re-build it elsewhere is ridiculous. It is already sitting in the correct spot, and provides excellent shelter and protection from wind, rain, and sun. It looks good with the new facility, and could be made beautiful and usable very easily.

The Recreation centre committee has not adequately consulted users on their wishes, but claims to represent all users and groups. It has also worked to create division in the community by refusing to engage in conversations with the community and by making false claims about who wants the Grandstand gone, and more. There has been much conflict, and it seems that they are entirely unwilling to shift or compromise in any way.

I believe that the Recreation Centre Committee is actively working against the community at this stage. They are acting in ways that have hurt our community, and it feels to be driven by egos. They are actively punishing the groups who wish to retain the grandstand, by not allowing access to the centre, while allowing other groups full access. They are scapegoating the Save the Grandstand group.

TDC's mayor has said that he wants this over and done with. He is sick of the division in the community. I believe that this Recreation committee is incapable of representing our community properly and I would like them removed and a new committee put in place that can work with the groups. Due to the personalities on the committee, many people have been put off being involved and feel bullied and ridiculed by this group. They seem to have zero goodwill towards those that wish to protect and restore the grandstand.

Please remove the exisiting committee and re-open conversation about what the community wants. It is time to allow full use of the Recreation Centre, until a community decision is made.

Collingwood Stormwater

The residents of Gibbs Road and Swiftsure Street in Collingwood, Golden Bay are being severely affected by stormwater issues and this is an issue that has been occurring for a number of years.

2

A community meeting was held in July at the Collingwood firestation and was attended by almost all of the residents who live at or own properties on Gibbs Rd and Swiftsure St. The submission is a result from discussions at that meeting.

The issues facing the residents are, pipes and culverts that are too small and gravel/ debris build up in the culverts and pipes which means the water flows down the road (which has ditch but the gradient is incorrect) and through people properties. The water causes slips, erosion, flooding, footpaths and road damage.

The flooding has cause major distress for residents, and has affected them financially and emotionally. During heavy rains the local residents have been clearing the drains and culverts themselves to protect their properties and those of their neighbours.

We are aware that repairs are scheduled in the Long Term Plan for 2035 but we believe that this is an urgent matter which needs to be rectified as soon as possible. The Golden Bay Community Board and the residents would like to see the repairs moved up to 2018.

If the repairs are not undertaken soon, then this will have an extremely detrimental effect on the residents. This issue is a constant agenda item at Engineering meetings, and being able to rectify the issues would be a major relief for the stormwater engineers who have some excellent solutions for this major problem.

Dear TDC & GBCB members,

I am asking TDC to put up "no exit" signs on our residential road (Washington St) in Collingwood.

I live at 7 Washington St at the "stopped" end of Washington St next door to where the paper road goes over and down the cliff.

In recent years there has been a very noticeable increase the volume of traffic coming down this short, dead-end cul-de-sac.

This week there has been several "lost" tourists in cars & campervans, furniture removal trucks, and general delivery vehicles all coming down Washington St in the mistaken belief that there is an exit down onto Haven Road below as the "paper road" ignores the 100 foot vertical cliff face in between! Talking to drivers indicates that a major contributor to the problem is that vehicle GPS navigation systems show the paper road as a through way. The problem is further exacerbated by vehicles then trying to find an alternate route down via private right of ways and also through the Ruataniwha Drive sub-division (which is also no exit but is not signposted as such).

Problems caused by this situation include:

- 1. Increased "unnecessary" vehicle traffic on no exit residential roads (Washington St, Ruataniwha Drive, & McDonald Place).
- 2. Increased risk to residents & pedestrians on those roads
- 3. Increased risk to schoolchildren at Collingwood Area School who use those streets for pedestrian access to the school.
- 4. Increased security risk to private property owners at 7, 9, 10 & 11 Washington St) of having uninvited vehicles entering private right of ways
- 5. Unnecessary wear & tear on council roads, particularly in the turning areas at the end of the roads.

Proposed solution

Ideally, it would be great if paper roads did not appear on GPS navigation systems. However, this is probably beyond TDC's ability to fix so the next best option would be to:

- 1. Install a "no exit" sign at the junction of Washington St & Ruataniwha Drive to discourage drivers from turning into the "no exit" end of Washington St, and
- 2. Install another "no exit" sign at the junction of Lewis St & Washington St to discourage drivers from entering the "no exit" subdivision.

I have attached a few photos to highlight the problem. These are:

- 89: the junction & road signage at junction of Washington St & Ruataniwha Drive. No indication
 exists that this is a no exit road despite the stopped end being clearly visible in the background.
- 90: the junction & road signage at junction of Lewis Road & Washington St. Again, there is no
 indication that the right hand turn into Washington St (and then Ruataniwha Drive) is is a no exit
 road. However, this corner is very "busy" with various signs for roads, school, playschool,




- cemetery, & speed limit so a no exit sign here might get lost in sign overload. A better location maybe on...
- 91: a roadside concrete post on Washington St near junction of Lewis Road & Washington St. is a possible alternative location for the second no exit sign

Specifically, a the sentence in the article that the river tribe find the TDC gate protective. Unintended consequence eh and it has fired locals emotions about being stopped from easy access to river close to town.

The local FB page had a post (that's now been removed) that informed us all that the main character interviewed by Nina did not move by choice to the river but as a result of eviction with rent owed. Details were given of his response -which was to egg and urine the place he left so locals are clear what and who they are dealing with.

The Rose family has responded on FB - pasted below. It was part of the removed post however it is relevant for you to read their interpretation of the debate over land ownership. It is the crux of next steps. We know historically it's a funny one and that the TDC lawyers and Rose family lawyers disagree - how do we mere mortals progress this one?

As there has already been TDC letters to Rose family perhaps this sits with staff to follow up in the first instance? I would like to know what court would decide which lawyers are right? I'm thinking TDC needs to advance such a judgement asap.

Beyond FB I have been asked by several Takaka folk seriously concerned it is a shabby shanty town of unsavoury folk - they have concerns about the drugs, sanitary conditions and the mess going into river when it floods. Basically folk don't want this group to remain - and they read conflicting info about ownership so are confused (as I am) to whom will ensure it does not keep growing in numbers. They also feel TDC has lumped this on Roses, made it their problem - they want us to help Roses. Effectively this legal difference of opinion is creating a talking past each other standoff.

You may recall when we passed resolution re gate moving that I noted it was hoped to be temporary - that folk understood we needed to act to change behaviours in the short term but that long term they want it back as a open spot and want the area tidied. This is coming through loudly from the community.

We meet as a Community Board on Tuesday 13th February - seems a long way away now but would be good to tag in your diary to attend - imagine Abbie may wish to add 'Reilly St land ownership' to her chairs report but also hoping it may evolve considerably by then. Kinda think a face to face with Rose family, maybe the lawyers? or some of us elected's can help? (have cc'd Richard as I recall he mentioned being over here for a few days in the New Year, and may have ideas on resolve)

Erin Rose Hello all. They are NOT on farmland and that land is NOT owned by the Rose's. It is Council land. The Rose's have made this very clear to Council - with evidence - via our lawyers - and the Council have not disputed this with us since. Nina Hindmarsh knows this very well and is in regular contact with David... It's most unfortunate that Nina has chosen her incorrect words "....private land owned by a Takaka dairy farmer, David Rose". It seems mischieveous to us. What's more, the Rose farm land along the river is owned by Fran Rose, our mother, and not by David. David is the farm manager. Nina knows this too. Nina also knows that David DOES NOT want them down there. They are a safety risk and have caused significant stress and concern to David and Fran. We would really appreciate a correction by Nina actually, as it's tiresome to have our family name being dragged into this discussion all the time, and then be misquoted by Nina to boot. David is doing his best to help reduce some of the risks down there but it's important for the community to be aware that the Rose's don't have any more power to manage these people than any of the other readers on this page.
