



Hi Emma

Pohara Overflows

What is I/I?

- Direct inflow of surface water into our network or infiltration of groundwater into the pipework, often at joints or through cracked pipes or fittings.
- Typical is between 4 to 6 ADDWF nationally and our design standards are for 6 times ADDWF.

We participate in the annual Water NZ Survey and our most recent results were as follows:

- 1. Brightwater = 5.9
- 2. Collingwood = 5.6
- 3. Upper Takaka = 5.5
- 4. Richmond/Hope = 4.8
- 5. Waimea Basin = 4.5
- 6. Mapua/Ruby Bay = 4.1
- 7. Takaka = 3.6
- 8. St Arnaud = 3.3
- 9. Tapawera = 3.2
- 10. Murchison = 3.1
- 11. Wakefield = 2.2
- Motueka = 2.2 (this is not representative of the level of I/I due to the volume of groundwater entering the system during dry weather)
- Takaka ranks 7 on this list of worst I/I areas, however, there may be catchments within these areas that have high localised effects and this will be part of future investigations.
- Often private laterals are the main cause of both inflow and infiltration as they are not checked or inspected until Council picks up an issue.
- Lack of systems for stormwater causes flooding into WW manholes, adding to the problem.

What are we doing as a Council?

- I/I budget for about 2 years and now have agreement from Council to this to be ongoing
- Rainfall response at pump stations are routinely checked
- In the past house inspections, smoke testing, dye testing have been undertaken in catchments to target stormwater installation or upgrade programmes, where none exist.
- Working closely with Building Consents and Building Inspectors for new builds.
- Inspection ports at boundaries for sewer as an easy check for flows.
- Temperature sensing investigations to track I/I which is a different temperature from sewage and we can identify the exact location of I/I.

Funding priority areas and why?

- Richmond Beach Road overflows industry shut down and manholes overflowing into streets in built-up areas and the estuary. It is also an area of significant growth.
- Motueka next due to high groundwater infiltration, even in dry weather, and significant surface flooding and toilets unable to be flushed in rain events.

 Takaka rain response has been evaluated and it is not enough to be a high priority, which confirms that growth is the key issue and therefore planned upgrades are included in the LTP 2018/2028 (refer spreadsheet).

What are the issues at Pohara?

- Will be some I/I and we will investigate further to identify whether this is a groundwater
 effect or direct inflow from storm events, which may indicate issues at households, following
 which Council will repair its pipes or serve notice on households to repair laterals or make
 good down pipes and gully traps.
- Growth and capacity upgrades required as this has taken up much of the design capacity previously discussed.

Contingency Plans in interim:

- Septic tankers where it is possible to avoid overflows
- SCADA/Telemetry system with Alarms
- Clean up and disinfection after the event is a priority

Plan going forward:

- Inspections of problem catchments
- Staged upgrade of the mains network and pump station
- Encourage property owners to check:
 - o Gully traps are 100-150mm above ground,
 - o Downpipes aren't going into gully traps,
 - o Keep stormwater grates clear of leaves.

The Board, at its December meeting, has asked me to report back on two matters.

- 59 Selwyn St improvement was noted but Mr Harvey Smith still has cages and animals on road reserve? Can you please update me as to whether he has done what was requested of him and if not what the next steps are.
 Mr Harvey-Smith has removed all animal cages and other items from legal road reserve as required to my satisfaction. There are still animal cages on side of the shared access but this is beyond the legal road reserve. I believe that no further action is required in this matter by Council.
- 2) Aorere Valley Rd had a presentation from Mrs Jo Pomeroy. She claimed that the gravel road was severely substandard and dusty. Claims we are using "unwashed grave" because Council does not let the contractor get river gravel (or because the royalty charges are too high). She alleged that other gravel roads were treated with dolomite why not this road because it was well used by tourists? Not sure if you can help me here.

The gravel is 'unwashed' on purpose as is common practise on gravel roads throughout New Zealand and abroad. It's not about river gravel costs at all. In a well performing gravel running course, a range of different sizes, from fine clay particles, all the way up to approx. 30mm is required in order for the gravel to be able to lock together and not be segregated and loose. This is one key component amongst other qualities. A running course gravel with good particle size distribution is always going to be dusty when very

dry. Dolomite based gravels are generally a premium priced product and treating large lengths of the road network would be cost prohibitive.

Thanks for the opportunity to give some feedback as to how the TDC facilities are coping this busy visitor season.

The short answer is that they are not coping.

There was no consultation with us regarding how the existing facilities were coping. There was it seems some last minute...a few days before Xmas provision of extra facilities. One Big Belly Rubbish Bin and two Portaloos for Waitapu Bridge. The same for Taupata Pt.

Chris from GB tanks is emptying these at least every second day. We are cleaning these toilets and emptying these Rubbish Bins twice a day.

We need to double the number of Big Belly bins provided in The Bay as soon as possible. On any given day we can provide photographic evidence of the bins not coping...namely a pile of Rubbish surrounding the bins when we go to empty them . The other issue with the Big Belly bins is that they don't lock when full which means they get too heavy to

safely empty without us removing by hand some of the weight of the bin before we can pick up and remove the Rubbish.

As mentioned above we also need to double the number of Big Bellys at Willow St. 2 needed beside Toilet Block next to the recycling bins. On a daily basis you can see visitors to The Bay walking around the toilet block looking for a Rubbish Bin. It would be logical to have a couple of bins beside the recycling. Another point is there is no Paper/Cardboard recycling in these areas.

We(Nelmac) have found it difficult to keep up with servicing the toilets and Rubbish around The Bay this Summer season.

We are looking at employing an extra worker for four months Dec-Mar to keep the standard of maintenance of toilets/Rubbish up to an acceptable level.

We need TDCs support in implementing these improvements to essential facilities and services in The Bay.

I almost forgot to mention we also need at least another two options for designated Freedom Camping in The Bay

Thanks for your time.

I hope my feedback didn't come accross too negative !

Visitor numbers will keep on increasing in The Bay as word gets out about our beautiful part of the world.
