My name is Sara Chapman and I am the current Chairman of the community organisation known as GBSRF which is a coalition of clubs and groups under the Incorporated Society umbrella of the Golden Bay Shared Recreation Facility.

I have been attending Community Board meetings for four years to keep board members, Councillors and public attendees informed of progress with the construction and operation of, and fundraising for, Rec Park Centre.

While GBSRF is contracted by Council to manage Rec Park Centre and to organise recreation programmes and community events, and under those contracts are required to formally report to the TDC Community Development committee when invited, we have always chosen to address this board with updates. In September, Laura will address you at the final Community Board meeting.

Golden Bay Recreation Park is complicated because it is reserve land with the users spread around the park. There are buildings owned by TDC and there are a number of buildings that are not owned by TDC but situated on the reserve land. And now there is Rec Park Centre which is a public facility owned by TDC and managed by GBSRF. GBSRF is the PCBU for this building and the land around the immediate footprint.

GBSRF is not the Recreation Park Committee and it has become evident that even though you are elected representatives you may not be clear of the difference between the Centre and the Park.

Please allow me to explain.

Golden Bay Recreation Park is under the authority of Tasman District Council and Golden Bay Community Board and falls within the Community Development portfolio. There are two separate strands, the Centre, which nominally includes the outdoor Netball Courts and the Reserve and Fields.

Let us follow the first thread.

GBSRF holds the Facility Management Contract and the Recreation Contract. The governance board is responsible for legal, financial, audit and risk, health and safety and employment policy. The User Council comprised of eleven representatives from our member clubs and groups is responsible for operational management working directly through our two key staff. Our constitution established a seat for a Golden Bay ward councillor ex-officio on the board with the Golden Bay Chair ex-officio on the User Council. These seats are reserved and occupied at your discretion.

The contracts enable us to employ two permanent part-time key staff, one for each contract and together they approximate one Full Time Employee. The TDC staff of Martin Sutton and Lani Evans deal directly with Laura and Abbie.

And because our staff maybe on-site when Glenn Thorn visits, he talks to them.....BUT Recreation Park is under a different Council thread. Starting with Parks and Reserves to the Recreation Park Committee of Roger Tait, Noel Baigent, Wayne Packard and Kevin Winter, with input from User Council (Park Users only) which is A&P, Football, Rugby, Cricket and Tennis.

This is the actual organisation structure. As you see GBSRF has a limited but defined role. Outside of governance, the board volunteers continue to fundraise for ongoing resources for clubs, groups and the community. In the last two years the board has raised an additional \$95,000 which has been invested in community assets.

The bare truth is that the Centre is run by our Golden Bay GIANTS. And that is the way it should be.
