N-Cap reporting

Create and submit your nitrogen report using HawkEye.

From July 2022, all dairy farms must provide their annual nitrogen (N) use for the year, from 1 July to 30 June, to their regional council.

How do I get started?

- Check your farm map is accurate and complete.
- Add **exclusion zones** for areas you don't want to spread any fertiliser.
- Record your nitrogen fertiliser applications inside HawkEye. GPS tracked fertiliser proof of placement can be provided by Ravensdown Joint Venture spreaders¹, your TracMap guided² spreading contractor and GPS enabled C-Dax controllers. You can also manually record where you have spread fertiliser.

Once you have your nutrient usage recorded for the year, you can create your nitrogen report with a few simple steps in HawkEye.

Creating your Nitrogen Report

- Go to Reports > Nitrogen Reports
- Click **Create** to make your landholding. This is a contiguous land area (area of adjoining land) being farmed that you will use to report your N use. You can create more than one landholding if you have non-contiguous areas on-farm.
- Enter your **Farm name**.

- Enter your NZ business number.
- If you do not have one or wish to apply for one enter 0000.

¹Mainland Spreading require the TracMap add-on for proof of placement data to be available in HawkEye.

- Select your **Dairy company** from the list.
- Enter your Dairy supply number.
- Select the paddocks and or management zones from the map or list. Exclude any ineffective areas such as laneways, houses, and dairy sheds.
- Select your Regional council(s).
- If your farm crosses regional council boundaries, select both councils.
- Update the **Area** of the farm to your full title area including any lease land.
- Click **Save.**

Create a New report

- Select New Report.
- Select the **Reporting year** from the list.
- Enter your **Contact details.** This should be the person on farm responsible for the nitrogen report.
- Click Save.

Assign land categories

- These define how your land was used during the reporting year. The categories are:
- ◊ Grazed pasture
- ♦ Grazed forage crops
- ◊ Grazed harvest crops
- Our Output Ou

An area can have multiple land categories assigned over the year and you can assign land categories to multiple paddocks at once.

HawkEye N-Cap Reporting



- Select the paddock(s) from the list or map.
- Select Assign.
- Select the Land category from the list.
- Change the **Date ended** if required
- For single categories, the date range is automatically defaulted to the reporting year.
- Click **Add** to assign a different land category in the same reporting year.
- You can add as many time periods as required.
- Add any **Notes**. These are for your reference and will not be sent to council.
- Click Save.
- Once all paddocks/management zones have been assigned you can generate your nitrogen report by selecting Generate report.

The Nitrogen Report

The nitrogen report consists of three parts. The N report, a product report, and a sales report.

N Report

The N report shows the hectares, total nitrogen applied and kg N/ha/yr for each land category and overarching category.

The information required for council is the kg N/ ha/yr and total hectares for grazed land, grazed forage, grazed non-forage (sum of grazed pasture and grazed harvest crop*) and ungrazed land. Grazed pasture and grazed harvest crop figures are supplied for your reference.

How does the calculation work?

HawkEye will look at all nitrogen-based applications for the reporting year and allocate them to the correct land category in the given time ranges. It will then calculate the total N applied and average kg N/ha for the year for each land category. It will also give an overall figure for the grazed land.

The Product Report

The product report provides a list of the products applied, the dates of application, and the N% in each product. Rates are not included

- Select **Submit report** from the Land category page or the Report page.
- Check your landholding and reporter details are correct. They can be edited at this point before being submitted.
- Select Yes if you have complied with the 190kg/N/ha limit on grazed pastoral areas.
 Select No if you have exceeded the 190kgN/ha limit on grazed pasture.
