#### 4 DECISION REPORT

#### 4.1 Tasman's Great Taste Trail Bylaw - RESC12-08-02

The Development Engineer, Dugald Ley, spoke to his report which was contained in the agenda.

The report provided a summary of a proposed Bylaw that would support the successful operation of Tasman's Great Taste Trail. The intended bylaw will allow activities on the loop trail to be controlled so as to prevent nuisance to other users.

An amended proposed Tasman's Great Taste Trail Bylaw 2012 was tabled by the Development Engineer who outlined the amendments.

The following points were made in discussion on the proposed Bylaw:-

- General Trail bylaw enforcement
- Enforcement of the bylaw where the Trail is on private land
- Bylaw not containing signage rules
- Spraying regimes of businesses close to the Trail was not included
- Spooner's Tunnel
- How the Tasman District Council and Nelson-Tasman Cycle Trails Trust could generate income from the Trail.

To a number of questions regarding the maintenance costs of the Trail, the Development Engineer advised that a full report would be tabled at the next Engineering and Services Committee meeting on this matter.

#### 6 DECISION REPORT

#### 6.1 Budget Reallocation - Utilities (Solid Waste) - RESC12-08-03

Utilities Asset Manager, Jeff Cuthbertson and Utilities Asset Engineer, David Stephenson spoke to the report which was contained in the agenda.

The purpose of the report was to seek approval to reallocate capital budgets and approve additional funding for the Solid Waste activity for the 2011/2012 financial year.

Committee members raised the following concerns regarding the Richmond and Mariri Resource Recovery Centres' over expenditure of \$699,298:-

- Staff were requested to explain why this happened and how long ago it occurred
- Who provided Council with the ground work advice
- If the over expenditure had been taken up with Audit NZ
- How this over expenditure is to be paid for
- Alternatives if the resolution is not passed
- Committee members advised staff that they would have appreciated hearing about this shortfall earlier.

Committee members felt this was a funding mechanism issue that needed addressing. The Utilities Asset Manager advised that the funding shortfall had been accounted for in the Long Term Plan.

#### 7.1 Transportation – Annual Report - RESC12-08-08

The Transportation Manager, Gary Clark, spoke to his report which was contained in the agenda.

The Transportation Manager's report covered the following matters:-

- Operations and Maintenance
- Assessment of Pavement Asset Condition and Performance
- Contractor Performance
- Road Safety
- Rivers
- Budgets and Expenditure.

Committee members discussed the following matters:-

- The inconsistency used over the road delineation policy. The Transportation Manager advised that road safety is what the Tasman District Council is focussing on. When road markers are taken out, this slows driver speed and this in turn reduces the severity of road crashes.
- Committee members requested a list of rural roads currently affected by the road delineation policy.

- McShane's Road was given as an example of a high volume road that has major issues on wet days.
- An article in Council's Newsline was suggested to get Council's message across regarding the road delineation policy.
- Staff were requested to investigate, and advise, just who it is that is crashing on Tasman's rural roads?
- Staff were requested to let river users know, via Newsline, that the draft river maintenance programme for the 2012/13 year is available on Council's website.
- Street Lighting. The Transportation Manager advised that throughout the District standard street lighting poles are replacing the older ones and that LED lights are going in.

The report set down the need for Council to review its existing Transportation Bylaws from time to time to comply with the Local Government Act 2002. Transportation bylaws managed under Council's Engineering Department include:-

- Speed Limit Bylaw 2004
- Traffic Control Bylaw 2005
- Stock Control and Droving Bylaw 2005.

Committee members asked if it was possible to amalgamate advertising the three bylaws outlined to avoid 'consultation overload' and were advised that this was a good idea and would be actioned.

Cr King requested a simple and straightforward Stormwater bylaw and was advised that staff were already looking at this.

#### 7.4 Port Motueka - Jackett Island Erosion Project - RESC12-08-07

The Transportation Manager, Gary Clark and Transportation Planning Officer, Sarah Downs, spoke to the report which was contained in the agenda.

The report provided information on the assessment and refinement of practical options to manage the erosion experienced along the seaward edge of Jackett Island. An update on the interim works on the Van Dyke property and the Port Motueka Groyne removal was also provided along with details of expenditure to date on the Jackett Island Erosion Project.

The Transportation Manager advised that the van Dyke's had lodged another case against the Tasman District Council to the Environment Court.

The Engineering Manager outlined the expenditure and budget for this project to date and recommended the Committee go back to Corporate Services staff requesting they initiate investigations on funding sources for the Project (including the insurance claim and the Port Motueka Endowment Fund). He then gave Committee members an approximate timeline of events yet to be addressed.

Committee members questioned if Council could afford to undertake any of the options they will soon be given by staff. The Transportation Manager replied that Council's mandate was to find a practical and affordable solution.
