### 3. Notes of last meeting – 8 February 2022

The record of the meeting from the 8 February 2022 meeting was accepted as a true and correct record.

### 4. Matters Arising (Action Log)

- *Circulate programme for Grossi Point Plan* Completed, sent by email Dec 2021.
- Confirm road marking signage works complete Sealing done but no marking as yet, Richard Hollier to follow up with the Roading Department.
- Confirm if Barney Thomas is appropriate representative of the group to coordinate iwi engagement for pou at Ngaio Park – David Loe noted that Barney Thomas had offered to do this.



- Check Ngaio Park boat steering wheel for damage Richard Hollier confirmed that this had been replaced and stolen again. Stephen Richards is organising a replacement from the MenzShed.
- Check with bookings calendar administrator and advise process and permissions Richard Hollier advised that bookings are approved by his team, the concert was on during the afternoon and did not go late. David Loe said it was on the overflow carpark and that it had been agreed that residents were to be notified. Additional Notation Richard Hollier: Concert was moved from Waterfront Park at organisers request in order to accommodate Covid-19 social distancing and numbers limited to 100 people. Notification had been overlook but would be done in future.

### 5. Masterplan 1-5 year progress review and plan of works – ....

Discussion on priorities in Masterplan and how the different areas in the plan work together. Andrew Butler updated on engagement of Davis Ogilvie to undertake investigations on boat ramp.

## 6. General Business

**Grossi Point** – Discussion about moving forward with the development of the Cultural Heritage Plan for Grossi Point. Amai Thompson outlined the iwi lack of capacity and resourcing issues. He suggested using the TDC kaihatu to facilitate discussion on moving forward and involvement of the other iwi. Amai will talk to other cultural managers and Barney Thomas and come back to Richard Hollier with an approach. In response to a question from David Loe about the name for Grossi Point, Amail talked about the protocols for the naming of areas and layers of occupation at Māpua and other areas. He stated that Māpua had been a former battleground and there were a number of *Urupā* around the Māpua area. It was a difficult area to deal with as each iwi have their own views and these may differ from other iwi.

**Meeting attendance –** there was a short discussion about the lack of attendance at the last two meetings. David Loe undertook to remind attendees by email 24-48 hours ahead of meetings as he had done previously.
