3 Matters Arising from the Minutes

Nelson Tasman Housing Trust

Mr Patrick Steer advised that Contractors had supplied the information required to progress the building consent for the Brook Street project.

Homelessness

Cr Ian Barker raised the issue of what is the reality in the Nelson Tasman region of people with no housing. A definition of the word 'homeless' was discussed and those who fit into this category. All agreed that quantifying homeless people in the region was very difficult.

It was agreed that Rev. Peter Norman, Motueka, Mr Edward Andrews, Male Night Shelter and Ms Jill Knight, Salvation Army would be invited to the next Nelson Tasman Housing Forum meeting to discuss this matter in an Agenda item entitled – Homelessness in Nelson Tasman.

Discussion then turned to the difficulties property investors experienced with local Councils and other Government agencies in respect to Acts, regulations, building consent applications, the RMA etc.

It was agreed that the Nelson Property Investors Association should hold talks on a regular basis with local members of WINZ/CYFS regarding issues with their rental clients and rent by re-direction.

4 Agency Updates

Abbeyfield New Zealand

Mr Chris Armstrong advised that Abbeyfield New Zealand:

- Are still negotiating with the Christchurch City Council regarding obtaining land at Hornby
- Had an unsuccessful Niche funding application
- Had an unsuccessful Growth Fund application.

Nelson Tasman Housing Trust

Mr Patrick Steer advised that Nelson Tasman Housing Trust:

- Also had an unsuccessful Niche funding application
- Was awaiting news of an application to the Growth Fund.

9.15 am: Mr Dale Bradley, Housing New Zealand arrived

Nelson Property Investors Association

Mr Glenn Morris advised:

- That 1,256 rental bonds had been lodged in the urban area in the past twelve months
- That Nelson currently has a rental vacancy rate of 1.3% compared to 2.9% in Auckland
- That property investors are currently not buying due to a depressed market
- That the next Nelson Property Investors Association meeting is on 24 February 2012 at the Suburban Club. They welcome people to come and speak at their meetings.

Nelson Marlborough District Health Board

Mr Les Milligan advised that the project 'Ageing in Place' aims to keep the elderly in their own homes.

Tasman District Council

Ms Francie Wafer advised that the Tasman District Council:

- Had let its first tenant into the new Aotea Place cottages
- Has a budget for the next financial year to place more heat pumps into their existing rental units.

Housing New Zealand

Mr Dale Bradley advised that Housing New Zealand:

- Have 1 person in its Category A high category
- Have 16 people in its Category B Significant category
- Have 5 people in its Category C category
- Have 3 people in its Category D category
- Is currently undergoing a restructure and is about to recruit new staff
- Holds tenancy reviews every three years with its tenants.
