### 1. PUBLIC FORUM

Mr C Robinson asked where balance sheets for the ASB Bank Aquatic Centre costs could be obtained. He questioned who is policing the parking adjacent to Salisbury Road. He spoke about the lack of carparking spaces along Talbot Street in Richmond and sought a copy of the traffic count carried out in Talbot Street in recent weeks. Mr Robinson raised concerns about the sale of Webby Place, Richmond, for Richmond Mall carparking.

Ms S Worthington read a statement for the Motueka Community Pool Committee regarding the proposed Motueka Pool Complex. That Committee sought further details on the proposed pool costs and associated information and sought Council's endorsement for this project.

Mr P Lyons sought Council's approval to operate his coffee vending business at Pupu Springs carpark and outside Totaranui Camping Ground. He referred to letters of support and a petition of up to 800 signatures in support of his operation.

Mr Bell commented on the Golden Bay Community Board submission and said that it had taken five years for legislative changes to occur and said that the warrant system guidelines must be interpreted using appropriate commonsense logic in their application.

# 6. TRADING IN STREETS AND PUBLIC PLACES BYLAW – DISPENSATION REQUEST, MR P LYONS

Mr Lewis spoke to his report of 6 December 2005 contained within the agenda which advised that Mr P Lyons is the owner operator of a mobile coffee shop known as Coffee Pirate and he has lodged an application for dispensation under Section 13 of the Council's Trading in Streets and Public Places Bylaw.

Mr Lyons has requested Council to remove the siting restrictions under Chapter 6, to permit him to operate on the Te Waikoropupu Springs carpark and the Totaranui Road Reserve.

Mr Lewis said that the Department of Conservation is opposed to the application by Mr Lyons.

Cr Riley said he could not see why Council can't consider the use of the Totaranui Road Reserve by the applicant.

Cr O'Shea suggested the use of a review process and timeframe.

Mr Lewis expressed some concern about traffic safety if this vehicle is parked on the narrow Totaranui Road.

Mr Lyons advised that there is a grass area just outside the Department of Conservation gate at Totaranui.

Cr Norriss suggested the two year review period and supported the Totaranui Road Reserve proposal.

THAT Mr P Lyons be granted a dispensation to operate his Coffee Pirate business at the Te Waikoropupu Springs carpark and the Totaranui Road Reserve providing a suitable safe location is available, for a two year period. CARRIED

### 7. REGIONAL ALCOHOL STRATEGY

Environmental Health Officer D R Lewis spoke to Council about the Regional Alcohol Strategy which is due to be released early 2007. He said that Councillors will be provided with the draft strategy and spoke about the potential for changes to licensing hours.

### 8. RURAL FIRE NETWORK PRESENTATION

Representatives from Rural Fire Network, Tom Broderick, Chris Milson, Robin Thomson and Doug Ashford spoke to Council about the work of Rural Fire Network on behalf of Council in regard to fire control in the open and the fire permit system.

Mr Milson spoke about the positive effects of the upgrading of the rural fire depots at Appleby and Ngatimoti and the programme to progressively replace fire appliances.

### 9. PROPOSED MOTUEKA SWIMMING POOL

Community Services Manager L Kennedy spoke to his report of 6 December 2005 contained within the agenda. The report said that the LHT Limited feasibility study and concept design attached to this agenda showed an anticipated estimate of up to \$5 million building costs based on that design for the aquatic centre.

Mr Kennedy's report suggested that the local contribution would be 20% of the total cost with the remainder funded through council sources and annual operating costs could be met by a special rate over the Motueka Pool rating area.

Cr Norriss asked if there was more than one concept plan and what other options had been considered.

Mr Kennedy referred to other options which had been considered and referred to the Pool School upgrade.

Cr Wilkins said that one option is wanted by the public otherwise the support of the Motueka Community Pool Society Committee may be lost.

Cr Inglis said that the ratepayers must be polled and questioned if the Motueka ratepayers think they can raise the necessary 20% contribution.

Cr O'Shea said that Council must go to the community with the true costs and the potential rise in the community rate would be district wide.

Mayor Hurley said he was concerned that the project may be lost to Motueka if it is not presented clearly to the Motueka community. He said that the project cost continues to grow and it is currently a very loose proposal. Mayor Hurley said the matter was required to be passed back to the Community Services Manager for a definite proposal.

THAT Council does favour having a poll regarding the Motueka proposed aquatic centre subject to staff coming back to Council with more definite project costs and alternative funding, either or both a facility rate and

development impact levies. The properties to be polled are to be defined and consideration be given to the feasibility of the school pool upgrade.

# 10. KAITERITERI FORESHORE ROAD RESERVE – PROPOSED DEVELOPMENT BY KAITERITERI RECREATION RESERVE BOARD

The Engineering Manager P Thomson spoke to his report of 8 December 2005 contained within the agenda which was accompanied by aerial photos of the north end of Kaiteriteri Beach, a letter of 16 November 2005 from Kaiteriteri Recreation Reserve Board together with a site plan.

The Board wishes to complete its foreshore redevelopment involving new beach perimeter fencing, footpath, kerb and channel, sealed roadway and sealed western side angle parking from the Boat Ramp northwards to the Lucas boundary. The last 28 metres of this fence, to the Lucas boundary, is on legal road and requires Council consent.

The Chief Executive said the public has the right to travel along a legal road, unimpeded, but questioned what would happen if the legal road was stopped. Staff would welcome time to investigate that proposed road stopping.

### 11. TRANSFER OF FOUR WHARVES IN GOLDEN BAY

Mr P F Sangster spoke to the Council about a proposal for a Charitable Trust to accept the ownership for the management and responsibility of wharves at Milnthorpe, Mangarakau, Waitapu and Collingwood. These wharves are all located adjacent to reclaimed land and Council had resolved in 2003 to no longer maintain or administer these four wharves.

The report in the agenda listed the proposed Trustee members and was accompanied by a copy of the draft trust document.

The Chief Executive said Council discovered these wharves belonged to the Department of Conservation and had the adjacent reclaimed land is unalienated crown land.

Cr Riley said the community is concerned about the lack of information on the proposed trust and is unsure what it is.
