#### 4 ARANUI PARK

Council's Reserves Manager, Mrs B Wilkes, was in attendance for discussion on this item.

Mrs Wilkes said the recommendation put to the Community Services Committee on 20 February 2007 was to accept option 3, which was to "carry out the proposed development of Aranui Park with the altered accessway and car parking as per the plan dated January 2007". That option would provide off road parking, provide views of the park and plantings, provide an open car parking area visible to Aranui Road, prevent vehicles getting into the rear of the park, keep the rear of the park quiet and peaceful, reduce any future impact of increased usage by vehicles by limiting the car park area to four vehicles only and provide formed car parking outside the entrance to the park.

Mrs Wilkes said the area between the driveway and Church would allow parking, and mounds, bollards and plantings would prevent vehicles going into the rest of the park, but vehicle access would be available for caravan club, maintenance vehicles etc.

Cr Higgins reported on what Mr Sharman and Mr Thawley had said at the public forum at the Community Services meeting and as a result was persuaded to support option two which provides an accessway into the centre of the park.

Cr Inglis said he would support the amendment on condition there was a barrier that keeps vehicles to the roadway.

Cr O'Regan said Cr Higgins case was a fair exposition of what we heard at the Community Services meeting.
