1.0 PORT NELSON SHARE BUY-BACK SUBMISSIONS

1 Timberworks Ltd

Mrs Sonya Denny was in attendance to present the submission on behalf of Timberworks Ltd. She sought funding for three shelters to be built at Rabbit Island to provide sun/rain protection for visitors. These shelters would add to the aesthetic charm of Rabbit Island while at the same time being eco-friendly and giving Tasman District a distinctive feature.

2 Penny Griffith

Ms Griffith asked that funds be used for the Nelson Provincial Museum building to house collections, professional staff and research users. She also asked that improvements and a walkway be constructed at the Collingwood inner harbour.

3 Peter Besier

Mr Besier asked that funds be used for the repair of the sea wall at Port Motueka.

4 Hope Community Church

Mr Donald Irvine and Mr Hudson Malcolm were in attendance to present the submission on behalf of the Hope Community Church. They sought a grant of \$141,000 from the Port Nelson fund to fund part of the projected shortfall of \$361,000.

5 Holy Trinity Church

Mrs Sonya Denny and Mrs Marie Tilley were in attendance and sought funding of \$873,000 for the Friends and Fun creche playground, redevelopment of the hall, maintenance of the Holy Trinity Church building, assistance with staff funding, upgrading of sound system and purchase of a photocopy machine.

6 Hope School

Mr David Pritchard, Principal of Hope School, was in attendance to speak to the submission from Hope School. The school sought \$21,234 for laptops, \$1,630 for a camera, tripod and headphones and \$10,200 for teacher aid costs.

7 The Nelson ARK

Karen Howieson was in attendance and spoke on behalf of The Nelson ARK. They asked that the building at 25 Oxford Street be moved to the property at Sandeman Road to provide office, indoor toilet and washing facilities at the proposed dog pound site, reducing construction costs of the new facility.

8 The Loop

Mr Charles Newton and Mr Geoff Scrimgeour were in attendance to speak to Council. They sought funding of \$164,149 to connect schools to The Loop. The Loop is a Nelson/Tasman-based schools project using the fibre loop provided and owned by Network Tasman Ltd to provide high-speed broadband connectivity to local schools.

11 Richmond Rotary Club

Mr Nigel Barak was in attendance to speak to the submission on behalf of the Richmond Rotary Club which sought \$10,000 sponsorship for the Brightwater Wine and Food Festival.

13 Warren Iggo

Mr Iggo was in attendance to speak to his submission. He asked that funding of \$80,000 be used to form an accessway from William Street, Collingwood to the launching ramp and for parking and recreation.

14 Dennis Win

Mr Win was in attendance and asked Council to pay back debt from the Port Nelson Share buy-back fund and to add to the Disaster Fund.

30 Golden Bay Community Board

Mr J Bell, Chairperson of the Golden Bay Community Board, was in attendance to speak to the submission made on behalf of the Board. The Board said that as the funds are currently earning more on deposit than the current cost of Council

borrowing, the funds should remain on deposit until this situation reverses and then used for debt reduction.

9 – P Harrington - asked for a Feasibility Study into public transport in Nelson – Richmond area

10 – Nelson Tasman Forest and Bird Society - support expenditure for ensuring strong environmental gains are made.

12 – David Richards - supported funding for the Headingly Centre

15 – Nelson Championship Committee - Requesting sponsorship of \$8,000 for hosting National NZPCA Horse Trials Championships

19 – Jennifer Thomas – supporting a performing arts centre

20 – Nelson Province Federated Farmers – Debt reduction

21 – Fraser Aitken – retain in entirety to fulfil and continue the "spirit of intention" to create a revenue stream and an appreciating asset for Council and the region, eg have discussions with Transit NZ and other progressive investors, with a view to commencing the Motueka bypass and new bridge.

40 – C M S Sutherland – supported money being used for Millennium Centre; Tasman Bays Heritage Trust, Nelson School of Music, Bishop Suter Art Gallery, Theatre Royal

41 – J & M Anderson – Form Tasman District Charitable Trust and invest to generate income to be used for establishing sporting and cultural facilities. Debt reduction on pro-rata basis to all TDC Wards.

45 – Garrick Batten – Hold amount as investment against debt liability in port subsidiary; debt reduction; funding part of projected debt increase for 2007/2008

46 – Peter Wilks – debt reduction

47 – Martin Conway – set aside for special project, eg Millennium Centre

48 – Tasman Aquatic Multisport Development Trust – development of flat water multisport course at Rabbit Island

49 – Motueka Community Board – debt reduction and balance invested long term

54 Community Action for People and Planet

D Eddy was in attendance to speak to his submission which asked that money be invested in a feasibility study on public transport and bus trial to link outlying and urban areas in the district.

16 Art Dol

Mr Dol was in attendance and requested Council to spend the money wisely and noted problems surrounding peak oil, climate change, peak water, peak food, over population, bio-diversity etc.

17 Headingly Centre

Mr Ken Polglase was in attendance and spoke to the submission submitted by Headingly Centre which sought funding to cover the cost of the alterations deemed necessary to meet community use.

56 Tarakohe Harbour Advisory Committee

Mr Merv Solly was in attendance to speak to the submission on behalf of the Committee. The Committee submitted that as the Port Nelson buy back fund has been generated from port related activities, it would seem appropriate to use it to reduce debt at Port Tarakohe and fund future development as listed in their submission.

23 Port Tarakohe Ltd

Mr Bob Butts was in attendance to speak to the submission on behalf of Port Tarakohe Ltd. Funding is needed for building facilities at Port Tarakohe to turn the harbour into a fully functioning commercial/recreational port. Funding is also needed for a management plan and business plan. Investing in hard infrastructure and retiring debt is a prudent use for this dividend.

18 – M Hewetson, Motueka Lumber Ltd – funds should be applied to various medium and long term facets of growth management.

50 – Nelson Millennium Centre Trust – supported Performing Arts and Conference Centre

51 – Nelson Tasman Chamber of Commerce – Debt reduction to enable funding of Economic Development Agency and Latitude Nelson. Bring forward capital works in LTCCP

52 – Golden Bay Futures – 50% to reduce debt; 50% subsidising sustainable selfreliant technologies at household level, such as solar hotwater and power local sustainable industries, micro-credit scheme for community investors in sustainable technologies 53 – Bearing and Engineering Supplies – carefully managed and used alongside Council's annual plan in providing infrastructure for growth
