7. APPROVAL OF PARTS I AND II, TASMAN RESOURCE MANAGEMENT PLAN FOR OPERATIVE STATUS

Policy Manager, G S Markham, spoke to his report of 27 August 2008, contained within the agenda, which recommended approval of Parts I and II of the Tasman Resource Management Plan (TRMP) and an operative date of 1 November 2008. Mr Markham explained that because of the content of these two parts is the subject to a number of current variations, the provisions affected by these variations cannot be approved and made operative yet. He said that these must remain as proposed provisions within the operative parts until the relevant processes are completed. Mr Markham explained that making the plan operative, makes change requests possible. He said that the Council still has to resolve the topics of cultural heritage and landscape issues.

Mr Markham said that the TRMP had been developed over a period of 12 years from May 1999. Cr Higgins commended Mr Markham on his work concerning the development of the TRMP saying that he was very appreciative of Mr Markham's work and referred to him as always impeccably professional. Crs King and Riley endorsed Cr Higgins remarks and extended their appreciation to the Environment and Planning Manager, Mr Bush-King, and the Policy Planning team.
