1 UNIFORM ANNUAL GENERAL CHARGE

Mr Staite spoke to the report contained in the agenda which considered the level of the Uniform Annual General Charge (UAGC) to be included in the 2009/2010 Funding Impact Statement and 2009 – 2019 LTCCP.

Cr Higgins expressed concern about the impact of increased UAGC on lower valued properties. He supported leaving the UAGC at \$220.

Cr Currie concurred with Cr Higgins. He said farmers can claim rates through their tax whereas the ordinary householder cannot.

Cr Inglis also concurred with Cr Higgins. He said people are really struggling and this would just add more burden to them.

Cr Riley reiterated that people are struggling and did not support the increase.

Cr Glover said it affects the poorer people and would not support the increase.

Cr King said people right across society are struggling. He supports the \$20 increase to the UAGC.

Mayor Kempthorne supports the increase to \$240, especially for the pastoral farmers who are facing huge increases in rates this year due to the revaluation process.

Cr Ensor said land prices are incredibly over-valued and have no relationship to productive value of farms. He does not support an increase in the UAGC.

Cr Norriss said rates and charges are supposed to be for services provided. He said because someone lives in a low-valued area in town, doesn't mean to say they are poor. While there is a tax deduction for farmers, in most cases there is a huge mortgage which isn't taken into account. He supported the increase.
