The plan will be advertised over the Christmas period so holiday makers can make submissions to have input into the plan.

3. REPORTS

3.1 Community Services Chairperson's Report

Cr O'Shea reported on the Motueka High School prize-giving. She also commented on the attendance at Motueka Arts Council workshops and the huge range of courses they run.

Cr Henry said the Motueka Arts Council receives financial support through the Creative Communities scheme and they do a great work.

Cr Henry said National Council of Women organised an information evening for people who may be interested in local government prior to elections. She suggested Council arrange information meetings prior to the elections next year. Such meetings to be held in the wards for people who may be interested in standing for Council.

Mayor Hurley was concerned about the high degree of ignorance as to how local authorities work and said we need an educational programme. He noted the degree to which Tasman District Council participates with Nelson City Council is not well known.

5. LARRY CHING - WAIMEA COLLEGE - EDUCATION FOR ENTERPRISE

Mr Ching, Principal Waimea College spoke on Education for Enterprise. It is based on a single issue – making schooling and learning more relevant for children. He asked for Council's support for this endeavour.

Mayor Hurley thanked Mr Ching for addressing Council on the Education for Enterprise initiative.

Cr O'Shea said she would like to hear from Mr Ching on achievements in this scheme.

6. RICHMOND CITY SOCCER - PHIL WHITLEY

Mr Whitley gave a powerpoint presentation and asked for a commitment from Tasman District Council to work together with Richmond Soccer to provide facilities that meet the growth and service requirements of the Region. He pointed out the last season the Club had approximately 780 players and this could grow to 1,000 next year.

Richmond Athletic AFC propose:

- the development of a multi-purpose facility at the Avery Sportsfield
- an estimated investment of \$1.8 million plus GST
- a financial partnership of 80% Tasman District Council and 20% Richmond Athletic AFC

Mr Whitley said Richmond currently owns its clubhouse and would be keen to own the new clubhouse and administer it on behalf of any community group that wishes to use it. He said the academy caters for children from age 4 through to representative senior soccer.

3.2 Proposed Exchange of Land – Jubilee Park, Richmond

Mr Kennedy spoke to the report from the Manager Property which was to consider a proposal to undertake an exchange of land pursuant to the Reserves Act 1977 at Jubilee Park, Richmond.

THAT the proposal to exchange part of the land known as Part Section 100, Waimea East District for part of the land in Part Section 104, Waimea East District be notified as a proposal to exchange land in accordance with the

provisions of the Reserves Act 1977 and that Crs Currie and Kempthorne be appointed to hear any submissions to the proposal and be delegated authority to make a recommendation to the Minister of Conservation on those submissions.

3.3 Reserves Manager's Report

The report was an update on capital projects and items of interest.

In response to a question from Cr Higgins, Mr Kennedy said there is an issue with the Old Mill Walkway where there are two hard surfaces at each end being the two seawalls. He said staff would like to try some spinifex planting on a shingle beach like that to see how it would work.

Cr Higgins considered the hard surfaces were not very significant and was of the view that reserves staff should be taking a firmer stand on the issue if they want the walkway to look attractive. He would like to see them having more detailed discussions with Engineering staff.

Cr Currie said at the Richmond "Meet the Councillors" meeting, they were asked to look at putting some lighting in Jimmy Lee Walkway and Washbourn Gardens.

Mayor Hurley commented on the Saltwater Baths carpark and said he was disappointed that a garden plot was put in the middle of it, which compromised the design. He also said there doesn't appear to be any water available for future planting.

Cr O'Shea said it was mentioned in the public forum at the Motueka Community Board that the Saltwater Baths carpark is more elaborate than what was needed.

Ms S Westley, Customer Services Manager, was in attendance for discussion on her report which updated the Committee on the Customer Services section.

3.5 District Librarian's Report

Mr B Paterson, District Librarian, was in attendance for discussion on this report.

Cr Kempthorne asked if consideration has been given to having joint library membership between Nelson and Tasman.

Mr Paterson said librarians from both councils meet regularly and the topic was raised at a recent meeting. They are planning to look at the range of possibilities there may be and will present them to the two councils for consideration. He said a different fee structure could be looked at for Nelson residents using TDC libraries

3.6 Rough Island – Partial Closure of Connington Road to Vehicles

The report from the Reserves Manager outlined the requests from the Tasman and Districts Equestrian Trust and members of the Ornithological Society to close part of Connington Road on Rough Island to vehicles.

Cr Higgins said there are safety issues relating to vehicles using the Equestrian Park and from the foreshore. This would increase the safety and the use of the area.

3.7 Community and Recreation Advisor's Report

The report highlighted the number of activities the Recreation Advisors are involved in at this time of the year.

Cr Henry advised that the Washbourn Gardens Fair will be held on Monday 29 January 2007.

Cr Inglis advised the Motueka Wine and Food Scallop Festival and the Golf Classic are being held on 6 January 2007.

3.8 Kids Voting 2007 and Beyond

Mrs S Hartley, Administration Advisor, was in attendance to present this report.

Mrs Hartley outlined that the objective of Kids Voting is to provide students at Year 9 with an authentic election experience, which will hopefully demystify the voting process and encourage interest in elections amongst kids and their parents/caregivers. School students will vote for the real Tasman District Council candidates on a real ballot paper.

Cr Bryant was concerned about the proposal as there are a lot of ill-informed people in the community who will believe that there are now kids voting for local body politicians.

Mr Kennedy said it was trialled in Auckland for the last election and didn't cause any problems. Its aim is to encourage kids to take more interest in local government.

Cr Borlase arrived at the meeting at 1.50 pm.

3.9 Synopsis of CHRANZ Study on Affordable Housing in the Nelson, Tasman and Marlborough Regions

Mr Kennedy said the information contained in the reports is very important.

Cr Borlase reminded Councillors that the reports apply to three regions, Nelson, Tasman and Marlborough and some of the recommendations do not relate to Tasman.

Cr O'Regan said our plan has very high expectations of people who are building anything. He pointed out that building consent fees had increased to over 100% higher than what they were two years ago to meet government regulations and added that if Council insists on having staff regulate colours of houses and natures of gardens, nobody will have an affordable house.

THAT a working group be formed consisting of the Housing Policy Committee plus Cr Kempthorne (as Chair of Environment and Planning), Cr Currie and a relevant Environment and Planning staff, to consider the findings of this study and to prepare recommendations and actions.

3.10 Pensioner Housing Issues

Mr Kennedy spoke to the Pensioner Housing Issues report contained in the agenda which recommended that the draft Pensioner Housing Policy (as attached to the agenda) be adopted and that consideration be given to increasing the number of cottages owned by Council.

Cr Higgins said Council should provide fair value housing, not subsidised housing. He said Council, being the landlord, has a lot of stability for tenants and he would charge them market rental.

Mr Kennedy said Council has previously made the decision to go to a percentage of market rent.

Cr O'Shea said most of the older units were built with subsidies and low interest money from government.

Cr Inglis said the problem in Motueka is the Maori lease properties with some leases being \$10,000 per year. He said people can't afford to stay in their houses and they have to find somewhere they can afford to live.

Mr Dickinson suggested the following wording be included in the policy under 7.8, "based on 80% of market rentals, reviewable no more than bi-annually".

Cr Currie said Council is providing accommodation for people who are in a position where they cannot afford the full market rental.

Cr Riley said there will always be some people who cannot afford market rentals. He supported the continuance of 80% of market rental which had built up a considerable credit balance.

Cr Kempthorne asked staff to look at how trusts are used around the country to provide low cost housing.

Mr Kennedy said he would do a listserve request to find out about housing trusts.
