6.1 Consideration of the November 2017 Applications

Mike Tasman-Jones, Community Partnerships Coordinator, summarised the report. He noted 21 applications were received totalling \$35,193.15 from an available remaining pool of \$29,015.20. Mr Tasman-Jones advised this was the second round of three for the 2017/2018 financial year.

The Subcommittee went through each application and made the following comments:

Riverside Community Trust

The amount of \$1,500 was granted.

Wakefield Mural Group

The amount of \$500 was granted.

It was noted the Wakefield Mural Group had subsequently decided on a different approved wall from that listed in the application.

Arts Council Nelson - Emerging Blind Art Programme
