3 RESERVOIR CREEK

Environmental Education Officer J Butler, T Kroos and Reserves Manager, B Wilkes were in attendance for discussion on this item.

Mr Butler spoke to his report contained in the agenda which informed the Subcommittee of the work being done by Council staff in the upper Reservoir Creek catchment and the report that has been commissioned. The report also informed the Subcommittee of the significance and vulnerabilities of the native forest part of the upper Reservoir Creek catchment with regard to the impending logging of the surrounding pinus radiata forestry. The report also made recommendations on the future management of the forest remnant and the surrounding forestry land.

Cr Higgins questioned if the long term future of the area is as a reserve for Richmond, should we be selling it to the Reserves Department and not logging it at all.

Mrs Wilkes advised that the land was taken under the Public Works Act.

Mr Wilks said resource consent has been applied for and one condition concerns sedimentation removal. The only other constraint is what we would normally do as responsible forest managers. To maintain the area free of invasive species would be an expensive exercise.

Mrs Wilkes considered a professional company should look at the site and give a brief on how to manage it for the next 4 or 5 years and give Council some costings and then decisions could be made on budgets and resources.

Cr Higgins said if the area was not logged it would test the permanent carbon sync market. He considered it possible that Richmond reserve DILs might consider it to be worth purchasing.

Mr Kilgour said fees are being collected from the boat ramp and they go to the Pohara Beach Boat Club. He said the boat club lease comes up for renegotiation this year and the whole package will be looked at.

Mr Wylie said the boat club has rights and they have indicated they are anxious to help with development of the port. As yet proceeding to full development has not been endorsed by this Subcommittee. Major expenditure will need to be put into the LTCCP and a long term development plan needs to be adopted.
