2 PROPERTY MANAGER'S REPORT

2.1 Takaka Library

Mr Frater advised that the library will be completed and occupied by early April 2008.

2.2 Collingwood Camping Ground

The existing manager's contract expires in May 2008. There are still further improvements to be undertaken and some land issues to be addressed before we consider the camp to be sufficiently viable to run as an independent business.

Discussion was held on the ability to expand the camping ground.

Mr Wylie said the camping grounds are important to Council and critical to the local economy.

2.3 Motueka Aerodrome

Mr Frater advised that drag racing events have proceeded smoothly. He said the Drag Racing Association have been advised that Council does not intend to renew the licence on expiry at the end of 2008.

There is a potential new tenant at the aerodrome which would involve the erection of a further hangar.

Cr Higgins advised that zoning issues in Motueka are being addressed at the present time and said the airport zoning could be addressed at the same time.

2.4 Port Tarakohe

Mr Frater advised that a water supply that is suitable for drinking is now available at Port Tarakohe.

Cr Inglis raised the issue of the installation of a boat arm at the ramp at Port Tarakohe.

Mr Frater advised that a 110-passenger cruise ship will visit Port Tarakohe on 16 January 2010.
