6 REPORTS

6.1 Chairperson's Report, Report RFN13-08-11

The Communications Advisor tabled, on behalf of the Chair, a list of all the major achievements made under the governance of the Communications Subcommittee over the past three years.

It was noted that the Communications budget in 2011 was \$1.25m, that it is now \$670,000 and that ratepayers are receiving a better level of communications for this lesser budget.

The Communications Advisor advised that it was more strategic to keep communications management in house.

Discussion on putting all communications information on line ensued.

Subcommittee members noted that this will be the last Communications Subcommittee chaired by Cr Wilkins given that she is not re-standing for Council and thanked Cr Wilkins for her Chairmanship of the Subcommittee.

6.2 2013 Communitrak Survey Results Report, Report RFN13-08-12

The Strategic Development Manager, Susan Edwards was in attendance to speak to the report tabled in the agenda.

The purpose of the report was to advise that the Communitrak Residents Survey had been carried out, and to provide the opportunity to discuss communications related matters.

The Strategic Development Manager highlighted the following matters from the Communitrak Residents Survey:-

- Of the 60% of residents who have contacted the Council in the last 12 months, 86% are satisfied with the service they received
- Most people are getting the main source of their information about Council from Newsline - 30% of residents got most of their information on Council from newspapers
- 90% of Tasman residents have access to the internet
- When questioned on levels of satisfaction with the way Council consults the public

in the decisions it makes 42% of residents are satisfied or very satisfied, 40% are neither satisfied nor dissatisfied.

Subcommittee members raised a number of matters including whether Council's departments are analysing the information received in the Survey and making recommendations on areas with low or reducing levels of satisfaction, the accuracy of the information provided by people being surveyed, the availability of information on why people are dissatisfied and the comments on rates, spending on roads and spending on stormwater.

- The independence of the Boredom Busters Survey was questioned given that the survey was contained within the magazine itself. It was felt that the age group it covers is too big and now requires refocusing on 5 to 10 year olds. Paul Jennings advised that this had occurred and asked Subcommittee members to read the next issue and to provide feedback on it. A first principal review of Boredom Busters is to be included on the

Action Sheet.

Identity Evolution

The Communications Advisor tabled documents that showed current and proposed samples of the new typographical Council logo and noted the following:-

- Cost effectiveness of the proposed, simplified logo means there are savings to be gained
- The existing Council logo includes a mix of six colours that are expensive to print
- Using a typographical identity saves money.

Subcommittee members raised a number of matters, including the acceptability of the logo externally, the process for changing the logo, whether a name is a logo, the actual cost savings and when the changes will occur to print materials, signage etc.

Staff were asked to come back to the next meeting with options for print material and versions of the logo.

Mayor Kempthorne requested the process to continue with this change be stopped immediately.
