4 SUBMISSION TO THE LOCAL GOVERNMENT COMMISSION ON THE PROPOSAL FOR THE AMALGAMATION OF NELSON CITY AND TASMAN DISTRICT – RCN10-10-13

Mr Wylie spoke to the report which was contained in the agenda. The draft submission was circulated prior to the meeting. Mr Wylie acknowledged Susan Edwards, John Cook and Jeff Jones for the work they have done in preparing the submission.

Ms Edwards tabled figure 10 which was missing from the original draft and a list of the appendices with a brief summary of them.

The report sought:

- a) Approval of the submission to the Local Government Commission on the proposal to amalgamate Nelson City and Tasman District, as contained in the document sent out to Councillors under separate cover;
- b) Agreement of the final submission being signed off by the Mayor, Deputy Mayor and Cr Bryant prior to being sent to the Local Government Commission;
- c) Agreement to advise the Local Government Commission that Council does not support the proposal to amalgamate Nelson City and Tasman District and request that it not proceed with the proposal following consideration of the submissions and the information provided in the Tasman District Council submission.

Mr Wylie said the petition is now defined as seeking a merger, "the choice" is therefore to either have the existing two unitary councils or one big unitary council, there are no other options are on the table.
