2.1 Tasman Bays Heritage Trust Report RCN11-04-01

The purpose of the report was to convey outcomes of the recent Joint Shareholders Committee meeting as it relates to the Statement of Intent for the 2011/2012 year for the Tasman Bays Heritage Trust. It also sought direction from Council as to the treatment of a \$1.2 million loan from the Council to the Trust and provided additional

A discussion ensued and it was noted that Council needed to provide a direction to the Joint Shareholders Committee on the matter and that the mechanism of dealing with the loan could be dealt with at a later date.

Council's draft Annual Plan would provide the public with an opportunity to submit on the issue.
