8.1 Advisors to the Tasman Regional Transport Committee, Report RCN14-02-01

Engineering Manager, Peter Thomson was in attendance to speak to the report contained within the agenda.

The purpose of the report was to set out the composition of the Tasman Regional Transport Committee. The appointment of six non-voting advisory members was recommended along with one representative each from Marlborough District Council and Nelson City Council.

The Council was also asked to ratify the appointment of the New Zealand Transport Agency representative, Jenny Chetwynd, Regional Director, Central.

8.2 Richmond Water Treatment Plant Project Report RCN14-02-02

Programme Delivery Manager, Russell McGuigan and Utilities Engineer, Jeff Cuthbertson were in attendance to speak to the report contained within the agenda.

The purpose of the report was to seek Council approval for staff to proceed negotiations with the preferred tenderer for the construction of the Richmond Water Treatment Plant (RWTP), and to explain how the current shortfall in funding would be met to enable the project to proceed.

The Programme Delivery Manager and Utilities Manager gave an overview of the existing two systems and the new RWTP project as well as explaining the cost reduction strategy to meet the allocated budget.

Dr Ed Kiddle, Medical Officer of Health, NMDHB was introduced to Councillors. Dr Kiddle advised that a safe and secure water supply and infrastructure was essential for the Richmond community. He added that the new RWTP would help to eliminate health risks from infections and nitrates.

Dr Kiddle reminded Councillors that the RWTP is required to meet the changes to the New Zealand Drinking Water Standards by July 2015, when the standards become mandatory in accordance with recent amendments to the Health Act.

Councillors raised the following matters:-

- Safety of the existing asbestos concrete pipes
- Nitrates and health issues in the current Richmond systems
- Growth capacity in the RWTP for Mapua
- Sustainability of the existing pipe work
- · Visual impacts at the site
- The public consultation process used
- Zonings around the RWTP site.
