The Community Development Fund is to enhance the identity, vitality and sustainability of the Tasman District's smaller communities. The funding could be used for planning, providing activities, running events or developing services to enhance communities. The fund has an annual allocation of approximately \$20,000.00.

SPARC Rural Travel Fund applications are open to rural sports clubs and rural school teams with young people aged between 5-19 years. Funding is to help with travel costs of participating in local sports competition.
