1 PUBLIC FORUM

1.1 Mr O Wahrlich

He said that the hoist at the ASB Aquatic Centre to enable disabled people to be able to use all the pool's facilities, has been trialled and would be available to the public in the next few days.

3.3 Council Cottages – Aotea Flats, Richmond Report – RCS12-05-06

It was agreed that she talk to police and seek their opinion on safety issues at the reserve and to also investigate the cost of solar lighting options for reserves and how long they run for.
