### 5.1 Chairman's Report RCS12-10-08

### 5.3 Cricket World Cup 2015 Report RCS12-10-03

The purpose of the report was to inform and seek direction from the Community Services Committee on whether to support, in principle, the preparation of a Nelson City Council bid to be a host city for the Cricket World Cup 2015.

- Agrees to support, in principle, the Nelson City Council bid for hosting the Cricket World Cup 2015, noting that any financial assistance, other than an application to Community Grants, would be subject to consideration through an Annual Plan process and there is no guarantee of funding being produced.

### 5.4 Request for Council to Fund Display of Historical Material at St Arnaud Report RCS12-10-09

Mr Tasman-Jones spoke to the report which sought Council direction on a proposal for Council to lease a building in a proposed development in St Arnaud for the display of archive and research material.

Mr Tasman-Jones noted that he had received feedback from Sarah Welland, who is involved with the Lake Rotoiti History Collection, and she currently did not support the proposal.

### 5.6 Manager Property Services Report RCS12-10-10

Manager Property Services, Mr Frater, was in attendance to present the report contained in the agenda which provided the Committee with an update on:

- the Mapua Waterfront Park
- the old Takaka Library insurance
- earthquake prone buildings
- the main office complex
- Civil Defence.

Discussion ensued regarding Council's temporary seating and that some pieces had gone missing since the Rugby World Cup. It was suggested that in future, the seats are to be checked in and checked out by Council's contractor. Cr Dowler said that next time the seats are being used at Sports Park, they are willing to mark the seats with Tasman District Council.

It was suggested that a report come back to this Committee which outlines the process of the person managing the seats, the current location, intended use, the cost to purchase and what return Council has made since it has owned them. It was also suggested that a container be hired for the seats.

Mr Frater said that a meeting with the Golden Bay Community Board was scheduled for 5 October to discuss the old Takaka Library insurance. A decision will be formalised at the November meeting of the Community Services Committee. He said that a risk analysis will be undertaken.

Mr Frater said that the Takaka Service Centre will be closed due to the outcome of the stability of the building and he is currently looking at options. The rear of the building, which houses the tearoom and toilets, could still be used but the meeting room would need to be closed. A full report would be coming back to the November meeting if the relevant information was received by then.

Mr Frater advised that a meeting had been held between Crs Bryant, Edgar, Robert Cant, himself, the Murchison Sport, Recreation and Cultural Centre and representatives of the Murchison Pony Club to discuss issues that had arisen regarding use of facilities in the area occupied by the Pony Club.

It was noted that Rabbit Island is a special place and the noise from the low flying planes would be annoying. It was suggested that the hours be restricted and not past 10.30 am because of the number of people around, especially in summer. Another comment was raised for the low flying zone to be at the other end of the beach and for it to be trialled over winter.
