Policy Manager, G S Markham, spoke to his report contained within the agenda to provide a six-monthly update on the progress with current resource policy projects. The report included a list of projects together with the proposed priorities.

Three new project priorities were included in the attached list for consideration by the Committee:

5. STATE OF THE ENVIRONMENT REPORT – FRESH WATER FISH SURVEY – REPORT EP07/08/15

The agenda contained a summary of the full report produced by Resource Scientist, T James. Mr James provided an illustrated report that followed a collaborative investigation, into how freshwater fish cope with varied degrees and types of stream habitat disturbance and water quality. The investigation also gathered baseline information that can be used to predict fish distribution and to measure the success of stream restoration projects.

Mr James provided a comprehensive report on the results of investigations. He concluded that in general, the results show similar patterns of habitat preference, to those found in other regions with highly disturbed streams, containing relatively low fish diversity in abundance. He said that the results confirm the need to continue to implement measures, that protect habitats of native fish from activities such as drain clearance, stream straightening, cattle trampling, fine sediment discharges, riparian vegetation removal and other land uses impacting the beds and riparian zones of small order streams in the Tasman district.

6. TEMPERATURE EFFECTS IN RESERVOIR CREEK - REPORT EP07/08/16

Cr Bryant arrived at the meeting at 11.10 am.

Resource Scientist, T James, spoke to his report contained within the agenda. He acknowledged the presence of Mr T Kroos at the meeting and spoke of his involvement of Stage 1 of the restoration of Reservoir Creek in its lower reaches.

Mr Kroos said that a meeting would be conducted in the afternoon of 23 August to discuss the management plan. Approval for financial input for Ministry for the Environment has been received for Reservoir Creek, Stage 2 Catchment and Stream Study.

Mr James discussed the results of temperature recording within Reservoir Creek and the need to plant stream-sides to produce shade and control water temperature and also as food source for aquatic life.
