## 3. END OF SEASON WATER METERING REPORT 2007/2008 - REPORT EP08/07/03

Cr King arrived at the meeting at 9.55 am .
Compliance Officer, D Page, spoke to his report of 4 July 2008 which presented an overview of the water metering project administration and compliance for the 2007/2008 irrigation season. Cr Glover cautioned against using a heavy handed approach on the productive rural sector. Mayor Kempthorne said that water users need to notify Council staff when they have finished watering and a system devised to follow up.

## 4. ANNUAL DAIRY REPORT 2007/2008-REPORT EP08/07/04

Compliance Officer, K Bunting, spoke to her report of 17 July 2008 contained within the agenda which presented the interim compliance results from the 2007/2008 farm dairy survey. The report particularly referred to compliance with respect to resource consent conditions for the discharge of treated dairy effluent to water and the discharge of dairy effluent to land as a permitted activity. The report also provided an update of Tasman's statistics for the 143 farm dairies in relation to the national targets of the Clean Streams Accord.

The report explained that $63 \%$ of the farms that operate under a permitted activity status were inspected for compliance and the Tasman District now has its best compliance rate on record. Ms Bunting advised that most dairy farms are permitted activities and Council cannot charge a monitoring fee.

Mayor Kempthorne spoke in favour of continuing general rate funding for monitoring dairy farms. He spoke of the positive effects of the Clean Streams Accord and the progress being made in meeting the Accord targets and spoke of the good relationship which the Council has through the application of this Accord.

## 5. CLEAN STREAMS ACCORD - LOCAL GOVERNMENT NZ QUESTIONNAIRE

Mr Bush-King said that Local Government NZ has asked for a questionnaire to be completed for consideration by the Regional Affairs Committee of Local Government NZ. Mr Bush-King said that Tasman District has 143 farm dairies that supply Fonterra which Council staff visit and good progress is being made to meeting Accord targets.

Cr Borlase referred to the Clean Streams Accord target date of 20 December and that it was up to Fonterra to address enforcement by pressure on farmers and suggested a letter be sent to Fonterra Board to encourage that.

Cr Riley said he supported the promotion of Council's current success with levels of compliance.

Mayor Kempthorne suggested asking Fonterra to apply some incentives or a price differential to farms to achieve greater compliance with the Clean Streams Accord.

The meeting noted that some other regions in New Zealand with high number of dairy farms are not achieving the high level of compliance with dairy farms which exists in Tasman District.

Co-ordinator Compliance Monitoring, C Cheeseman, spoke to this report of 3 July 2008. Discussion related to illegal rubbish dumping and abandoned vehicles and problems relating to smoke nuisance from outdoor burning.
