2.1 Te Waikorpupu Springs

2.2 Tasman Tb Action Control News

The agenda contained a copy of the latest newsletter for the Tasman region from Tb Free New Zealand.

Cr Norriss said that at present the contractor, Ron Walker of Southern Pest Management, is based in Nelson and if the plan goes ahead to amalgamate regional units, his services may be partly lost to the Tasman region with more emphasis being placed on the West Coast.

Cr Borlase agreed and said there was no consultation with local farmers through Federated Farmers on the issue. He said although there are presently only three Tb infected herds, some herds are overdue for testing.

THAT the Environment & Planning Manager be requested to write to the National Animal Health Board expressing the concern of Council regarding amalgamation of regional units and seeking assurance that the Tasman regional will not receive a lesser service.

3. REDUNDANT AGRICHEMICAL COLLECTION AND DISPOSAL - REPORT EP08/08/02

Resource Scientist, Ms J Easton, spoke to her report contained within the agenda. She said that the storage facility at Eves Valley contains 9 tonnes of hazardous waste and this will be removed shortly.

Cr Bryant expressed concern about the charge of \$9.00 per kilogram for on-farm pickups of hazardous waste.

- 1. Council sets a charge for hazwaste collection of \$9.00/kg for on-farm pick ups;
- 2. Council retains the budget item of \$140,000 in 2009/2010 budget to dispose of the 10 tonnes we can collect from the 214 farmers;
- 3. Council continues the Household Hazardous Waste collection and storage system with Nelson City Council;
- 4. After the 214 listed farms have been cleared, Council provides a registration system for farmers and endeavours to pick up the waste from enrolled farmers at least every two years. With budget being provided via the LTCCP process, starting at \$30,000 for the 2010 / 2011 financial year.

Control Services Contractor, Mr J Bergman, and Administration Officer, Ms A Brown, spoke to the annual report contained within the agenda.

The report said that property visits to all dog owners were carried out in both residential and rural areas in 2007 / 2008, although a more targeted approach may be of more value in tracking down unregistered dogs and owners who fail to meet their obligations.

The project has been funded for the 2008 / 2009 and Crs Borlase and Ensor have been involved in the project oversight group. The landowner assistance programme will be available to landowners on freehold land with natural areas that have been assessed as being significant native habitats where the landowners have already received an ecological report. Participation is on a voluntary process and the project continues to have widespread support from all participating parties.

Heart of Nelson is the project title for the development of a central city strategy and Nelson City Deputy Mayor, Ms R Reese, and Project Manager, Mr D Jackson, had been invited to address Council on this project.
