1 PUBLIC FORUM

Richard (Dick) Lamb, Golden Bay Contractor

Mr Lamb advised that, in his opinion, Tasman District Council contracts gave no opportunities for small scale local operators and therefore limited competition.

Mr Lamb also advised of his perceived contractor protectionism especially in times of emergency where he felt Council's contractors should have allowed everyone with suitable equipment to help out. He added that State Highway contractors were not cooperating with local contractors in times of extreme emergencies.

Penny Griffith, Collingwood

Ms Griffith advised of ongoing stormwater problems in Swiftsure Street, Collingwood and was disappointed that there was nothing on the current agenda to address this issue.

The Chairman advised that this matter was under action and that the issuing of a Resource Consent was the current holdup.

Reginald (Reg) Turner, Lodge Operator

Mr Turner advised that he had been requesting to erect a tourism information direction sign along Collingwood/Bainham Main Road for five years now without success.

The Chairman advised Mr Turner that he would speak with the appropriate Council staff and get back to him.

Sue Brown, Land Owner

Ms Brown read, and tabled copies of, her concerns regarding flood protection in the Aorere catchment. Ms Brown advised that she was speaking on behalf of landowners in the Aorere catchment who pay the Y river rates and are suffering on-going damage following the flood event of the 28th December 2010.

The issue was the damage occurring due to diversion of fast moving water onto, and across, their properties from:

- Incomplete emergency repairs to river assets,
- Failure of emergency repairs and
- Lack of management of river gravel build up in the beds of rivers.

Ms Brown further advised that the level of service the landowners had received had fallen well short of that described in the TDC 'Rivers Activity Management Plan' and added:

- 'We need action now,
- We need the previous level of flood protection restored to maintain viable businesses
- We need timely repairs or cost of repairs increases with each high rainfall event'.

Ms Brown added that poor communications with TDC had compounded their problems and concluded by asking:-

- 'Why have emergency works not been done to standard of protection that existed prior to the 28th December 2010 event?
- Why have our emergency works been so slow?
- What solution is proposed for dealing with gravel build-ups to re-gain effective flood mitigation?'.

An inspection tour of the river had been arranged for Committee members and staff for later that afternoon.

Graham Pomeroy, Collingwood Landowner

Mr Pomeroy advised that he supported everything Ms Sue Pomeroy had raised.
