It is proposed to have a stall at market day selling Tasman Collection.

3.4 A & P Shows

D Cowdrey tabled a list of subjects that could be displayed at the A & P Shows.

Mayor Hurley arrived at 8.45 am.

Mr Ward was concerned about having too much information on display.

Cr O'Shea suggested having the latest zoning and planning maps under discussion on display at the Motueka and Golden Bay shows.

Mayor Hurley would like to see promotion of the things we work together with Nelson City Council on, in shared ownership/co-operation.
