4 DRAFT MEDIA AND ADVERTISING POLICIES – RFN10-08-10

The report in the agenda informed the Communications Subcommittee of the current work with regard to the Council's media and advertising policies.

Media Policy amendments:

- timely and balanced/objective
- proactive should be included under Content of Media Policy.
- It was noted the Mayor, because of his position, is not included in the sentence about "treating all members equally".
- General media releases to be circulated to councillors, community boards, and staff.
- It is to be noted that staff should deal with factual issues and Council should comment on political issues.
- Councillors' personal media releases should not be utilising the media template or letterhead.
- Mayoral/ Councillor comments should be widened to include community boards.
- Under legal considerations "silent" to be replaced with "does not cover it"
- Comment about response to letters to the editor should be covered in the policy.

Advertising Policy amendments:

- preamble should cover use of other media for non legislatively-required advertisements.
- Official advertising "...aware of, or given ...".
